Dear Council Members:

We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimant, Linda Wade, 1134 North 44th Street, Milwaukee, WI 53208, alleges through her attorney, Law Offices of James C. Mentkowski, S.C., 111 East Wisconsin Avenue, Suite 1750, Milwaukee, WI 53202, that on September 15, 2001 she sustained injuries when she fell due to gap and/or crack in the sidewalk located at 3314 West Vliet Street. They claim damages in the amount of \$60,000.00.

Our investigation reveals that the Infrastructure Services Division records indicate that for at least one year prior to the claimant's accident they did not receive any complaints for the sidewalk in front of 3314 West Vliet Street.

Upon notification of a sidewalk defect the division will send a repair crew to correct a hazard usually within 24 hours. Prior to this complaint, the City had no notice of this alleged defect in the sidewalk and because of this lack of notice, the City would not be liable. Accordingly, we recommend that this claim be denied.
