3. On 03/26/2021 at 12:50pm officers were dispatched to a Subject with Gun complaint at 2812 W. Fond du lac Av. Officers interviewed the applicant, who stated a subject has been loitering and panhandling on the premise. The subject refuses to leave and has been bothering his customers. The applicant stated the subject got into a fight with a customer who was armed with a gun. The officer viewed video of the incident, which showed a subject armed with a gun hitting the panhandler. The officers spoke with the panhandler but he refused to speak with the officers. The officers asked for a copy of the video but the applicant stated the person that handles the video was out of town.
4. On 04/16/2021 officers conducted a license premise check at Citgo gas station, 2812 W. Fond du lac Av. The officers observed 3 video gambling machines with patron playing them. The officers spoke with the applicant by phone. The officer advised the applicant he needed a PEP license to operate the machines. The applicant stated the distributor had provided a license. The officer stated the applicant needed a PEP to operate the machines at his business. The applicant stated he would unplug the machines until he had a license.
5. On 06/15/2021 at 10:26pm officers conducted a license premise check at Citgo gas station, 2812 W. Fond du lac Av. The officer observed the licenses posted on the wall but did not see a cigarette license. The officer checked LIRA and found the business did have a valid license. The officer advised the applicant to post the current license.

6. On 08/10/22 at 9:06pm, Milwaukee Police were dispatched to 2812 W. Fond Du Lac Avenue for a subject with gun compliant. Investigation revealed that the victim was at the filling station pumping fuel when another vehicle approached and pointed a gun at her. The victim went inside to ask the clerk for the address and he did not give it to her. Officers did not interview the clerk and video was recovered at a later date.

7. On 01/16/23 at 9:04p.m., Milwaukee Police were dispatched to a Shooting that occurred in the rear of 2844 N. 26<sup>th</sup> St. The victim of the shooting ran to 2812 W. Fond du Lac to seek help. Officers were able to view video surveillance and the victim was seen requesting help, however, none of the employees reached for a phone to assist, despite the victim bleeding inside the gas station. Further review of the video showed employees using a mop to clean up the blood on the floor. The officers attempted to interview a manager on scene, who was uncooperative and argumentative with officers.
  8. On 05/15/23 at 8:45a.m., Milwaukee Police were dispatched to a Fight at 2812 W. Fond du Lac. This was related to an automobile accident, unrelated to the business. The business was cooperative and allowed officers to view video surveillance, which captured the incident.
  9. On 06/13/23 at 3:23a.m., Milwaukee Police were dispatched to a Shot Spotter at 2812 W. Fond du Lac. On arrival officers observed a large rock and a casing on the ground. Investigation revealed a subject locked themselves out of their vehicle and after numerous attempts to gain entry, the subject fired one shot in order to break the window and gain entry. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
  10. On 10/28/23 at 2:44p.m., Milwaukee Police were dispatched to a Shots Fired at 2816 W. Fond du Lac. On arrival the officer did not locate any casings, however, did recover a bullet

fragment. The officer attempted to view video surveillance at 2812 W. Fond du Lac, however the employee stated they did not have access to the system. The agent called the attendant and advised the officer via telephone that they reviewed the camera system from home and it did not show anything other than customers coming and going.

11. On 12/21/23 at 11:52a.m., Milwaukee Police were dispatched to a Trouble with Subject at 2812 W. Fond du Lac. Investigation an unknown subject entered the business and stated they were with the City Inspector Office, however, could not provide credentials. The subject then stated they work with the Alderman, however, a phone call to the Alderman revealed the subject was not employed with their office. The subject was issued a contact card and advised not to return to the store.

~~On Monday, January 16, 2023, at approximately 21:04PM, we were dispatched to a shooting complaint at the gas station on N 28th St and W Fond Du Lac Ave.~~

Upon arrival, I observed victim identified as **Nelson KYLES, (M/B, DOB 06/08/1967)** standing on the west side of the location with a gunshot wound to his left leg (thigh). KLYES stated he was inside of his residence located at 7147 W Burleigh St #5 which is located above a barbershop. KYLES stated that three (3) subjects were banging on all of the apartment doors at the location. KYLES stated the subjects entered into his apartment accusing him of stealing narcotics. KYLES stated all three subjects were armed with handguns and a rifle. KYLES stated he told the subjects he doesn't know what they are talking about and was hit on top of the head with a gun.

KYLES stated the subjects forced him at gun point into a new model gray Jeep Cherokee with Florida plates. KYLES stated the subjects continued to question him and he continued to tell the subjects he doesn't know what they are talking about. KYLES stated they drove him to the alley in the rear of 2844 N 26th St. This location is based off ShotSpotter (Flex ID #81-895709) at 8:52PM for two (2) rounds.

KYLES stated that the subjects told him to exit the vehicle and stated to tell them where the drugs are, or they were going to shoot him. KYLES stated that one subject stated someone is looking out of the window. KYLES stated the subjects told him to get back in the vehicle and he refused. KYLES stated the one of the subjects discharged their firearm striking him the leg and he began running. KYLES stated the vehicle fled N/B in the alley from the location.

KYLES ran to the gas station at 2812 W Fond Du Lac Ave. The surveillance footage shows KYLES walking into the gas station at 8:59PM and talking to a customer who can be seen making a phone call.

KYLES described subject 1, who shot him as a B/M, dark skin complexion with a scar on his neck. Subject 2, B/M, light skin complexion, with a short, braided hair style. Subject 3, B/M, owner of barber shop below his apartment.

KYLES was conveyed to Froedtert Hospital by MFD Med 18, green shift, LT. ROSEMOND regarding.

PO TERRELL and I reviewed surveillance footage from the interior and exterior surveillance cameras. Upon review, we observed KYLES enter the gas station requesting help and requesting for people to call "911". I did not observe any of the employees reach for a phone to assist. I observed KYLES bleeding inside of the gas station. I observed KYLES exit the gas station and wait for emergency services to arrive. I then observed the employees to mop up (clean up) KYLES' blood that was on the floor of the gas station.

As the investigation continued, I observed the manager at the location, identified as **Suriner SINGH (a/m, 11/30/96)** attempting to exit the gas station. I requested he go back inside of the gas station and informed him that none of the employees could exit until after the scene was clear. At that point, SINGH became uncooperative and argumentative with me. At that point, PO TERRELL entered the gas station and informed SINGH that he could not exit. SINGH finally complied and walked to the employee "booth" with his co-workers.

An overall check of the business revealed the location was clean and in order.

On June 13th, 2023, at approximately 3:23 AM squad 5320 (P.O. Juan MEDEL and I) was dispatched to 2812 W Fond Du Lac Ave (located in the City and County of Milwaukee) for a ShotSpotter. My partner and I were in full duty uniform, operating a marked Milwaukee Police Department squad, and equipped with Axon body worn cameras.

Upon arrival, near Pump 1, we observed shards of glass, a large rock, and 1 casing located on the ground.

We spoke to an employee at the location who stated an individual had locked himself out of his own vehicle and after several failed attempts to gain entry decided to shoot one round (shot) into the rear window. However, we did not get his information. A licensed premise report was initially not filed since this incident was outside of the gas station and did not involve the business or gas attendant.

We viewed surveillance footage which depicted a black male, wearing a red jacket, and black pants attempting to break the window to a silver Chevrolet Malibu (no plate). The individual had several citizens help him but were unsuccessful. The subject is then observed producing a firearm and firing a single shot into the rear driver side window. The subject then unlocks the vehicle and drives away.

P.O. MEDEL, who is a trained Crime Scene Technician, took 5 photos at 3:35 am.

I placed the casing on MPD inventory (23019083).

On October 28, 2023, at approximately 2:44, P.O. Ashley NAVONE and I were dispatched to 2816 W Fond du lac Av for a shots fired complaint.

Upon arrival P.O. NAVONE, and I did an search for bullet casings in the parking lot and an around the property of the the Citgo gas station. During the search we did not find any bullet casings but ended up finding a bullet fragment laying next to gas pump number 3.

After finding the bullet fragment, P.O. NAVONE when into the gas station and talked to the attendant behind the desk to possibly get some details about the incident. The gas station attendant stated to P.O. NAVONE that he did not see or hear any gun shots. The Citgo does have camera's but the attendant did not have access to the system.

I then conducted a canvass of a few surrounding businesses that had camera's. My first stop was an ABC liquor store (2816 W Fond du lac Av) that is next door to the Citgo. They stated to me that they have the same camera system as the Citgo and that the manager is on the way. While walking to the next place I was observing Fond du la Av looking for broken glass in the road way. The next business that had camera's was a small church (2823 W Fond du lac Av) across the street. They have a ring doorbell camera and a ring security camera. When I went to ask if I could see their footage, their WIFI was off and not working. The last place that I went to is the One Stop Mart (2709 N 29th St). They had several camera's pointing at W Fond du la Av. A detective from CIB and myself looked through the footage and ended up finding the incident that took place on camera 22 of their system. The detective uploaded the footage to a USB drive for his investigation.

The Citgo owner Kanwar V SINGH (W/M, 05/30/1981, (414)899-0848) called the attendant and wanted to speak with me. I spoke with SINGH and he stated to me " I looked at the security camera footage between the time of 1:45 PM and 2:30 PM and there was nothing on them except people getting gas and walking in and out of the building." SINGH never came to the scene, he viewed the footage from him home.

While on scene, I did not observed the business license posted.

This report is being written by Police Officer Dana VANBUREN, Squad #5234, assigned to District 5 Early Power Shift.

On Thursday, December 21st, 2023, at approximately 11:52am, Police Officer Evan MIKULSKY and I were dispatched to a Trouble With Subject complaint at 2812 W Fond Du Lac Ave., located in the City and County of Milwaukee.

Upon arrival we were met by the caller who was identified as Kanwar SINGH (W/M 5-30-1981), who stated that he was the owner of the store CITGO. SINGH stated that one of his employees informed him that an unidentified black male came into the CITGO and stated that he was a City Inspector and he was there to check the condition of the food being sold to the customers. SINGH stated that upon his employees request for the unknown male to show credentials for his position as a City Inspector, the unknown male could not provide any. SINGH stated that he eventually arrived on scene 10 minutes after 10:47am, and the unknown male was still on scene. SINGH stated that the unknown male stated to him that he works for Alderman Stamper's Office. However, SINGH stated that he called the Alderman's Office, which revealed that the unknown male was not an employee for the Alderman's Office. SINGH showed us video surveillance of the incident. SINGH was cooperative with us throughout the entire investigation. SINGH stated that he did not want charges pressed on the unidentified suspect; however, he would like us to inform him that he is no longer welcomed on the premises at 2812 W Fond DU Lac Ave.

SINGH stated that the unknown male then began to open multiple boxes of pizza and stated that the slices of pizza were not up to standards and should be thrown away. SINGH stated that the unknown male eventually left the scene in a blue 2006 Kia Sedona. SINGH was able to get the plate number from the vehicle and he provided us with the plate #ASL-3393. A Wisconsin Department Vehicle check revealed that the plates were listed to a Corey J. KIRKWOOD (B/M 11-28-1985). A Milwaukee Police Department records check listed an address associated with KIRKWOOD and a photo of him. The photo matched the suspect in the video footage that was shown to us earlier by SINGH.

I issued SINGH a community contact card listed with my contact information.

We then made contact with KIRKWOOD at his residence at 3027 N Palmer St., located in the City and County of Milwaukee. We informed KIRKWOOD that he was no longer welcomed at the CITGO located on 2812 W Fond Du Lac Ave., and that he was not to return to the CITGO.

KIRKWOOD agreed to no longer go to the CITGO at 2812 W Fond Du Lac Ave., he he requested a
