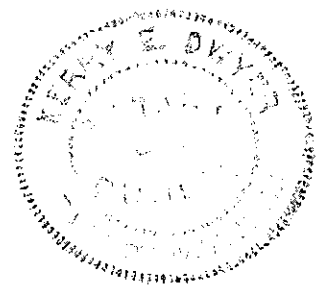

- 081311...** Substitute ordinance relating to the First Amendment to a Detailed Planned Development known as RGS Warehouse, on lands located on the West Side of South 6th Street and North of West College Avenue, to allow for options to the approved building materials, in the 13th Aldermanic District.
