I have called and spoken with your assistant who told me to email you the following information.

I am writing on my mother's behalf who is a 79 year old senior citizen. She is willing to talk or meet with anyone if necessary. Her name is

She would like this complaint to be filed on Legends Towing LLC so it will be made available when the Licensing Committee reviews their towing license. A complaint on them will also be

filed with the BBB by her as well. She has already filed a complaint with WI Dept. of Agriculture, Trade and Consumer Protection. Read below. This towing company besides potentially overcharging customers, don't accommodate for the needs of senior citizens nor handicap persons. We were forced to deal with this business. It was not by choice.

TOWING COMPLAINT FILED WITH DATCP

On 10-16-23 my midsize 2004 Taurus car was towed by Legends Towing LLC from the Metro Market Pick-n-Save on Van Buren Street at 6:39PM. Apparently I parked on the lines next to a handicapped space as I tried to park in the handicap space. I was ultimately charged \$449 dollars and paid Legends Towing in cash on Tuesday, 10-17-23. I believe I was overcharged \$160-\$190. According to the WI State Statutes on Towing 319.03 Section D: \$150 can only be charged in special circumstances and I don't believe they applied here. I believe it was a standard tow from that location and my daughter saw the pictures provided by the employee of the company, which didn't show any obstructions. I was charged \$35 for storage and that can only apply if my car was in covered storage and at the tow lot we saw it was outside so only \$25 should be charged. On the bill it says TOW# \$35. I have not idea what this means since there is a separate TOW CHARGE for \$150. I'am a 79 frail elderly woman who needs occasional assistance with walking and standing. I asked my daughter to go with me to get the car and be my support advocate to read over the bill and ask for clarification of the charges since they seemed excessive. When we arrived and spoke to an employee (heavy set male 35ish) he seemed to act like he was the boss. He showed the 2 pictures of my car before he towed it. We then asked for an explanation of the charges because I was quoted \$396ish and that seemed excessive based on our knowledge of the towing statutes. He refused to explain and said he would only talk to me and not my daughter and I had to go with him to see the bill. I wanted my daughter with me and he said no. She asked for him to bring the paper bill outside. He said no and stormed off. We didn't know what to do so my daughter called her husband. When he came, he and I attempted to go in 3-4 times together and he was told each time by this same man (employee or boss) he was trespassing and couldn't go in with me. We then had to sit outside the gate on a landscape log while he served other customers. We hoped he would change his mind. In the meantime he mocked me and laughed and said I don't have a walking disability. Finally, as closing time approached he allowed my son-in-law to go with me to the office. I was exhausted and didn't have the energy to ask for clarification on the bill and my son; in-law didn't either because he was more concerned about my mental well being and not the money after this long ordeal. I signed the bill and paid it and got my car and left.

I have a attached a copy of the receipt for the bill paid to get her car back.

If there is anything else you need from either of us please let me know. Feel free to call my mother between 9AM-Noon if necessary. She is the primary care giver for my disabled father and most available during those hours.

I am very sorry about your experience. Sounds pretty outrageous.

The property in question is owned by Watercrest. Metro Mart is a tenant, I have never seen the Metro Mart lease so I don't know how parking lot enforcement is handled. Sounds like the landlord can enforce at will. Sounds like some possible collusion with legend. Watercrest has been problematic in the past.

The city has no jurisdiction over towing on private property. There is some state regulation. We license towing companies but have no control over private property owners' towing policies.

We will enter a complaint in Legends license file. This will trigger a hearing at renewal. You can testify.

I am a long time Metro Market customer which is located at 1123 N. Van Buren Street,
Milwaukee, Wisconsin. While in the store on Sunday, August 20,2023, I had my car towed from
the corner surface lot (Van Buren and Juneau). A clerk in the Metro Market advised me to call
Legend Towing (414-326-4127). Legend Towing told me I couldn't get my car until Monday,
August 21, 2023 and in order for me to take possession of my car, I must bring \$347.50 eash,
proof of registration of my car, and proof of car insurance. After getting my car on Monday
morning, August 21, 2023. I told Legend Towing there is no time restriction posted on that
surface lot. He told me to talk to Metro Market. On Monday afternoon, August 21, 2023, I
spoke with Matt, the Metro Market store manager. He told me to call Watercrest Real Estate
Property Management (414-276-6370). On Wednesday, August 23, 2023, I called Watercrest
Real Estate Property Management and a woman answered the phone. I asked to speak with Jim
or Carolyn Gadd, the owners of Watercrest Real Estate. She said they weren't available. I
explained the situation and she said to call Legend Towing and hung up on me. I feel like I am
really getting the run-a-round. Upon speaking to some employees in the Metro Market, other

customers and employees have also been towed. Peter in the deli department had his truck towed and sustained \$7,000 worth of damage to his truck. The next day his Honda Civic was also towed. Also two Metro Market corporate employees visited the Van Buren Metro Market store on Friday, August 18, 2023 and also had their cars towed. This predatory practice of towing customers' and employees' vehicles must be halted. There is no sign posted on that corner surface lot (Van Buren and Juneau Ave.) of any time restriction. I feel I was unjustly towed and should be reimbursed \$347.50. I will be sending you a text message with attachments of the signage for the corner surface lot at the corner of Van Buren Street and Juneau Avenue and the \$347.50 towing bill.

4. On 06/06/23 at 2:45pm, a complaint was made at District 4 of the complainant's vehicle being illegally towed, by Legends towing. The complaint stated that her vehicle was eventually returned back to her residence, but wanted to make the police aware.

- 5. On 09/12/23 Milwaukee Police were dispatched to 3950 N. Holton St, for a trouble with subject. Officers spoke with employee who stated that a female was having problems paying for her tow fees, regarding her vehicle. The female was no longer on scene upon police arrival.
- 6. On 10/19/23 at 4:27pm, Milwaukee Police were dispatched to 3950 N. Holton St for a trouble with subject. The caller stated that the owner of the tow lot is being aggressive and not allowing her to get her vehicle back. Officers made contact to the caller, who stated that matter is resolved and no longer need police services.
- 7. On 10/25/23 Milwaukee Police were dispatched to 3950 N. Holton St for a subject with gun. Officers spoke with the caller who stated that owner of the location Julio Arias brandished a hand gun at him. This was done when the caller tried to retrieves his grandmother's vehicle. Officers spoke with Mr. Arias, who stated that he did not brandish a hand gun and the argument was a heated verbal argument. The grandmother was on scene and witnesses the argument but no hand gun was scene. The vehicle was released to the owner. Officers were initially were going to cite the owner for Disorderly Conduct, but was advised by a supervisor to advise the incident.
- 8. On 11/27/23 at 4:53pm, Milwaukee Police were dispatched to 3950 N. Holton St, for a subject with gun complaint. Officers spoke with the caller who stated that his wife's vehicle was towed by Legends Towing, and he got into verbal altercation with owner of the business, trying to retrieve his wife's vehicle. During the altercation a dog was brought out of the business location to intimidate him. Also a group of 5 subjects surround his vehicle and one of the subject's brandished a hand gun. Officers then spoke with the agent of the business, who advised officers the vehicle was towed and the amount due was \$347.50, and the business only takes cash, and the lot closes at 6:00pm. The agent showed officers video but officers stated that they were not allowed to see the full video, due to the agent fast forwarding past parts. The agent was uncooperative with officers and initially did not want to release the towed vehicle to the owners who returned with payment prior to 6:00pm.
- 9. On 11/29/23 at 5:05pm, Milwaukee Police were dispatched to 3950 N. Holton St, for a trouble with subject complaint. Officers spoke with caller who stated that he was trying to get his vehicle returned from Legends Towing. Officers spoke with the owner of the business who was not cooperative with officers during the investigation.

- 10. On 12/13/23 at 10:49am, Milwaukee Police were dispatched to 3950 N. Holton St, for a battery complaint. Officers spoke with the employee of the location who stated that the caller took possession of his vehicle and battered him. The employee stated that he also did not pay the impound fee. The officer attempted to reach the caller but was unable. The officers reviewed video, but the employee did not wish to press charges.
- 11. On 12/19/23 an officer of the License Investigation Unit recovered a stolen auto from 2855 N. Weil St, due to the vehicle attempting to be re titled. The officer later received a called from the owner of Legends Towing, Julio Arias. Mr. Arias stated the vehicle was properly towed, and the notification was made to the owner, making him legally able to sell the vehicle. Mr. Arias attempted several different avenues trying to take possession of the vehicle. The officer's investigation revealed that there were discrepancies, regarding the tow location and notification being mailed to the wrong address. Mr. Arias was notified that him starting an improper mechanical lien and then selling the vehicle are State and City violations. The vehicle was released to the proper owners.
- 12. On 01/10/24 License Investigation Unit (LIU) RSTP and Secondhand Dealer Investigator concluded an investigation related to incidents that took place on 07/31/23. Milwaukee Police officers notified the LIU regarding Legends Towing of 3950 N Holton St conducting non consensual tows of vehicles from a private garage open to the public. The officer stated that he observed an unmarked tow truck taking vehicles from the location of 1123 N Van Buren St (Pick N Save) The officer made contact with the driver who stated that he works for Legends Towing, and the truck was unmarked because it was recently painted. An officer from the LIU reviewed video of the tows and contacted Legends Towing regarding the concerns of observed violations. The officer attempted to set an appointment where he could review the business tow records. On 01/10/24 the agent was cited for the violations regarding the tows on 07/31/23. On 01/10/24 the owner Julio Arias met with the officer who wrote the citations and was upset. Mr. Arias made a comment that Mr. Kevin Lopez, (who is the listed agent) has nothing to do with the business, and citations do not concern him. Mr. Arias continued to be aggressive and made comments which, could be perceived as threats to the officer. The officer confronted Mr. Arias about the comments he made, and Mr. Arias requested a police supervisor to file a complaint.

13. On 01/15/24, Milwaukee Police Detectives investigated the threats/ comments made by Julio Arias, who is 50% owner of Legends Towing, located at 3950 N. Holton St. Mr. Arias had an interaction with a police officer, on 01/10/24 after his business received citation for towing violations. Mr. Arias comments made to the officer were perceived as threats. The detectives

- re-interviewed officers and video regarding the interaction. Charges were filed but the District Attorney's Office did not choose to prosecute the charges.
- 14. On 01/20/24 Milwaukee Police were dispatched to 3950 N. Holton St, for a theft. Officers spoke with the caller who stated that when she received her vehicle back from Legends Towing, the battery was missing. The caller also mentioned the business had her WI ID card and registration of her vehicle. The officers witnessed that both the caller and employee were being uncooperative.
- 15. On 05/06/24, officers of District #5 conducted follow up on a fraud complaint, involving Legends Towing located at 3950 N. Holton Av. The complainant, a representative from U-Haul stated that Legends Towing did not, give proper notification to U-Haul of their towed vehicle. The complaint also indicated the business charged \$200.00 dollars a day in storage fees of the U-Haul owned vehicle. The complainant, also indicated Legends Towing billed U-Haul a large amount money, for the towing and storage of the vehicle. Attached are correspondence letters from U-Haul to Legends Towing, regarding the matter.

- Jeremy Shelly (Caller) (608) 982-2115) reported an altercation at [3950 N Holton St.] involving Julio R. Arias, owner of the premises.
- Arias allegedly retrieved his grandmother's car while being aggressive and brandishing a firearm, threatening Shelly.

On Monday, November 27, 2023 at approximately 4:53 PM, my partner, P.O. LAMACK and I were dispatched to the location of 3950 N. Holton St. in the State of Wisconsin and in the City and County of Milwaukee for a Subject with Gun call. Squad 5291, P.O. Nash was also dispatched to the listed location.

Upon our arrival, I observed a large parking lot with a fenced-in lot to the east. I observed a large Rottweiler or similar breed dog behind the fence that barked when officers approached. In the parking lot, we met a black male, who was our caller, identified as Keith R. MOORE b/m 06-29-1967. KEITH stated that his wife, later identified as Karmelita S. MOORE b/f 04-27-1972 had her car towed from the Pick'n Save parking lot located at 605 E. Lyon St. in the State of Wisconsin, City and County of Milwaukee by Legends Towing LLC located at 3950 N. Holton St.

### 

KEITH stated that his wife had parked her 2022 Lincoln Nautilus in a handicap spot at Pick'n Save, but did not have her handicap placard displayed in the window. KEITH stated that his wife called him and let him know that her vehicle had been towed, and that the manager at Pick'n Save gave her the location of the tow lot. KEITH stated that he arrived at the lot at approximately the same time that the tow truck with his wife's vehicle arrived.

KEITH stated that he ordered the people operating the tow lot to release his wife's vehicle, and that an unknown male from the tow lot, described as wearing a tan suit, got in KEITH's face and stated, "Your lucky these cameras are on, pussy, or I'd beat your ass." KEITH stated the unknown male let his dog out to intimidate him. The unknown male was later determined to be Julio ARIAS m/w 09-07-1987. KEITH stated he threated to run over the ARIAS' dog if he let him loose. KEITH stated ARIAS then ordered one of the tow truck drivers to hook up KEITH's pickup truck and get it off of the property.

KEITH stated that he told ARIAS he was not going to deal with this, but was going to call the police. KEITH stated he believed ARIAS must have called some of his friends, because approximately 5 males showed up, and surrounded his truck. KEITH stated one, who he described as a heavy-set black male with dreads and gold teeth, brandished a gun. KEITH stated that he then drove out of the lot and headed south on Holton, and turned east on Nash, and the black male followed him in his vehicle. KEITH stated he called the police and told the dispatcher that he was being followed. KEITH stated the dispatcher told him to pull over, and that he pulled over and waited on Holton St. outside of the tow lot until we arrived.

### 

KARMELITA stated while she was shopping at the Pick'n Save, she got an alert on her phone that her car alarm was going off. KARMELITA stated that she came out to see her vehicle had been towed, and she inquired with a police officer who was nearby who stated that the city had not towed her vehicle, and that she would have to speak with Pick'n Save. KARMELITA stated she spoke with the customer service at Pick'n Save, and they gave her the information for the towing company. KARMELITA stated she called her husband and let him know that her vehicle had been towed and was being taken to 3950 N. Holton.

P.O. NASH spoke with an unknown male who did not identify himself. The unknown male stated he was not there, but said that KEITH tried to block the gate at the tow lot with his pickup truck, and was told that if he did not move his vehicle, they would be towing it. The unknown male stated that only one person was allowed to go into the office at a time. KARMELITA requested that officers go with her to go inside the tow lot office, because she was afraid to go by herself. P.O. NASH stated that he observed tears coming from KARMELITA's eyes, as she was visibly scared to go inside the business alone.

P.O. LAMACK spoke to the licensed premise agent, identified as Migdalia L. CUCHTA w/f 12-28-1979, stated that they are the private company for Metro. CUCHTA stated that CUCHTA was parked in a handicap space without a handicap tag and so they towed her vehicle. The tow number is: 2395789. CUCHTA stated KEITH, showed up to the location, and was angry. CUCHTA believed that he had a gun, because he was reaching into his pockets. CUCHTA stated she did not see any guns during the exchange.

P.O. LAMACK escorted KARMELITA into the tow lot office door where she was met by a w/m, later identified as Julio ARIAS m/w 09-07-1987. ARIAS told KARMELITA that she needed to pay cash only in the amount of \$347.50. KARMELITA asked about the tow, and ARIAS repeatedly stated that she was in the wrong. P.O. LAMACK told ARIAS that he did not have to be so argumentative with KARMELITA, because she is just trying to get her vehicle.

P.O. LAMACK reviewed surveillance footage, and requested to view more, but ARIAS stated that he did not have access to the full video. P.O. LAMACK stated that ARIAS did not let her see the full video and would fast forward through parts. P.O. LAMACK stated the footage showed KEITH arriving to the listed location, appearing angry and telling the tow truck driver to "drop the car." ARIAS narrated the video, and added that KEITH acted as if he had a gun. In the video, the tow lot staff as well as KEITH get into a verbal argument, which ended with a male voice saying, "Cut the cameras."

ARIAS told KARMELITA that she was at fault, it would cost \$347.50 to get her car out of the lot, and they would only accept cash. ARIAS became agitated and angry, and was yelling at KARMELITA who was not disagreeing with him, and admitted that she had parked illegally. P.O. LAMACK told ARIAS that she (KARMELITA) gets it, but everything that ensued after was not necessary. ARIAS continued to be argumentative, and P.O. LAMACK told ARIAS that it was not worth arguing anymore, and KARMELITA just wants to get her car. This was approximately at 5:30 PM. During this interaction ARIAS also stated, if we had wanted to do something we could have (referring to the altercation KEITH).

KEITH and KARMELITA left the tow lot to go get cash in order to pay for their vehicle, and returned to the tow lot at 5:58 PM. When KEITH and KARMALITA arrived back at the location, ARIAS refused to provide KARMALITA her vehicle, despite having payment, being available and returning prior to 6:00 PM when they stated they were closing. KARMALITA asked ARIAS if it would be the same cost in the morning, and he said there would be an added cost.

P.O. LAMACK asked ARIAS if he would be able to quick take care of KEITH and KARMELITA, and he said it was too late, and "I'm not going to help those cowards." P.O. LAMACK asked ARIAS what his name was and he refused to provide it. P.O. LAMACK stated she was going to refer him to the CPU, because of his lack of cooperation and attitude.

P.O. LAMACK advised ARIAS that he needed to provide his name, because he could get his licensed revoked if he failed to provide it and cooperate with the city and the law. ARIAS replied, "Ask me if I care."

P.O. NASH asked ARIAS, "Is there a problem?" ARIAS stated, "There's no problem... I know your brute tactics."

P.O. LAMACK told ARIAS, They (KEITH and KARMELITA) arrived here before you closed, but you did not tell them you were going to close without helping them. ARIAS replied by sarcastically gesturing with a thumbs up, and said, You're so smart. You know all the rules.

P.O. Nash told ARIAS to just pull his vehicle into the lot.

This report submitted by Officer Carlos Felix assigned to the License Investigation Unit, Day Shift.

On December 19, 2023, I recovered a reported stolen vehicle (case number 232910021) from the 2855 N. Weil Street. The stolen vehicle was in the process of being retitled to Vidal Acevedo under a mechanical lien. An attempt to contact Acevedo at the property was made without success. The vehicle was recovered and secured at the city tow lot.

I later received a call from Julio Arias the owner of Legends Towing. He questioned why the vehicle was towed and I advised him it was a reported stolen. Julio argued he received a tow number from the city, and the vehicle was removed from a private lot he has a contract with. After an additional check of the city's tow records, I located a tow number generated by Legends towing for the vehicle. I advised Julio the tow number was pulled after the vehicle was reported stolen, but I would conduct additional follow up (report 232910021). The call was ended.

The original reporting victim stated the car was parked in front of 608 W. Vliet on the public road, which I informed Julio. He stated the car was removed from a private lot at 1614 N. 10th Street.

On December 19, 2023, I received a call from the city tow lot manager Nicole Anderson. I was informed that Julio was at the property causing a scene and attempting to claim the vehicle.

I advised the manager that Julio was not the legal owner, and I was still conducting an investigation into his rights to the vehicle. A Milwaukee Police Officer that was working as security for the tow lot asked to speak with me. The officer stated Julio was not cooperative and irate demanding the vehicle. The officer questioned what he should advise Julio. I informed the officer that Julio is not the legal owner, and the vehicle cannot be released to him without conducting my follow-up, which would start when I'm provided with the documents, I requested from him earlier in the day. The call was ended.

On December 20, 2023, Julio went to the Police Administration Building and requested to meet with me. I met him in the lobby and explained to Julio in person the car was reported stolen and that was the reason I recovered it. Julio argued he received a tow number from the city, before removing the car from private property. The owner was sent a tow notification but abandoned the car. I advised Julio several times that he could not claim stolen property, but he continued to disagree believing he was legally allowed to sell the car. I advised Julio I would conduct additional follow-up and confirm his rights to the car before releasing it to anyone. Julio requested a supervisor and Lt. Mark Krowski responded to the lobby. I briefed the Lieutenant of the situation, and he explained the same to Julio before providing him with a complaint form per

Julio's request. The contact was ended.

A short while later I received a call from a District Five supervisor. That supervisor was requesting information on the vehicle, stating Julio was attempting to file a theft report. The supervisor was advised the car was towed and I would be conducting additional follow-up regarding ownership, which Julio was aware of that. For the next few days even during off days I continued to receive calls from District Five officers and supervisor regarding Julio attempting to recover the car or file complaints regarding.

After communicating with Julio and EAN Holdings' representatives the original owners of the car, it was found that Legends Towing mailed the tow notice to the wrong address. Julio of Legends Towing, started the mechanical lien process and sold the vehicle to an individual without properly notifying the legal owner which is a State and City violation. The car was released to the EAN Holdings who provided documents showing the car was titled to an address different then what Julio showed the notice was mail to.

No additional enforcement was taken on this incident.

Report submitted by Officer Carlos Felix assigned to Squad 2742 at the license investigation Unit.

Approximately around July 31, 2023, Officer James Duerr and Lydia Rivera met with me regarding a tow company that was conducting non-consensual removal of several vehicles from a private garage open to the public.

Officer Duerr stated on July 13, 2023, he observed a black pick-up style truck with a boom attached but no identifying markings, being used to remove vehicles from the Pick N Save parking garage located 1123 N. Van Buren Street. Officer Duerr made contact with the operator and was told that the tows were being conducted by Legends Towing who had a contract with the attached Pick N Save business. Officer Duerr asked the operator about the city RSTP sticker and business identifiers not affixed to the truck. Officer Duerr was told the truck had been painted and stickers were not replaced. Officer Duerr observed other individuals in the parking garage checking vehicles and preparing them to be towed. Officer Duerr recovered security video on a later date which showed individuals related to Legends Towing, mounting wheel dollies onto parked vehicles and pushing those vehicles to the garage opening where they were hooked up to the black tow truck with no identifying markings.

On July 31, 2023, I called Kevin Lopez the listed agent and 50% owner of Legends Towing. I advised him of possible towing violations that are being investigated. Lopez stated he would have his manager call me. A short while later I received a call from a male identifying himself as Steve Johns, the manager for Legends Towing. I advised Johns of the suspected violations and requested to meet at the business and check their tow records for the day in question. The male stated he would call back with a date we could meet.

On August 2, 2023, I received a call from a male identifying himself as Julio Arias from Legends Towing. Julio stated he spoke to Officer Felix the other day (suspected Steve Johns). I advised Julio that I had been waiting for his call and wanted to review some of the tow records. Julio stated he was at a district filing a complaint on officers and would be leaving to Florida soon. I later received an email with an attached video and an invoice for one towed vehicle (Toyota Four Runner). No other information or phone calls have been received from anyone representing Legends Towing.

A check of the city Towing Management System confirmed several tow numbers generated on the request of Legends Towing. The times stamp of the tow number request was later than the time stamp on the video, which showed identified vehicles being removed. Officer Duerr confirmed with Pick N Save the security video time stamp was correct. I confirmed with Parking Enforcement that the Tow number timestamp is instantly generated when the violation and vehicle information is called in and established.

While viewing the video several RSTP non-consensual tow violations are observed and listed below.

- Legends Towing operators did not take the required photos of the parking violation before conducting a tow and moving the vehicle as per City Ordinance 93-47-d.
- Legends Towing intentionally did not have identifiers affixed to the commerce vehicle used to conducted non-consensual tows as per City Ordinance 93-45-1-b.
- Legends Towing employees intentionally initiated a non-consensual tow without reporting the vehicle and having an approved tow number generated by a city agency before moving the vehicle as per City Ordinance .93-4-2e.
- Also, Legends Towing conducted non-consensual vehicle tows from private property. When records were requested by police for inspection, not all documents were provided. This was done intentional and contrary to ORD. 93 -47-7.

Lopez the LIRA listed owner and agent of Legends Towing was cited for violations found regarding 4 out of 11 vehicles towed on July 13th. Several additional violations could not be confirmed in the video obtained.

police inquiry was made into violations.

On January 10, 2024, at 11:00A.M., I called Lopez and advised him citations were being issued for violations that were observed during non-consensual tows. At 1:00 P.M., Lopez met me in the Police Administration Building front lobby. I handed him the citations and advised Lopez of the violations. He asked why he was receiving the citations. I explained he is the listed business agent and 50% owner, and responsible for how business is conducted. Lopez stated he did not agree on how business was being conducted and separated from Legends at the start of the company. I asked why he did not make an attempt to change the license, which he could not explain. I reminded Lopez when I contacted him earlier in the year, he stated his manager would call me and said nothing of not being related to the business. After explaining to Lopez there were other violations and he could request to meet with the City Attorney regarding the citations, he left without incident.

At around 3:00 P.M.., I received a call from an officer assigned to the Muni-court entrance stating Julio was there and wanted to speak with me. When I arrived, Julio was holding the citations I issued Lopez. Julio asked about the citations, and as I attempted to answer, he removed U.S. currency from his pocket, flashing it around and stating he was not concerned about the citations. I advised him the citations were issued to Lopez. Julio stated, Lopez had nothing to do with the business and the citations would be dismissed. Julio stated he was the business owner. Julio stated he would just change the license into someone else's name. Julio continued to be argumentative making snide remarks such as me being a modern slave, and borderline threats. Due to Julio's actions, I could not continue to talk with him. He requested a supervisor and filed a complaint. I ended my contact with him.

On Monday, January 15, 2024, I was advised by my commanding officer of an incident that occurred on Wednesday, January 10, 2024, involving a Milwaukee Police Department Officer identified as Carlos FELIX.

On Thursday, January 11, 2024, FELIX drafted a Milwaukee Police Department Memorandum to his commanding officer detailing the Safety Concern regarding his interaction with a subject known to him as **Julio R ARIAS**, **M/W**, 9-7-87, (manager and self-identified owner of Legends Towing) which occurred on January 10, 2024, at approximately 3:05 PM, at the Municipal Court Entrance to the Milwaukee Police Department, 951 N James Lovell St, located in the city and county of Milwaukee.

#### INTERVIEW OF P.O. CARLOS FELIX

On January 15, 2024, at approximately **12:30 PM**, I conducted an interview of FELIX. FELIX stated his PeopleSoft number is 015476 and was hired as a Milwaukee Police Officer on 4-1-02. FELIX stated he is currently assigned to the License Investigation Unit, working the Day Shift, and has been assigned to that location for approximately 2 years. FELIX stated on January 10, 2024, he was working 9AM to 5PM, as Squad 2742.

FELIX stated on January 10, 2024, at approximately 1:01PM, an individual identified as **Kevin I LOPEZ**, **M/W, 2-11-89**, responded to the Milwaukee Police Department Municipal Court Entrance to speak with him. FELIX stated he was to issue municipal citations to LOPEZ regarding Legends Towing, as LOPEZ was the licensed agent and 50% owner of the company. FELIX stated he spent nearly a half an hour explaining the citations to LOPEZ, which were for violations such as not photographing a vehicle before a tow, not informing the tow desk before a tow, and markings on the tow truck. FELIX stated although LOPEZ disputed the violations, he was polite and respectful. FELIX stated LOPEZ left the location with the issued citations.

FELIX stated on January 10, 2024, at approximately **3:05PM**, an individual known to him for over 6 years identified as ARIAS, responded to the Milwaukee Police Department Municipal Court Entrance to speak with him regarding the same citations issued to LOPEZ and Legends Towing. FELIX stated ARIAS wanted to know why LOPEZ was receiving the citations and that the citations were "pocket money" to him, while flashing a large stack of suspected US currency.

FELIX stated he and ARIAS continued to talk about tow records as ARIAS stated to FELIX he was just mad because he (ARIAS) called internal affairs on him. FELIX stated he continued to show documentation to ARIAS as ARIAS stated LOPEZ should not be receiving the citations and that he should. FELIX stated ARIAS became more argumentative and stated to him "You're going to get me to the point where I'm going to literally start wanting to get you out of your position". FELIX stated he told ARIAS he was just doing his job when ARIAS stated, "I know who you are, I know stuff about your parents, I know a lot of stuff about you". FELIX stated he asked ARIAS what that was supposed to mean and he moved on stated he was upset and that he was going to pay the fines because he is a man.

FELIX stated ARIAS continued to argue with him about emails, vehicles and tow numbers. FELIX stated ARIAS continued to brag about how much more money he makes than him, calling him a "modern day

slave". FELIX stated ARIAS then stated to him, "Hopefully you don't commit suicide, I know that run in your DNA, that's how personal it's gonna be" FELIX stated he asked ARIAS if that was a threat? FELIX stated ARIAS stated, "Did I make a threat, I'm just saying that's in your DNA and you wanna take the easy way out".

FELIX stated ARIAS eventually wanted to talk to a supervisor and he (FELIX) kept his distance as **Sgt Guadalupe VELASQUEZ** spoke with him. FELIX stated prior to VELASQUEZ arriving ARIAS was having a
phone conversation with an unknown person and talking intentionally loud enough to be heard. FELIX
stated ARIAS stated on the phone something to the effect of "You're going to have to move to Florida for
a year, I'm going to turn it up" FELIX stated he had no further interactions with ARIAS after that point.

FELIX stated ARIAS is known to him through an off duty incident that occurred between him and ARIAS on **August 7, 2017 (MPD IR# 17-219-0186)**, near his (FELIX) old residence in the 400 block of E. Lloyd St. FELIX stated ARIAS knew where he lived as well as his mother and other family on the block and threatened to shoot him over intervening in a fight between him (ARIAS) and a female. ARIAS was eventually arrested and convicted of Disorderly Conduct in Milwaukee County Case Number **2017CF004294**.

I asked FELIX what he thinks ARIAS meant about the suicide comment. FELIX stated ARIAS knows his father committed suicide about 30 years ago and believes the "In your DNA comment" is in reference to that. FELIX stated he is not sure what the "Turn it up" statement specifically meant, but this is when he began fearing for he and his families safety, as his mother and other family members still live in the 400 block of E Lloyd St.

FELIX stated his first cousin "Delia Cruz" had a daughter named Emily ZAYAS, F/W, 11-18-84. FELIX stated ZAYAS has a child in common with ARIAS' brother, Juan A OREGO, M/W, 11-27-82. FELIX stated "Delia Cruz" recently made an unannounced visit to his mother's house and ZAYAS called him recently asking about advice regarding child custody. FELIX again stated his concern and fear for his safety about the statements made by ARIAS and ARIAS' knowledge of his family's residential locations.

FELIX stated both of his interactions with LOPEZ and ARIAS were captured on his body worn camera (BWC).

FELIX stated he wished to prosecute for this offense.

#### INTERVIEW OF P.O. DENISE RUEDA

On January 15, 2024, at approximately **10:15AM**, I conducted an interview of RUEDA, who was working at the entrance to the Milwaukee Police Department Court Administration Section.

RUEDA stated she recalls the incident between ARIAS and FELIX on January 10, 2024. RUEDA stated at least an hour before ARIAS came in to speak with FELIX another individual (LOPEZ) arrived and asked to speak with FELIX. RUEDA stated the conversation was civil and the individual went on his way.

RUEDA stated when ARIAS arrived at approximately **3:00PM**, he had some papers in hand and asked for FELIX. RUEDA stated ARIAS seemed agitated from the get go and while waiting for FELIX to arrive made a

comment to the effect of "I fucking hate the police".

RUEDA stated when FELIX arrived, she overheard parts of the conversation and knew it was about citations. RUEDA stated the conversation became somewhat heated and she heard ARIAS say he knows FELIX personally. RUEDA stated FELIX eventually walked away as a Sergeant arrived to speak with ARIAS. RUEDA had no further information regarding the incident.

On Saturday, January 20, 2024, Squad 5140 (PO Markel MCKINLEY and I) responded to 3950 N Holton St. (LEGEND TOWING) in the City and County of Milwaukee, WI, for a theft complaint in which a vehicle owner was missing the battery of her vehicle when she picked it up from the lot.

We met with Ashley L A LEWIS (b/f, 11-5-91) who stated that her vehicle was towed from the lot at her apartment building in Glendale (1633 W Bender Rd, Glendale, WI) sometime after 8:00pm on 1/18/23. LEWIS stated that her apartment building recently changed the parking policy prohibiting parking of vehicle with severe or disabling damage in the lot. LEWIS indicated that her vehicle did have some prior accident damage, but it runs, and she used it daily to take her son to and from the bus stop while it has been cold. She stated the vehicle is not disabled.

The vehicle in question is a 2012 Kia Forte, White, WI Plate ANN7333 / VIN KNAFT4A28C5468913.

LEWIS learned that the vehicle had been towed to LEGEND TOWING located at 3950 N Holton St in the City and County of Milwaukee.

LEWIS stated she made contact with the tow company and came to pick up her vehicle. She stated when the employee brought out the vehicle, she was informed that the battery was dead. They were able to get the vehicle started for her and she drove the vehicle away. She stated that when she later had a friend help her with the issues, she was informed by the friend that the battery was not dead, it was in fact missing.

LEWIS stated she again contacted LEGEND TOWING and informed them that the vehicle was fine when she last used it and that the battery was missing after she picked it up (after an employee told her it was dead). LEWIS indicated that an unknown employee advised her to "take care of it with her insurance company".

LEWIS stated that LEGEND TOWING staff had possession of the registration and her WI ID card, and she wanted assistance in getting her property back from the company.

PO MCKINLEY spoke with an employee of LEGEND towing on the phone asking if LEWIS can get her property back from the business. PO MCKINLEY was informed that LEWIS may do so if she comes alone.

LEWIS, PO MCKINLEY and I were let into the locked gate area/payment booth by a female employee. The female employee then entered another door and came to the counter where she provided LEWIS with a stapled form and requested a signature. LEWIS began reading the form and the employee stated she just needed to sign the form at the bottom. LEWIS informed the employee that she would like to read what she's signing prior to signing the document.

LEWIS declined to sign the form which indicated costs etc associated with the tow and indicated there was no damage or missing parts. LEWIS wrote "No Signature" at the bottom of the page and attempted to hand the paperwork back at which time the female employee indicated LEWIS needed to write her name at the top. LEWIS stated she was not the driver of the vehicle and refused this portion

as well. LEWIS stated she was going to leave it empty as the company already has a copy of her ID anyway.

At this time a male employee, who was wearing a full face covering and could not be identified indicated that he gave LEWIS a deal on the payment. LEWIS took a cell phone photo of the documents she refused to sign and left them on the counter and began to walk out.

The female employee then came outside to the gate to let us out of the locked area. LEWIS and the female employee exchanged words, each accusing the other of being difficult and/or argumentative throughout the process.

A replacement battery for LEWIS'S vehicle is estimated at approximately \$150.

I was supplied two letters from U-Haul in regards to a legal matter between U-Haul and Legends Towing LLC.

The first letter dated April 15th, 2024 explains their recovery attempt for a U-Haul truck, which is a 2023 Dodge Ram 1500, with Arizona plate, AM34126 and VIN #3C6JR6DT9PG665638.

The letter goes into detail when U-Haul received a letter from Legends Towing LLC on March 29th, 2024 informing U-Haul of the over \$8000.00 charge for them to recover their property. The letter stated Legends Towing LLC had U-Haul's vehicle for over 43 days and is set to go to auction. It indicates that Legends Towing LLC never contacted the registered owner (U-Haul) before this time because they were waiting for the driver that rented the vehicle to claim the vehicle. U-Haul states if Legends Towing LLC would have notified them of the tow, U-Haul would have immediately recovered the vehicle.

The letter mentions Legends Towing LLC received a tow number from the police department. This information is incorrect as the police department does not issue tow numbers. The City of Milwaukee Tow Lot issues numbers for tows.

The vehicle was listed as a private property tow and was requested by a contractor. The tow company was Legends Towing. The vehicle was towed from 5474 N 83rd St.

Later in the letter the amount of \$9603.10 in regards to the fee is mentioned. The vehicle was towed on March 3rd, 2024 and U-Haul did not receive notification until April 11th, 2024. The letter also claims per Wisconsin Administrative Code, Legends Towing LLC is not authorized to charge \$200.00/per day.

The second letter dated April 18th, 2024 is a Cease and Desist letter. This is advising Legends Towing LLC that if they continue with the selling/auctioning of U-Haul's vehicle legal action will be taken against them.

Please be advised that, at this time, the U-Haul equipment held at Legends Towing LLC has been reported stolen as that was the last formal information U-Haul has received on this equipment. U-Haul was not properly notified of the tow as required by law.



This letter is written on behalf of U-Haul Co of South Eastern Wisconsin and its related companies. U-Haul's Equipment Recovery Department was notified on April 11,2024 that the vehicle above was towed by Legends Towing LLC. The subject vehicle was reported stolen to the Milwaukee Police Department (case#C2403090037).

Jose Lopez, the Repair Dispatch Manager of U-Haul Co of South Eastern Wisconsin spoke to Kim at Legends Towing LLC and was advised that U-Haul owes in excess of \$8000.00 to recover the unit. She stated that they have had this unit for over 43 days and a letter was sent on March 29, 2024. The vehicle is set to go to auction on April 19, 2024. Jose received a call from Blue, who advised he was the supervisor at Legends Towing LLC. Blue advised that they did not send a letter out sooner because they were waiting to see if the driver would come and pick up the equipment. He also stated the unit was not stolen because they received a tow number from the police department. Alicia Hemphill-Arnold from U-Haul's Equipment Recovery Department spoke to Kim on April 15, 2024. Kim explained the unit was towed on March 03, 2024, because the customer needed a tire changed but did not have the money to pay them so they towed it from his residence. She stated they charges \$200.00 per day for storage and we now owe over \$9000.00 to recover the unit. She explained they called the Milwaukee PD the day it was towed and they provided them with a tow number. Kim advised they do not negotiate charges. Alicia also spoke to Officer McKinley at the Milwaukee PD to find out why U-Haul was not notified when the unit was reported stolen. He stated that it was a private property tow and he is not sure why the officer that took the stolen report did not advised U-Haul the unit had been towed.

Moving Made Easier.

Per the Wisconsin Statutes Vehicles § 349.13. Authority to regulate the stopping, standing or parking of vehicles.

1. Subject to par. (dr), a vehicle may be removed from private property under par. (b) or (c) only by a towing service at the request of the property owner or property owner's agent, a traffic officer, or a parking enforcer. Subject to par. (dr), a vehicle may be removed from a leased space under par. (bm) only by a towing service at the request of the operator, a traffic officer, or a parking enforcer.

2. Before any vehicle is removed under par. (b) to (c) by a towing service, the towing service shall notify a local law enforcement agency of the make, model, vehicle identification number, and registration plate number of the

vehicle and the location to which the vehicle will be removed.

Subject to par. (dr) 2., if a vehicle is removed under par. (b) to (c) by a towing service, the vehicle owner shall pay the reasonable charges for removal and, if applicable, storage of the vehicle, as well as any service fee imposed under par. (dm). Subject to par. (dr) 2., if the vehicle was removed at the request of the property owner or property owner's agent or at the request of an operator, these reasonable charges shall be paid directly to the towing service, and the towing service may impound the vehicle until these charges are paid. If these charges have not been paid in full within 30 days of the vehicle's removal and the vehicle owner has not entered into a written agreement with the towing service to pay these reasonable charges in installment payments, the vehicle shall be deemed abandoned and may be disposed of as are other abandoned vehicles.

Per Wis. Admin. Code Trans § Trans 319.03 - Trans 319.03 Charges for towing and storage.
(1) TOWING SERVICE FEES. A towing service may charge a vehicle owner ordinary and reasonable fees related to removal and storage of the vehicle from private property under s. 349.13(3m), Stats., except that no charges may exceed the following individual total amounts:

- (a) \$150 for a vehicle removed using a flatbed, hook and chain, wheel-lift, boom, or any other method.
- (b) \$25 for each period of 24 consecutive hours that the vehicle is stored at an outdoor storage facility.
- (c) \$35 for each period of 24 consecutive hours that the vehicle is stored at an indoor storage facility.

Note: The daily storage charge under par. (b) or (c) can be collected by a towing service the first minute after notice of the tow is given to a law enforcement agency by the towing service. A second daily storage charge cannot be collected until 24 hours after the time at which notice is given to law enforcement, subject to the limits for closed storage facilities specified in s. Trans 319.03(4).

- (d) \$150 for any other necessary and commercially reasonable charges relating to the use of special equipment in the removal or storage, or both, of the vehicle, and for any expenses incurred by the towing service relating to travel exceeding twenty miles. Administrative fees, gate fees, lien processing fees, or any other fees for equipment or procedures ordinarily required for the removal or storage of a vehicle may not be charged under this paragraph. A towing service may collect charges under this paragraph only if any of the following applies:
  - The removed vehicle possesses unusual characteristics, such as size or mechanical condition that make the maximum removal charge under par. (a) unreasonably low, or has a gross vehicle weight rating or registered weight of 10,001 pounds or more.
  - The location in which the removed vehicle was parked contains certain spatial constraints or limited access to the parked vehicle impeding the tow that make the maximum removal charge under par. (a) unreasonably low.
  - The roundtrip travel by the towing service exceeds 20 miles. A towing service may charge a surcharge of \$3.00 per mile under this subdivision for miles in excess of twenty miles. Mileage is based on roundtrip mileage from the storage facility to return thereto. The towing service shall establish the mileage from the tow truck odometer and shall include on the tow slip the beginning and ending odometer readings to

the 1/10 per mile. If the tow truck is dispatched from a location other than the storage facility, the one-way mileage between the location from which the vehicle is removed and the storage facility shall be multiplied by two. Mileage fractions less than 5/10 shall be omitted, and mileage fractions of 5/10 or more shall be rounded up to the nearest whole number.

Note: Pursuant to s. 349.13(3m) (dr)2, Stats., a towing service is prohibited from collecting any charges for the removal or storage of an illegally parked vehicle towed under s. 349.13(3m), Stats., if the towing service has not complied with the requirement under s. 349.13(3m) (d)2, Stats., to notify law enforcement prior to removing the vehicle.

- (2) MUNICIPAL SERVICE FEE. If requested under s. 349.13(3m) (dm), Stats., by the municipality in which the removed vehicle was illegally parked, the towing service shall charge the vehicle owner a service fee not exceeding \$35 and shall remit this service fee to the municipality. The fee under this subsection is in addition to any fees charged under sub. (1).
- (3) TOW FEE. If the fee under sub. (2) is requested by a municipality, the towing service may charge the vehicle owner a service fee not exceeding the fee amount remitted to the municipality under sub. (2). The fee under this subsection is in addition to any fees charged under subs. (1) and (2).
- (4) STORAGE PERIOD. The storage period is the number of consecutive 24-hour periods beginning on the date and time that the towing service provides the notice required under s. Trans 319.05(1) and ending when the vehicle is retrieved, rounded up to the nearest whole number. No towing service may charge a storage fee for any calendar day that the storage facility is open less than 4 consecutive hours between the hours of 8:00 a.m. and 5:00 p.m., for retrieval of the vehicle.

U-Haul believes the fees of \$9603.10 to recover this unit are both outrageous and egregious as Legends Towing LLC failed to properly notify the registered owner about the impoundment. Despite the Vehicle being impounded on March 03,2024, U-Haul did not receive a certified letter until April 11, 2024. There is no plausible reason why notice was not able to be given in a timely manner. We reported the unit stolen to the same agency that Legends Towing LLC stated they received a tow number from however. U-Haul was never made aware that the vehicle was towed and allowed to report the unit stolen. A simple call by Legends Towing LLC to U-Haul would have resolved this matter immediately. Legends Towing LLC admitted did not send any notification to the registered owner as required because they were waiting to see if the driver was going to pick up the truck. The driver of the subject vehicle is not the registered owner. Legends Towing LLC failed to comply with statutory and other requirements to timely notify the Vehicle Owner of possession and impound of the Vehicle Had proper and timely notice been given, we would have immediately recovered the Vehicle. Additionally, per the Wisconsin Administrative Code, Legends's Towing Inc is not authorized to charge \$200.00 per day for a private property impound. Kim from Legends Towing LLC advised that they towed the unit from the customer's address but it is not a private property impound. I advised her that the police have tow down as a private property tow. I have also attached a copy of the notice that was sent that says the unit was towed off private property. Legends Towing LLC is attempting to charge fees that exceed what is authorized in the Wisconsin Administrative Code.

Please be advised that this letter serves as a formal demand and notice to Legends Towing LLC and its applicable affiliates, parent company, subsidiaries, employees, agents, members, officers, directors, partners, and any other person or entity which may be associated with Legends Towing LLC. U-Haul Co of South Eastern Wisconsin is prepared to pay reasonable towing and storage charges in exchange for the release of the equipment. Hopefully, this refreshes your recollection about your legal obligations to notify the registered owner of an impound. While we appreciate your attention to this matter, U-Haul Co of South Eastern Wisconsin contends that it does not owe any impound fees for storage or towing that exceed the statutory requirement.

U-Haul Co of South Eastern Wisconsin expressly reserves the right to contest any illegal charges related to the


