Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.

Michelle Holman was in a motor vehicle accident which was caused by an unsecured sign falling from a city vehicle on Interstate Highway 43. She claims damages in the amount of \$1,705,00.57.

This matter was previously approved for \$250,000.00 under Resolution No. 211390. After mediation, Michelle Holman and her attorney agreed to \$170,000.00.

Because settlement of these matters is deemed expeditious to the City, we recommend settlement of these claims in the amount of \$170,000.00 and have enclosed an appropriate resolution.
