I am appealing the administrative procedure followed by <u>Pepartment of Neighbor</u> (Name of City Department) Son 'Per

Amount of the charges \$ 336,20

Charge relative to: Solid Waste Vielation

I feel the City's procedure was improper due to the following reasons and I have attached any supporting evidence, including city employee's names/dates which I spoke to regarding this issue and copies of any city orders received:

1. The blue notice was incorrectly posted, it was posted on one of our 7 buildings - 5364 B N. Lovers Lane Rd, while the violation was issued to 5356 N. Lovers Lane Rd - which is the building with the office and thus it is visited a few times a day. Therefore we noticed the violation notice one day later, it should have been posted on building located at 5356 N. Lovers Lane Rd, i.e. where it was addressed. The violation notice was never mailed to us.

2. Please understand that it was an extreme situation - somebody trashed our property along the fence with 35 or 40 tires, 40 or so plastic pepsi pallets, one couch and truck cap. We believe it was coming from the closed Pepsi store which was located at 5500 N Lovers Lane Rd. I even called the Alderman Westmoreland's office and spoke to Todd Peterson (on March 27th) to request some clean-up help from the city due to overwhelming garbage situation for us. Mr Peterson explained that we were responsible for all clean up and the city would not offer any help. Inspector Twaddle said that the only help he could offer was to wait a bit with issuing a fine under the circumstances.

3. All the notated items were removed and properly disposed in the course of 2 days, it was quite a few hours job for us and we worked hard and non-stop to clean up the garbage. None of the notated items was present when the city garbage truck showed up on March 31st.

Please understand if the wind is blowing heavily we get garbage blown toward the fence from all directions and you might still see some leftover regular garbage.

4. We asking the city to remove the fine of \$336.20 due to such unfortunate with somebody trashing our property heavily. We did comply with the requirements and removed all the garbage items. We would tremendously appreciate your understanding.
