I am emailing you to express my concern of, and staunch opposition to, any data centers being built in Milwaukee and specifically the data center proposal at a site near 60th and Capitol.

Milwaukee is a fantastic city that I love living in. I want to live and work in Milwaukee until I retire. However, the pollution (to our air, sound, waterways) and economic devastation caused by a data center will lead to great problems in the city.

The public is waking up to the fact that data centers are just Ponzi schemes for you all to sell out the health of the citizens and the environment and privacy of your citizens just to enrich a small fraction of wealthy elite. If you pass this, generations upon generations will remember who sold out their futures. I wouldn't want to live with the weight of such a shameful legacy.
