4. On 11/15/2021 at 4:55pm officers were dispatched to a Shots Fired at Taco Bell, 5751 W. Fond du lac Av. The officers interviewed the manager, who stated she heard 2-3 shots from outside and the front window of the business was struck by a bullet. The victim of the incident stated the shooting occurred on the street and not the property of Taco Bell.
5. On 11/19/2021 officers spoke with a female, who stated she was in the drive-thru at Taco Bell, 5751 W. Fond du lac Av with her boyfriend. Her boyfriend was complaining because their order was wrong. She stated a male employee came out and pulled a handgun. The employee fired shots at the boyfriend's auto. The female stated the boyfriend did not want to make a complaint. The officer went to the Taco Bell and spoke with the manager, who stated all the employees from earlier had gone home. The manager did not have access to the video system but attempted to call the manager from earlier for the code.
6. On 11/30/2021 officers were dispatched to a Shooting at N. 60th St. and W. Capitol Dr. The investigation revealed the incident occurred near the parking lot of Taco Bell, 5751 W. Fond du lac Av. The manager was cooperative and allowed officers to view video of the incident.

This report is written by P.O. Matthew WIERZCHOWSKI assigned to District Seven, Early Shift.

On November 15th, 2021 at approximately 4:55 pm. Squad 7250 (P.O. Jordan KARR-HARDIE and myself) responded to a Shots Fired Complaint at the location of (Taco Bell) 5751 W Fond Du Lac Av which is located within the City and County of Milwaukee, Wisconsin.

Upon arrival we located the caller who was verbally identified as Rochelle OWENS (B/F 8/31/1969) who was the manager at the location at the time of the incident.

OWNES stated that on 11/15/21 prior to 4:39 pm she heard approximately 2-3 gun shots after seeing a white vehicle's trunk area along with another vehicle that she could not describe parked in front of the vehicle. OWNES stated that the vehicles were located just north of W Fond Du Lac Av on N 58th St facing northbound. OWNES then stated that she then observed a male subject standing on the southeast corner of W Congress St and W Fond Du Lac Av.

OWNES then stated that after she heard the gun shots the vehicles were still sitting in the same area for approximately a couple mins and the person who was standing outside was gone and unknown which way the person went.

I then spoke with another employee who was identified as Travell K. JOHNSON (B/M 11/23/1992) who stated he was at the drive thru window handing food to a customer when he heard a gun shot go through the window in the lobby and he stated he dropped to the floor. JOHNSON then stated he did not hear anything else or see anything during this incident.

The bullet went through a window in which it then went into two ceiling lamps then went into the door

INITIAL INVESTIGATION

This report is written by PO Juan Galindo, assigned to District Seven Dayshift.

On 11/19/21 at 3:45PM, while assigned as the acting Desk Sgt, I took a walk in reckless use of a weapon complaint from Raquel C Quinn(b/f 04/25/91).

Quinn stated at 12:50PM, She was a passenger in a car that was driven by her boyfriend, and they went through the drive thru at the Taco bell located at 5751 W Fond Du Lac Av. Quinn stated at the completion of the transaction her boyfriend realized that their order was missing items, so he got the attention of the worker and told her that they were missing things in their order. Quinn stated that after a couple of seconds the interaction between her boyfriend and the worker got heated. Quinn stated that during this her boyfriend never made threats towards the worker nor made any mentions of having any guns. Quinn stated that they then saw a Black male appear in the window and made a motion towards them like to come around to pick up the rest off their order, so she then stated that her boyfriend drives around towards the doors of the Taco bell. Quinn stated that when they pull up she thinks the same black male that she describes as a tall, light skinned black male come out of the Taco Bell and makes a motion towards them and points towards his waist, he then lift his shirt and pulls out a black hand gun and fires off multiple rounds towards them. Quinn stated that her boyfriend then drives off and heads off toward N 60th St and W Fond Du Lac Av.

Quinn stated that she did not call the police right away because she was scared and did not know what to do and and her phone battery was dying. Quinn also stated that she checked the car for bullet strikes but did not find any.

I then asked what her boyfriend's name was and she refused to identify him because he did not want to get involved in this incident, especially since he has a warrant. Quinn also left the district without giving a description of the car that they were in.

I then checked with dispatch for any related shots fired calls in the area of 5751 W Fond Du Lac Av, but dispatch could not find any.

P.O. Marshall JONES, assigned to District 7, Late Power Shift conducted follow up regarding this incident. PO Jones spoke to Travell K JOHNSON (B/M 11-23-92) who stated that he was the Late Shift Manager for Taco Bell. JOHNSON stated that he did not know anything about the incident that occurred earlier but did hear about an employee of Taco Bell having an altercation with a customer on the earlier shift.

JOHNSON stated that he did not know which employee it was that got into the altercation with the customer. JOHNSON stated every employee that worked earlier was no longer at the location.

JOHNSON stated that working the earlier shift this day was, Bryant HARMON, Elijah HELM, Jakobe JONES, Rochelle OWENS, Charmone PETE and Carl WILLIAMS. The General Manager Richard BROGAN was also working earlier as was scheduled to be back at work at midnight on 11-20-21.

JOHNSON was not able to let us view video surveillance at the Taco Bell due to him not having a password to the system. JOHNSON stated that BROGAN was the one with the password. JOHNSON attempted to call BROGAN while officers were on scene, but he did not get an answer to the phone.

Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
