Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/20/23 at 9:47a.m., Milwaukee Police were dispatched to a Hold Up Alarm at 100 E. Capitol Dr. On arrival it was determined the alarm was pushed by accident.
2. On 04/29/23 at 8:18a.m., Milwaukee Police were dispatched to a Property Damage at 100 E. Capitol Dr. Investigation revealed suspects entered the locked store and removed items via breaking the glass door. The business was cooperative.
3. On 09/01/23 at 10:46a.m., Milwaukee Police were dispatched to a Shoplifter at 100 E. Capitol Dr. Officers were advised two suspects took meat and left without paying. The officers were advised due to the camera angle, it did not capture the incident on video surveillance.
4. On 10/26/23 at 4:13p.m., Milwaukee Police were dispatched to a Fight at 100 E. Capitol Dr. Investigation revealed a subject entered the store with a bag and refused to comply with store policy and check the bag. The security guard stated the subject became aggressive and felt they needed to decentralize the subject. The subject stated they refused to comply because security got in their face and attacked them. The subject was advised not to return to the store.

5. On 11/01/23 at 5:13p.m., Milwaukee Police were dispatched to a Subject with Gun at 100 E. Capitol Dr. Investigation revealed a subject entered the store and proceeded to consume items, without paying. When the subject was approached by security, the subject dropped the item and fled the scene. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

On Friday, September 1st, 2023, at approximately 10:46 AM, My partner P.O NEUZERLING and I were dispatched to 100 E. Capitol for a Shoplifter complaint.

Upon our arrival I observed the scene to be safe and secure.

I spoke to the caller Identified as Tavarus D. SHORTER (B/M, 05-16-1994), Phone number 414-435-6162. SHORTER stated that on August 31st, 2023, at approximately 7:50 PM, Two unknown suspects took \$200 worth of meat. SHORTER stated that he was in the process of closing the store down and was standing by the entrance. SHORTER stated that as people started to leave the store, he noticed one suspect (B/M, 5'10, bald, white shirt, blue jeans and a brown hat) and another suspect (B/M, 5'10, bald, pink shirt, blue jeans).

I did not review camera footage of the incident but was informed by SHORTER that due to the camera angle, The suspects were not able to be caught in the act.

Upon arrival, I observed someone waving us down near the front entrance of the store, later identified as Diana J. SCHMIDT (W/F 7/11/1974), who stated she was the store manager.

SCHMIDT walked my partner and I to the aisle, where I observed 2 male subjects on the ground in the Outpost store aisle. I observed the store security guard, later identified as Tavarious SHORTER (B/M 5/16/1994), restraining a subject, later identified as Kyle E. PAULSEN (B/M 8/24/1995). SHORTER stated PAULSEN did not want to check in his bag before entering the store and asked PAULSEN to leave. SHORTER states it was store policy for customers to check in bags before walking through the store. SHORTER stated PAULSEN became aggressive with him and refused to leave the store. SHORTER stated he then restrained PAULSEN on the ground until officers arrived.

P.O. Brisco asked PAULSEN to speak with him outside of the store. PAULSEN stated he didn't know there was a store policy regarding his book bag. PAULSEN stated he usually goes to the cafe area to do some work because he was homeless. PAULSEN stated he didn't leave the store because the security guard got in his face and attacked him. PAULSEN refused medical and I went back inside the store to talk to SCHMIDT.

SCHMIDT showed me the surveillance video footage from the time s walked into the store at 4:08 PM at 10/26/2023. I observed SHORTER speaking to PAULSEN and PAULSEN had a book bag with him, shook his head back and forth and the two were talking. The video surveillance I observed had no audio. I observed SHORTER grab PAULSEN by both arms and guided PAULSEN to the ground with both his arms around PAULSEN'S arms. SCHMIDT stated she called for medical to come but they would not respond without officers coming to the scene first. SCHMIDT stated PAULSEN had to be restrained because he became aggressive and was a danger to the store customers. SCHMIDT stated this was the first time they had an issue with PAULSEN. SCHMIDT stated she did not want PAULSEN to come back to the store anymore and was interested in filing a restraining order. I gave SCHMIDT the restraining order information on a community contact card. SCHMIDT and SHORTER were cooperative.

I observed the Outpost licenses were displayed on a wall and were all up to date, including a food and dealer license and a class A malt e class liquor license (Agent Edward SENGER) issued to Outpost Natural Foods Cooperative.

My partner and I spoke with PAULSEN, who's demeanor was very excited, and talking over me when I explained to him all customers must leave their bags checked in with store employees and I showed PAULSEN the sign displayed on the glass door before customers enter. I advised PAULSEN to not come back because the business was going to file a restraining order against him.

This concludes my report.

This report is written by Police Officer Kesha LINDSEY, assigned to District Five, Early Shift, Squad 5241 along with Police Officer Steve XIONG.

On Wednesday, November 1, 2023 at approximately 5:13 PM, P.O. XIONG and myself were dispatched to 100 E Capitol Dr for a Subj with Gun complaint, which is located in the City and County of Milwaukee.

Upon our arrival, I observed a security guard standing outside in the parking lot of the location of 100 E. Capitol Dr, which is a Grocery Store named Outpost Natural Foods.

Upon our arrival, I spoke to the caller, who verbally identified himself as Tavareus D. SHORTER (B/M 5/16/1994), who stated he is a Security guard of the establishment "Outpost Natural Foods" located at 100 E. Capitol Dr. SHORTER stated a male customer entered the store and started to grab merchandise throughout the store and attempted to flee through an exit door without making any sort of payment for the items. SHORTER describe the male as a Black male, approximately in his 30's, light skin complexion, wearing an army fatigue black and white jacket. SHORTER stated the subject was yelling aggressively while throwing things. SHORTER stated the male fled the scene in a Black Honda with no plates and a broken rear window.

Officer observed customers and employees inside the store continuing to shop and manage the business. Employees were very cooperative and answered all questions asked.

There were no other witness on scene at the time of the interview.

I reviewed video surveillance footage. The footage showed the male inside the store near the bakery/coffee area on the far westside of the store grabbing a cup for coffee at approximately 4:56 PM. Video surveillance depict the male also grabbing a muffin and eat into. The male walk near the hot food section where hot rotisserie chicken. The male then attempted to leave the store with the items in his hands but he was stopped by the security guard at the store. The male dropped all the items and fled the store.

While on scene, I observed the licenses posted. During my investigation, I did not observe any violations in the licensed premise.

The hearing before the Licenses Committee will take place on 5/7/2024 at 1:20 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
