Good Afternoon Alderman Bauman,

I am writing to you today as one of your newer constituents, and as an attorney, to ask you to please consider voting against, or severely revising the mask mandate proposed by Alderwomen Dimitrijevic. I understand the push towards a mask mandate, and though I sincerely believe it is the job of the business owner to determine whether masks are required in their establishments, I can understand the pressure to pass a mask mandate. I do however believe that the current proposal goes too far.

We are not San Francisco, nor do we have the same concerns as cities like San Francisco, that the proposal claims to be based off of and if a lawsuit is brought, the Wisconsin courts will not follow California courts.

The CDC guidance specifies that individuals should socially distance 6 ft from one another, there is no reason that we need a mandate that requires 30 ft of distance. The guidance as written would be one of the strictest in the nation. Not only is it overkill, but it's impractical and impossible. You wouldn't be able to go anywhere in the city without being within 30 ft of someone, and how does one even judge that distance? There has been no scientific guidance on the arbitrary "30 feet". Additionally, we are in the middle of one of the hottest summers and the mask requirement outdoors can lead to other complications for those who are already at risk for heat stroke...will I be able to take my mask off if I'm outside to re-hydrate? What if I'm on a run and feel faint?

The proposed language does not, to my knowledge, provide appropriate guidance. It does not specify when masks can be taken off at bars and restaurants, it does not discuss exercise or gyms (in which I firmly believe masks should NOT be required if socially distancing is being practiced). I think many of us can get behind the mask mandate indoors, but the outdoor mandate is severely overreaching, especially if more specific guidance is not provided.

The mandate as written discourages people from leaving their own homes and thus will severely hinder the city's economy. Especially when residents can just drive five minutes to any of the suburbs, who have no requirements in place, or if forthcoming, are more likely to have a more reasonable mandate. Even Dane County's mandate does not go this far. I would highly recommend you look into

guidance from similar cities, such as the City of Columbus, OH or even at Illinois, to draft a more appropriate mandate.

I sincerely hope you will take these comments into consideration, and carefully weigh the language of the mandate before voting to move forward. I am happy to discuss my concerns if requested.

Hi to the Venerable Whom It Concerns,

I am an over 60, long distance runner. In good faith I have tried to wear a mask while running. In the cooler weather, it was marginally possible, so a mask could be worn temporarily whenever anyone came into sight. I have seen many runners do this. They are hard to breathe through, so impractical when actually running at training levels.

With the current summer weather and the attendant heat and humidity, we as human beings keep our bodies cool by sweating (yes we all do). The problem being that after about a mile, the mask becomes saturated and it is like trying to breathe through a plastic bag. It is virtually impossible. Carrying it around my neck, or anywhere else does not work, as everything I am wearing gets soaked when I am running. I ran 25 miles Saturday with it around my neck and it was very warm and made the sweating that much worse. After the first mile I put it up when I ran past two separate people running the opposite direction, and I almost suffocated before I got past the second person.

I understand the importance of wearing masks inside and I always do, but the deaths due to the virus have been diminishing since late April so forcing them on the public at this time is highly insincere. The outdoor mask wearing proposal is the equivalent of banning exercise outside. Many people have been training harder than ever due to either time off or to mitigate the stress of the current state of anxiety we are subject to, to stay healthy in a time of pandemic, or just to spend time doing something constructive.

If governments had the public health actually in mind, we would be passing legislation to limit sugar in foods and beverages to under 10 grams per serving, banning all tobacco sales and especially use outdoors where it impacts others (not to mention the increasingly common exposure to marijuana). These are the primary causes of the co-morbidities that cause death from the corona virus, but so far it seems governments are more interested in banning exercise (a crucial element of health) and allowing, undeterred, the real causes of poor health that lead to deaths from this pandemic. Alcohol use is probably another major factor and that is increasing dramatically too.

I wish you would please stop treating us like farm animals.

Dear Milwaukee Leadership Team,

Last night, the news media reported that the City of Milwaukee was planning to implement a policy to require mask wearing in public. I am writing to you to express my complete and total disagreement with this requirement.

While I do not live in Milwaukee, I shop in Milwaukee. To date, I have boycotted Menards in the old North Ridge Mall area because of their requirement to wear masks and moved my shopping to Menomonee Falls and Germantown for home repair needs. If you enact a face covering requirement of any kind, I will move the rest of my Milwaukee purchasing to those cities who do not require a mask.

As I understand it based, on the news report, you want to enact a face covering ordinance because:

1. Businesses have asked for it (at least some)
2. To show caring for others
3. To protect the public

I believe all these reasons are flawed and not based on verified facts. Rather, fear and other motivations are driving such proposals.

How can we protect ourselves and show caring for others? Simple, follow the decades old approach:

- Sneeze/cough into your shoulder
- Wash hands frequently with soap and water
- Don't touch your face
- Stay home when you are sick

Simple rules/practices and time tested. These are all the things that make the typical cold and flu season tolerable and minimize infection.

Having said all this, I oppose any government mandated wearing of masks. It's that simple. Choosing to wear a mask is a personal decision and must always remain a personal decision. If you pass a requirement to wear a face mask, I will take my business to more people friendly communities.

Dear Alderman Bauman:

I have just learned about the proposed mask ordinance and am writing to express my opposition. I have read every document in the Common Council legislative file #200344, and I have found no scientific evidence in there to support the proposed subsection 2 of the new section 62-8, requiring a mask to be worn outdoors whenever the person is in an outdoor public space and sees a person within 30 feet who is not a member of the person's family or household.

Nor have I read any scientific evidence suggesting that mask-wearing is always (or ever) necessary when outdoors and coming within 30 feet of another person.

Please do not vote to pass a highly divisive law that will be ignored by a significant portion of city residents that is not supported by competent, up to date, scientific evidence.

My understanding of the latest scientific thinking is that it is not just distance that is important, but time that is spent near others. In other words, a person who simply walks past someone outdoors at a distance of six feet is very, very unlikely to get the virus, but people who hang out with others in a crowded outdoor area (like an outdoor dining patio), even if everyone is six feet away, is at more risk. In this regard, I would recommend that you read the recent work of University of Massachusetts at Dartmouth professor Erin Bromage, who wrote, "Remember the formula: Successful Infection = Exposure to Virus x Time." He has been interviewed on CNN, among other media.

Thus, according to this thinking, the 30 foot requirement for casual passers-by is completely useless and may be difficult to defend in court.

Further, the 30 foot requirement would be inconsistent with whatever law or guidance that currently permits outdoor dining. Unless the outdoor tables are 30 feet apart, outdoor dining



would not be permitted under this ordinance. And if you were to exempt outdoor dining from the ordinance, that would be evidence of the lack of need for the ordinance and would be another reason why the law would have difficulty withstanding legal challenge.

I am not sure if you will get a say in this mask situation that seems to be brewing everywhere. But if you do please consider

voting against the mandatory mask wearing.

Many reasons why we should not be forced to wear them and I'm sure you have heard them all.

But with the "defund police" (which I find ridiculous) who will enforce this rule? What kind of fines would it be?

I pay over \$6000 in taxes every year and now people want to tell me to wear a mask that will, in the long run, cause damage and health issues? I am all for if a business (and Menards, Costco, etc...have been doing it from the start) feels the need to make it one of their conditions, fine. Also did you know that for every case of a positive CV diagnosis they must get tested every week? Every test is considered a new patient. So if you have it 8 weeks you are considered 8 patients. They count tests, not patients. These counts have been skewed from the beginning. I am blessed to not have had it, or anyone I love have it or even know someone, or know someone that knows someone that has it. I have people in my life with organ

transplants, heart issues, cancer, diabetes, and just all around bad health and not one of us have gotten sick. I work at a job that I talk to people all over the country and not 1 has had it or has a loved one that's had it.

My city is turning into a joke. Since the end of May when the protests started I had 3 weeks of every day protesters coming by my house and most did NOT have a mask on but I was stuck inside. The hypocrisy of allowing protest after protest going with out masks and yet those of us who have followed the rules of stay home orders are now again going to get punished.

How many of those protesters pay property taxes? I would guess very few. Yet they get to do as they please but tax payers will be stomped on to wear a mask.

Please consider voting not to make mask mandatory.

Dear Alderman Bauman,

My name is Kelly Schlicht and I am a constituent who lives in the Third Ward.

First, let me say I am in favor of a mask mandate in the city. I whole-heartedly agree that people should wear masks indoors and within close proximity to people not in their family units. My husband and I bring masks with us everywhere we go.

However, I am concerned with the language in the proposal that states that everyone must wear a mask outdoors within 30 feet of someone not in their family unit/household. As someone who runs and walks every morning and most evenings by myself in the Third Ward, Downtown, and Lakefront areas, I would need to wear a mask essentially anytime I left my apartment. It seems to be an excessive distance requirement.

In the early days of the COVID-19 pandemic, I did attempt to wear a mask at all times when outdoors. While running in 40 to 50 degree weather, after short distances, I found it nearly impossible to breathe. I can't imagine how difficult it would be to breathe with masks in 90 degree weather that we have right now. Additionally, many people are taking refuge in outdoor exercise because they do not want to be indoors at a gym, where it is considerably more dangerous and risky. There are several articles from the NY Times, the Washington Post, and other reputable news organizations who have interviewed infectious disease experts. Those experts say it is highly unlikely to catch COVID-19 while running outdoors by yourself. It is not impossible, but quite rare, to have the right amount of the virus particles carried on the right air stream, just as someone else is passing you, that would allow them to become infected, or vice versa.

I would urge the city council to take a look at the mask mandate from Madison/Dane County. Theirs seems to be a bit more reasonable than the proposal here in Milwaukee.

If the council does adopt a plan that requires you to wear a mask outdoors, I suggest the mandate require masks to be worn if you are outdoors and within 6 feet of someone not in your family unit/household for more than 5 minutes.

I just wanted to throw this out there as it relates to the mask requirement discussion that is coming up with the Common Council tomorrow.

I'm sure everyone is discussing the pros and cons but I would like to throw the question out there... Who is going to enforce the requirement?

The police department is already inundated with calls that are of a lower priority and citizens end up having to wait long periods before the officers arrive.

Just think about how busy downtown is with patrons on the weekend since we have opened up, it will be a nightmare to enforce.

Also, since there are proposed exceptions to the mask, a lot of citizens are not going to be approaching non-wearing mask citizens to see if they have a reason for not wearing the mask, they are likely to just call the police not knowing if the person has a legitimate reason for not wearing a mask. The police will just be called to sort it out - taking up a lot of resources unnecessarily.

Protocols have changed since the beginning of this pandemic. The back and forth on mask recommendations from the CDC. Again, it's just a recommendation.

Dear Alderwoman Dimitrijevic,

I appreciate the active role you have taken in Milwaukee's response to the COVID-19 pandemic thus far. I'm concerned, however, that the ordinance you've recently proposed mandating the wearing of masks indoors and outdoors will have unintended side effects, despite its commendable intentions.

Edgar Mendez (of *Milwaukee Neighborhood News Service*) recently FOIA'd MPD's records for the 177 individuals arrested for violating Milwaukee's stay-at-home order. He found:

Of the 177 individuals arrested from March 27 to May 12, 138 were African American (78 percent), and 21 were Hispanic (12 percent), according to MPD data. Only 6 percent of those arrested were white.

He found that 26% of arrests occurred in the 53206 zip code alone. (Full disclosure, I made the maps which appear in his article).

An ordinance which allows the Milwaukee Police Department to arrest people on sight is a recipe for disaster. Even when officers are not acting with prejudiced intentions they will still simply have more opportunities to enforce this order in communities of color because those areas are more heavily policed.

I appreciate that your proposed ordinance includes fines which are much lower than those imposed by the stay-at-home order. But even small fines can snowball into warrants, derailing the lives of those affected.

I believe it is imperative that Milwaukee addresses racial inequality in all its public health measures. *An alternative approach to the ordinance currently under consideration could be penalizing businesses, rather than individuals, which fail to enforce mask wearing.*

## 2019 ASSEMBLY BILL 617

November 19, 2019 - Introduced by Representatives Tauchen, Spiros, Tusler, Steffen, Ballweg, Ramthun, Schraa, Wittke, Kulp, Brandtjen, Dittrich, Duchow and Tittl, cosponsored by Senator Nass. Referred to Committee on Criminal Justice and Public Safety.

**1An Act** to renumber 947.01 (1); and to create 947.01 (1) (b) of the statutes;

**2relating to:** committing disorderly conduct while wearing a mask and  
**3**providing a penalty.

### *Analysis by the Legislative Reference Bureau*

Under current law, a person who engages in violent, abusive, indecent, profane, boisterous, unreasonably loud, or otherwise disorderly conduct under circumstances in which the conduct tends to cause or provoke a disturbance commits the crime of disorderly conduct and is guilty of a Class B misdemeanor.

This bill increases the penalty to a Class A misdemeanor if the person commits the crime of disorderly conduct while wearing a mask to conceal his or her identity. The bill provides specific exceptions to the increased penalty such as excepting masks worn for religious beliefs, masks worn as holiday costumes, masks worn for protection from the weather, or masks worn for employment purposes.

Because this bill creates a new crime or revises a penalty for an existing crime, the Joint Review Committee on Criminal Penalties may be requested to prepare a report.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

**4Section 1.** 947.01 (1) of the statutes is renumbered 947.01 (1) (a).

2947.01 (1) (b) 1. In this paragraph:

3a. "Highway" has the meaning given in s. 340.01 (22).

4b. "Mask" means an item or material that covers the face or part of the

62. Whoever, while violating par. (a), wears a mask with the intent to  
conceal his  
7or her identity is guilty of a Class A misdemeanor if any of the following applies:

8a. The actor uses, enters, or remains on a highway, sidewalk, walkway, or  
bike  
9path.

10b. The actor enters or remains on property owned, occupied, or  
controlled by  
11the state or a local governmental unit.

12c. The actors holds or participates in a meeting or demonstration on  
property  
13owned, occupied, or controlled by another person unless that person has  
provided  
14written permission to the actor.

153. Subdivision 2. does not apply if any of the following applies:

16a. The mask is worn because of religious practices or beliefs.

17b. The mask is worn as part of a holiday costume during a holiday  
season.

18c. The mask is worn to provide protection from the elements.

19d. The actor is engaged in a trade, employment, or a sporting activity  
and the  
20mask is worn for physical safety of the actor or because of the nature of the  
trade,  
21employment task, or activity.

22e. The mask is worn as part of a theatrical production, masquerade ball,  
23parade, ceremony, or celebration.

1f. The mask is worn as part of a prescribed part of a civil defense drill, a civil
