In accordance to your instructions in filing a claim against the City of Milwaukee, please use this letter as one of the documents needed stating the circumstances of the incident in question.

On the evening of October 4th, 2000 at approximately 6:00 PM, my house, and privacy was violated by a tactical squad of the Milwaukee City Police Department. I reside at 2756 North 24th Street in the City of Milwaukee.

On the evening in question, several police officers were responding to a proposed shooting call that apparently happens in my neighborhood. As I was sleeping in the front room, I was awakening from a noise coming from my front porch. As I went to go see what the noise was, I was greeted by several police officers with guns and a loud noise in the rear of my house. As the police officers rushed into my house from kicking in my two back doors, causing over \$_____ dollars in damage, they immediately began to question me about an alleged shooting. At this time, the lead officer, while pointing his weapon at me, was constantly yelling and asking me is they're anybody else in the house. I am an elderly woman with a heart and kidney condition that had been at my dialysis treatment earlier that day and was subjected to brutal treatment for a incidence that could have been avoided by simply ringing my front door bell or further investigation into the matter by the police department.

The lead officer stated to me that there were reports that a man had been found down the street from 2 gunshot wounds that came from my house. After searching my house for about ½ hour to verify what I have told them was correct and that there was no shooting that occurred in my house, the officers left without fixing what they damaged or even

apologizing for what they did. As I question the lead officers about the damage to my doors, he simply stated that I need to file a claim with the city and then left.

At this time, I have enclosed to two itemized estimates from _____ and ___ indicating the amount of money needed to properly repair my doors to there usefulness. I would appreciate your response to this matter be handled in a quick and professional manner, totally different that the way your officers handled the situation at my house.
