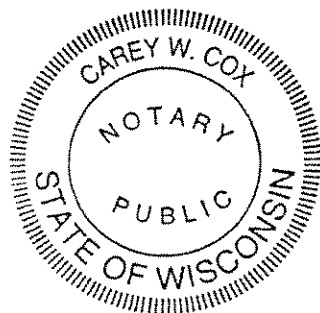

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, and sodding.

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.
