We are in receipt of your claim for damages to your 2006 INFINITI QX56 in the amount \$4,229.04 that resulted from a driver of a stolen vehicle striking your vehicle while parked, in the midst of being pursued by the Milwaukee Police Department on September 24, 2019.

We have conducted and concluded our investigation of this matter. Our investigation revealed that the Milwaukee Police Department followed standards and procedures as it relates to high speed pursuit. The damages to your vehicle was a direct result of the driver of the stolen vehicle, losing control of that vehicle, colliding into your vehicle while being parked, as the driver of the stolen vehicle was being pursued by the Milwaukee Police Department.

The City bears no negligence in this matter. The City cannot accept liability for the damages to your vehicle that resulted from the September 24, 2019 incident. There, we are denying your claim.
