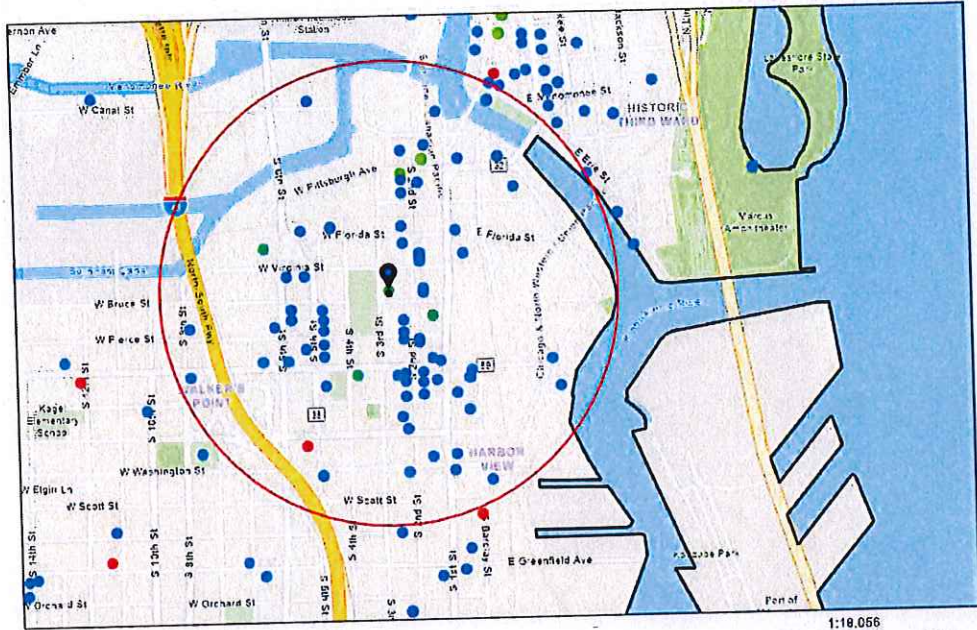
ADDITIONAL COMMENTS/RECOMMENDATIONS:
