2nd Aldermanic District

W. Florist Ave. – N. 68th St. to N. 76th St. (ST211070124):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (0-7 foot width of tree border area), and grading.

3rd Aldermanic District

E. Back Bay – A point east of N. Terrace Ave. to N. Terrace Ave. (ST211110128):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (1-7 foot width of tree border area), and grading.

5th Aldermanic District

W. Courtland Ave. – W. Potomac Ave. to N. 84th St. (ST211110126):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8 foot width of tree border area), and grading.

W. Peck Ct. – N. 86th St. to a point west of N. 86th St. (ST211060113):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (13 foot width of tree border area), and grading.

W. Townsend St. – N. 84th St. to N. 86th St. (ST211060149):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7-8 foot width of tree border area), and grading.

N. 88th St. – W. Tucker Pl. to W. Capitol Dr. (Including W. Tucker Pl. – W. Lisbon Ave. to W. Elmore Ave.) (ST211120120):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6-10 foot width of tree border area), and grading.

8th Aldermanic District

S. 36th St. – W. Burnham St. to W. Mitchell St. (ST211120152):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (4 foot width of tree border area), and grading.

S. 50th St. – W. Cleveland Ave. to W. Jerelyn Pl. (ST211030103):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (14 foot width of tree border area), and grading.

10th Aldermanic District

W. Main St. – S. Hawley Rd. to S. 70th St. (ST211110139):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (2-7 foot width of tree border area), and grading.

W. Michigan St. – N. 91st St. to N. 93rd St. (Including N. 93rd St. – W. Blue Mound Rd. to W. Wisconsin Ave. (ST211120131):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7-8 foot width of tree border area), and grading.

W. St. Paul Ave. – N. 91st St. to N. 92nd St. (Including N. 91st St. – W. St. Paul Ave. to W. Blue Mound Rd.) (ST211120149):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6 foot width of tree border area), and grading.

11th Aldermanic District

W. Fremont Pl. – S. 63rd St. to S. 67th St. (ST211120151):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7-8 foot width of tree border area), grading, and install traffic calming speed hump(s).

W. Montana St. – S. 55th St. to S. 58th St. (ST211120133):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6-9 foot width of tree border area), grading, and install traffic calming speed hump(s).

W. Wedgewood Dr. – S. Honey Creek Dr. to S. 76th St. (Including W. Wedgewood Ct.) (ST211120136):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6 foot width of tree border area), and grading.

13th Aldermanic District

S. 18th St. – W. Morgan Ave. to W. Holt Ave. (ST211120103):

Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (6 foot width of tree border area), grading, and tree removal where necessary.

15th Aldermanic District

N. 37th St. – W. Hadley St. to W. Locust St. (ST211120162):

Install traffic calming speed hump(s).
