Report on the Renewal Application of the Class "D"

Bartender License of Pedro L. Rodriguez

FINDINGS OF FACT

1. Pedro L. Rodriguez (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2009.

- 2. An application to renew said license was timely filed with the Office of the City Clerk on December 18, 2009.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On December 21, 2009, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
- 4. On August 25, 2010, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on September 8, 2010, commencing at 1:30 p.m. in Room 301-B of City Hall. At said date, time and place, the licensee did not appear and he was not represented by counsel. That was the applicant's second nonappearance.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

A notice of the hearing as well as a copy of the police report was sent to Pedro L. Rodriguez at 1625 South 8th Street, Milwaukee, Wisconsin 53204 on August 25, 2010 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 1625 South 8th Street, Milwaukee, Wisconsin 53204 is the address given by the Licensee on his application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on September 8, 2010.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based on the above facts found, the Committee concludes that the Licensee, Pedro L. Rodriguez, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon nonappearance.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Pedro L. Rodriguez based upon a second nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "D" Bartender License be denied based upon nonappearance.

Re: Report of the Renewal Application of Brian L. Crawford, for a Class "B" Tavern license for the premises located at 2060 North 24th Street in the City and County of Milwaukee, Wisconsin ("Toxic").

FINDINGS OF FACT

- 1. Brian L. Crawford (hereinafter the "Licensee") is the holder of a Class "B" Tavern license for the premises located at 2060 North 24th Street in the City and County of Milwaukee, Wisconsin ("Toxic"). Said license expired at midnight, July 27, 2010.
- 2. An application to renew said license was timely filed with the Office of the City Clerk on June 28, 2010.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of this license on June 28, 2010.

The hearing notice also stated that there was "Objection to the renewal of the license due to applicant's failure to comply with the Milwaukee Code of Ordinances §90-11-1-f which states: 'If any person fails to have issued by the city clerk prior to the expiration of the license an alcohol beverage retail establishment license that has been approved by the common council, the person shall not be permitted to apply for and be issued more than one renewal license for the premises, provided that the person is residentially and in all other respects qualified to make the application. The common council may waive the

provisions of this paragraph if unusual circumstances have been demonstrated."

In addition, there were also claimed neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, drug and criminal activity, prostitution, trespassing, public urination, fights, shootings, vandalism, thefts and conduct which is detrimental to the health, safety and welfare of the neighborhood.

- 4. On August 25, 2010, the City Clerk's Office provided notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report that could form the basis for nonrenewal or suspension and the neighborhood objections and included a copy of the police report. The matter was scheduled for a hearing on the police report and neighborhood objections on September 8, 2010 at 9:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee did not appear and he was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
- A. Based upon the records of the License Division of the City Clerk, the licensee has not had his Class'B'Tavern license issued by the City Clerk for the last three years, contrary to 90-11-1-f, Milwaukee Code of Ordinances.
- B. On January 22, 2009 at 12:50 a.m., the licensee received a citation for liquor license required at 2060 North 24th Street. The licensee was found guilty on this citation on June 5, 2009 and fined \$3,231.00 with the balance of \$3,211.00 due by June 25, 2012.
- C. On January 28, 2009 at 10:55 p.m., officers of the Milwaukee Police Department conducted a license premise check at 2060 North 24th Street. The investigation revealed that the licensee did not have a valid Class'B' Tavern license due to holds that were in place on the license. The officers observed nine patrons in the bar drinking fermented malt beverages. Officers spoke to the licensee, Brian Crawford, who stated he did not believe there were any holds remaining and that he called city hall that day and was told there was a mistake made and that

there were currently no holds preventing him from operating. A citation was issued to the licensee for license required. The licensee was found guilty for the license required citation on June 5, 2009 and was fined \$3,211.00 which is due on June 25, 2012.

D. There were objections to renewal of this license by neighbors Ida Grant, Albert Grant and others.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Brian L. Crawford, who holds a Class "B" Tavern license for the premises located at 2060 North 24th Street in the City and County of Milwaukee, Wisconsin ("Toxic"), has not met the criteria of Chapter 90, specifically§90-11-1-f of the Milwaukee Code of Ordinances, together with the neighborhood objections, police report and nonappearance to allow renewal of his Class "B" Tavern license. The Committee finds the police report as stated above to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Class "B" Tavern license of Brian L. Crawford for the premises located at 2060 North 24th Street in the City and County of Milwaukee, Wisconsin ("Toxic") based upon the license applicant's nonappearance, failure to comply with \$90-11-1-f of the Milwaukee Code of Ordinances and the above-described factual findings from the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "B" Tavern license held by Brian L. Crawford for the premises located at 2060 North 24th Street in the City and County of Milwaukee, Wisconsin (Toxic') not be renewed based upon the police report, neighborhood testimony, nonappearance and \$90-1-f of the Milwaukee Code of Ordinances.
