Dear Council Members:

Returned herewith is a document filed by Attorney Laurie Eggert for attorney's fees for representing Police Officers Luis Aguilar, Trinidad Rodriguez, James Hernandez, Alberto Riestra and Richard Scharnott. The claim is in the amount of \$468.99 including \$6.99 in disbursements for 4.20 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the police officers on whose behalf this claim was filed.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Wis. Stat. § 895.35, *Bablitch and Bablitch v. Lincoln County*, 82 Wis. 2d 574 (1978).


The above-named police officers have retained us to represent them in connection with the above-referenced matter.

On Friday, November 5, 1999, this case was ordered in to the District Attorney's office where it was reviewed by Assistant District Attorney Thomas MCADAMS, in the presence of Lt. James SHEPARD and Det. Hattie NICHOLS, both of the CIU/IAD. The complainant, Mr. CREGO, failed to appear as requested.

Assistant District Attorney MCADAMS no processed the case due to the lack of cooperation from the complainant and insufficient evidence to prove the case beyond a reasonable doubt.

This complaint is cleared as warrant refused.
