To Whom It May Concern.

I am writing to appeal against the charge related to graffiti nuisance violation for 2465 W Vliet Street. The first item I want to address is my mailing address. I have not resided at the address listed on the bottom of the letter since 2014. My correct mailing address is PO BOX 26790, Wauwatosa, WI 53226. I received water bills and other city notices there so I did not know that I additional departments should be updated.

I received the notice dated 7/15/25 on the evening of 7/27/25. This notice said that the graffiti needed to be removed by 7/22/25. This date had already passed by the time I had this notice in hand. I called the listed Inspector, Kewand Eskridge on 7/29/25 at left him a message regarding the letter. I called him again on 8/1/25 regarding the letter and left a voicemail. Neither message was returned. I called Kewand again on 8/7/25 and left a message. I also emailed him on 8/7/25. I let him know in the email that I left him a couple of voicemails and how I planned to address the graffiti on the building. I let him know that due to the material of the building, I had researched the solvent specialized for bare brick and called the local retailers. There were only two local realtors and neither had it in stock. I said that I ordered the solvent and once it arrived, I would have someone remove the graffiti.

On 8/7/25, later that morning I received a message from Dave Silver and he left me a message saying that the order had been in for a contractor to abate the graffiti. I called Dave Silver and left him a voicemail and asked him to give me a call. I called Lori Gallop and spoke with her about the property. She looked it up and said that an order had been

put in but it had not been completed. She looked up the photos to see if it was gang-related because that is a priority. She said that it did not look like it was. She asked how much time I would need to move the graffiti, and I said two weeks. She said that she would investigate my options and get back to me.

Later that afternoon on Thursday, 8/7/25 I received a call from Dave Silver, he said that he had spoken with Lori and she told him I needed two weeks. I told him the solvent was being deliver ed that day and I would be getting the building cleaned. Dave said that the order had been put in and the person in charge of that department was out on leave. He said that he contacted that department to try to get the order cancelled. He told me that if someone came out and I was there I could send them away. He said that he would contact the department again on Monday 8/11/25. He said that if no one came out by then I should be okay. I was at the building when I was having all of these calls. The gravffitti was still on the building.

On Friday, 8/8/25 I drove to the building and there was a grey pick up truck begind it and a man was on the phone standing near the graffiti. I approached him and asked was he from the city, because I would be taking care of the graffiti. He became irate and told me not to ask him questions. I said that this is my property, and he said that he was working somewhere else even though he was parked behind my building. I explained again that I would be taking care of the graffiti. He said he was not from the city.

The weekend that followed 8/9/25 -/8/10/25 was the heavy flooding, so no work was done on the building. Grafitti was still there 8/11-8/13. I was there taking care of flooding ssiues. On 8/15 I came and the Graffitti was had been scrubbed. I had scheduled someone to come out the upcoming weekend. I called Dave and asked him what happened. He investigated the file and suddenly it sys that they came out on 8/3/25. He said that doesn't makes sense because he spoke after that. He told me that I could file an appeal and that there was enough notes there to support it.


On 8/26/25, I received a call from Herlyn Robetson saying that Dave said I had a question about how the graffiti program works. I told her that I did not have a question about how the program works but a concern about why contractors came out after emails were sent asking the order to be stopped. She said that they came out on 8/3/25 and I told her that was impossible because I was talking to Dave and Lori on 8/7/25 standing outside my building. She said that she has been working with these contractors for years and so she believes them. She said that she has pictures, and I asked were they time stamped. She said yes. I said that was impossible and could she please email them to me. She emailed me 3 pictures. Only one had a time stamp of 7/15/25, the date the order was made. The other two pictures were photos with words typed across them. These are not true dates.


There was no work completed on the property on 8/3/25. I have enclosed pictures and phone documents for your review.
