Hello.

I live on the same block as 817 W. National Ave and I am opposed to the new licence of Customers Only MKE in the the region's level one trauma center. A requirement of my duties is that I am on call during the overnight shift at least once a week. When I am called in due to an emergency or mass casualty situation (like we just saw with the tragedy in Waukesha), I have 30 minutes to get to the hospital and the only way into or out of the alley is past the proposed entryway into Customers Only MKE LLC establishment.

The applicant already shows no regard to blocking the alley when they are only the barbershop Flip 'N Styles now. As this is my only way to and from my garage, I have already been blocked in and out and had to go find someone to move the cars. This will only escalate if they are allowed to go forward with their plans for a bar/nightclub. Along with the cars, they do have a large amount of trash in the alley too. I have seen furniture and other large items just pile up and sit in the alley for weeks. The dumpster that they have also has been jutting into the alley way for just about 9 months now. Does the applicant have a plan to handle the extra alley traffic that Customers Only MKE LLC will bring to the alley that 3 families depend on as their only way to and from home?

I am also concerned about the potential violence that having Customers Only MKE LLC bar/nightclub could bring to the block. Just a few weeks ago there was a shooting at the barbershop, Flip 'N Styles that sent two people to the hospital. After that shooting I watched from my living room window as the EMTs, MPD, and MFD closed down the street, secured the area and brought the two victims out. This all happened at 6:00 p.m. in the evening, imagine the kind of trouble there will be at midnight after some drinks have been had. Does the applicant have a plan to address the risk of violence the Customers Only MKE, LLC could bring to the block?

The last opposition I have is that having a bar/nightclub in the block will bring increased noise. As a c my shifts on the weekends start at 6:30 am, and on occasion 3:00 am. I have already been awoken by noise that has come from their parties. Adding a Customers Only MKE LLC bar/nightclub to the mix will just bring yet even more noise and disruption to our block. Would the applicant be taking any precautions to minimize the noise and disruption that will come with people coming and going at all hours of the night?

Hello -

I'm a resident on the block (effectively down) from 817 W. National Ave. and I strongly oppose the new license for CUSTOMERS ONLY MKE LLC. Here's why:

- As a resident, I've seen they already have opened, despite the lack of license throwing "parties" for a while.
- The place is a barbershop already they'd be doing this in the back of the barbershop, making the alley a common way to get in or out of the establishment.
- The alley itself has only one exit point past the proposed location. The applicant already has no care that they block the alley they have a dumpster that we have to drive around, and often cars that park there, forcing us to find someone and ask them to move. They have piles of trash usually a couch or some other pieces of furniture.
- With their parties, all kinds of people park in the alley, blocking it. This will get worse.
- The noise level is already an issue for these parties.
- Not being able to leave our house or let a firetruck into the alley would be very difficult for the 3 families that rely on that one-exit alley.
- As a barbershop, they've already had a bit of a violent past, including a shooting weeks ago that included a barber and customer as victims.
- As a barbershop, they've brought an endless amount of customers who leave their unusually touchy car alarms engaged, and park right out front of my business. National Ave is famous already for motorcycles and loud vehicles rushing by setting off all the alarms. This makes phone / zoom calls impossible. We've asked their

This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. The applicant is on Federal Supervision. Email notification to US Probation Eastern District on 05/08/2019 requesting they provide information to the License Division regarding the probation/parole status and the end date of the status.
- 2. On 07/27/2019 at 9:00pm officers conducted a licensed premise check at Walker's Lounge, 626 S 5th St. The applicant was on scene and stated he was not open to the public but was having a quinceanera for a relative. He stated he was not serving alcohol and he was allowed to have a private party. There was a live band playing and the officer advised to close the doors as the night got later. The applicant was cooperative with the officer.
- 3. On 08/10/2019 at 10:20pm officers conducted a licensed premise check at Walker's Lounge, 626 S 5th St. The applicant was on scene and stated he was not open to the public but was having a private birthday party. The applicant stated he was not serving alcohol but the party had carried in its own beer. There was music playing and subjects dancing. The applicant was cooperative with the officers.

Items #2 & 3 heard at 12/03/2019 meeting for Change of Entertainment

- 4. On 01/29/21 at 11:00pm, Milwaukee Police, along with an Environmental Health Specialist, conducted a license premise at 626 S. 5th Street. Officers and the specialist observed patrons not practicing social distancing, not wearing masks, and standing/dancing. The specialist said he will be issuing three citations. The applicant was cooperative during the investigation. (no citations were found regarding this incident).
- 5. On 06/09/21 at 1:44am, Milwaukee Police, while on patrol, observed a huge crowd and approximately 80 vehicles blocking traffic at 626 S. 5th Street. While on scene, officers observed patrons walking in traffic, vehicles blaring loud music, and motorcycles operating on the sidewalk. Security staff told officers that there were several subjects brandishing firearms outside the tavern and one of the first squads on scene had trash/debris throw at the wagon.
- 6. On 06/16/21 at 12:40am, Milwaukee Police were dispatched to 626 S. 5th Street for a shots fired complaint. Upon arrival, officers observed approximately 20 people running away from the location and speeding off in their vehicles. A security guard was interviewed and he told officers that there was a "scuffle" inside the tavern and they got the people involved out of the business, but there were no shots fired. Officers attempted to talk with the manager but she was extremely uncooperative and stated that she did not hear or see a fight. All other security guards said they were not inside the business and did not see anything.
- 7. On 10/05/21 at 10:15pm, Milwaukee Police, while on patrol in the 200 block of W. Virginia Street, heard several gunshots coming from the southwest of their location. Squads went to investigate the shots fired and were flagged down at S. 5th Street and W. Bruce Street who informed police that someone had been shot outside 626 S. 5th Street. Investigation revealed that the incident appears to be a road rage incident between two vehicles and the victim of the shooting was eating food on the patio of the tavern and was not involved in the argument. The applicant was cooperative during the investigation and provided video footage to officers.
- 8. On 02/07/22 at 10:30am, a Meeting was held at the Second District with officials from the City of Milwaukee and the applicant of 626 S. 5th Street. Topics of discussion were Parking, Security, promotors, and the needs of the neighborhood. Regarding parking, the applicant says they no longer have issues with the nearby church and has security monitor their parking lot. In addition to the security in the parking lot, he has security conduct searches and scan identification cards, as well as have them dress in a similar uniform. The applicant has been in talks with other taverns and has suggested getting a security vehicle to monitor the area. The applicant will continue to have promotors but they will conduct themselves according to his rules. He also realizes the changing demographics of the neighborhood and may need to change his business to meet the needs of the neighborhood.
- 9. On 02/26/22 at 12:00am, a patron of 626 S. 6th Street stated they parked their vehicle near the premise and left their firearm in the vehicle. Upon their return, they noticed their vehicle was broken into and a firearm was stolen. The victim went to a Police District Station and reported the theft.
- 10. On 03/04/22 at 8:41pm, Milwaukee Police conducted a license premise check because they observed traffic cones blocking public parking spaces in front of 626 S. 5th Street. Officers told employees that they could not reserve public parking spaces in front of their establishment and they removed the cones. Follow up was done on a later date and there were no traffic cones in the street and the staff was cooperative with police.

- 11. On 04/18/22 at 12:00am, a patron of 626 S. 6th Street stated they parked their vehicle near the premise and left their firearm in the vehicle. Upon their return, they noticed their vehicle was broken into and a firearm was stolen. The victim went to a Police District Station and reported the theft.
- 12. On 04/23/22 at 1:14am, Milwaukee Police was flagged down for a trouble with subject at 626 S. 5th Street. Investigation revealed that security was removing a group of subjects from the tavern for being disorderly and two subjects began arguing with them. An altercation ensued between the subjects and security and the subjects left. All staff of the establishment was cooperative.
- 13. On 06/10/22 at 9:20pm, Milwaukee Police, along with the Wisconsin Department of Revenue, conducted a license premise check at 626 S. 5th Street. The only violations found were that they only had current receipts for alcohol purchased (they need to have two years' worth) and they had Hookah Pods that contained Nicotine. The pods were confiscated. The applicant was on scene and cooperative during the investigation.
- 14. On 06/20/22 at 2:00am, a patron of 626 S. 6th Street stated they parked their vehicle near the premise and left their firearm in the vehicle. Upon their return, they noticed their vehicle was broken into and a firearm was stolen. The victim went to a Police District Station and reported the theft.
- 15. On 07/17/22 at 1:00am, a patron of 626 S. 6th Street stated they parked their vehicle near the premise and left their firearm in the vehicle. Upon their return, they noticed their vehicle was broken into and a firearm was stolen. The victim went to a Police District Station and reported the theft.
- 16. On 08/19/22 at 12:01am, a patron of 626 S. 6th Street stated they parked their vehicle near the premise and left their firearm in the vehicle. Upon their return, they noticed their vehicle was broken into and a firearm was stolen. The victim went to a Police District Station and reported the theft.
- 17. On 09/16/22 at 11:00pm, a patron of 626 S. 6th Street stated they parked their vehicle near the premise and left their firearm in the vehicle. Upon their return, they noticed their vehicle was broken into and a firearm was stolen. The victim went to a Police District Station and reported the theft.
- 18. On 09/17/22 at 1:00am, a patron of 626 S. 6th Street stated they parked their vehicle near the premise and left their firearm in the vehicle. Upon their return, they noticed their vehicle was broken into and a firearm was stolen. The victim went to a Police District Station and reported the theft.
- 19. On 09/24/22 at 12:59am, a patron of 626 S. 6th Street stated they parked their vehicle near the premise and left their firearm in the vehicle. Upon their return, they noticed their vehicle was broken into and she was missing shoes, a bag, nail tools, and U.S. Currency. The victim called the police.
- 20. On 09/30/22 at 11:00pm, a patron of 626 S. 6th Street stated they parked their vehicle near the premise and left their firearm in the vehicle. Upon their return, they noticed their vehicle was broken into and two firearms were stolen. The victim went to a Police District Station and reported the theft.

- 21. On 10/01/22 at 1:00am, Milwaukee Police, while on patrol, observed four vehicles obstructing traffic in front of 626 S. 5th Street. Officers asked security about the vehicles and they told officers that the operators of the vehicles had paid for parking and were waiting to enter the parking lot of the establishment. Police blocked the streets in order to alleviate the traffic congestion and security removed the vehicles into the parking lot.
- 22. On 11/19/22, Milwaukee Police took a report of an entry to auto which occurred at 400 W. Bruce Street. The auto was entered the night before or the early morning hours of 11/19/22 and the victim's firearm was taken. Investigation revealed that the victim parked his vehicle at the location and went to the tavern located at 626 S. 6th Street. When he returned his vehicle had been broken into and his firearm was stolen. The firearm was later recovered in the trunk of a homicide victim's vehicle.
- 23. On 12/08/22 at 1:30pm, Milwaukee Police conducted a meeting with tavern owners and the Association President in Walker's Point. The meeting was to discuss theft from motor vehicles, patron conduct, staggered closing time, sharing security personnel, bring back the South 5th Street Festival, and having a traffic study done on S. 5th Street. Attendees stated that they were generally content with the Milwaukee Police Departments current present level in the area.
- 24. On 01/01/23 at 2:48am, Milwaukee Police were dispatched to 626 S. 5th Street for a shooting compliant. Investigation revealed that a fight happed inside the tavern and one of the subjects produced a firearm and shot two people. The fight resumed outside and more shots were fired. One casing was found inside the establishment and three were located outside, directly in front of the tavern. The applicant told officers that he will no longer employ the security company since they failed to pat down patrons correctly. As of this report, officers have been unable to retrieve surveillance video of the incident.
- 25. On 01/03/23, Milwaukee Police did draft and submit a "Notice of Nuisance Premises" designation for the address of 626 S. 5th Street.

and his attorney, Chris HAYDEN, regarding general concerns around the premises.

The meeting began with introductions and a summary of recent license premises reports for Walker's Lounge. The licenses for the premises had been renewed with a suggested ten (10) day suspension.

The following items were then discussed:

Parking - Officers brought up concerns from the Our Lady of Guadalupe Parish regarding patrons/staff parking in the church's parking lot. MARTINEZ stated that this has been resolved and the lot is no longer used. Officers brought up the large volume of "Entry to Autos" complaints in the area and that firearms are often the target. Officers suggested that the tavern make an effort to educate their customers to leave their firearms at home, instead of in their parked vehicles. MARTINEZ stated that the premises has a parking lot for approx. 25 vehicles and that it is monitored by security staff.

Security - MARTINEZ stated that in addition to security in the parking lot, there are male and female security officers that check and take pictures/scans of identification for patrons. MARTINEZ stated that the security also conducts searches of patrons as they enter. MARTINEZ stated that the security will also monitor the exterior of the building at bar close. MARTINEZ stated that he will dress similar to security and monitor the premises during business hours. MARTINEZ stated that he typically closes between 2:00 am - 2:15 am, but will close the business early if he gets a sense that tensions are rising amongst patrons. Officers suggested that security attempt to monitor areas where patrons park their vehicles. MARTINEZ stated that he is in discussions with other tavern owners in the direct area to contract for a shared security vehicle to monitor the area during bar time in an attempt to reduce vehicle break-ins. MARTINEZ stated that he has purchased two additional exterior cameras and plans on installing them at the alley rear of the location.

Promoters MARTINEZ stated that he has and will continue to use promoters, but that they have to go induct the miselves according to his rules and that his security is present for events.

General - MARTINEZ stated that he recognizes the demographics/needs of the neighborhood are changing with the construction of a six-story residential building across the street and that he may need to change his business plan to meet those needs/wants. Officers urged MARTINEZ to reach out to neighborhood groups. MARTINEZ stated that he was interested in the possibility of partial street closures during busy tavern hours and was instructed to contact Ald. PEREZ. Officers and MARTINEZ also discussed the possibility of a shared "traffic plan" with other taverns in order to ease congestion at and around bar

On the date of 3/4/2022, while patrolling the District Two Walkers Point area my partner and I observed several constructions cones in front of the address of 626 S. 5th Street. These cones were being used to save parking spaces in front of the tavern WALKERS LOUNGE. My partner and I recorded the cones in front of the business and conducted a tavern check regarding. While inside we spoke to several employees of the tavern who we notified that they are not able to block parking spaces in front of the establishment and that it is a infraction. I requested to speak to a manager or MARTINEZ who operates the tavern but, no manager was available at the time. After speaking to the employees we exited the tavern and observed workers moving the cones out of the street to allow proper parking that is no longer controlled by WALKERS LOUNGE staff members.

On the date of 3/6/2022 I returned to 626 S. 5th Street to follow up and attempt to speak with a manager. Once we entered inside of the tavern I spoke to CHAIREZ, Crystal (F/W, 9/30/1985, 3505 W. Pierce Street, 414-852-3283). CHAIREZ stated she was currently the operating manager of the tavern and that MARTINEZ left prior to our arrival. I asked if CHAIREZ was aware of the construction cones blocking the parking lane and that the tavern could not block parking spaces and or charge patrons for that. CHAIREZ stated that bar staff notified her of our past tavern check and it would not occur again. CHAIREZ also stated that MARTINEZ is aware. Upon this tavern check I did not observe any cones blocking parking spaces in front.

Both times my partner and I entered the tavern the staff was cooperative. The licenses were posted in a open area and were observable. The licenses posted were last years but, when asked they said the city has not mailed the new ones yet. My partner and I then checked online and verified that everything is up to date:

On Saturday, April 23, 2022 at approximately 1:14AM squad 2488 was patrolling the 600 block of S. 5th St which is located in the City and County of Milwaukee, WI, when I was flagged down for a trouble with subject that stemmed from the address of 626 S. 5th St (Walkers Lounge). The unknown female stated that her boyfriend (unknown male) got into a physical altercation with the security at the Walkers Lounge. She stated that the security guard had punched her boyfriend after they had forcibly removed her and her boyfriend from the bar. I attempted to gather their information regarding this incident but the unknown female and her boyfriend refused to give their information and left after giving their initial statement.

I spoke to the head security Javier P. SANDERS (M/B 01-17-1986) who stated the subjects that were complaining were inside the bar and started to argue with another group of individual inside the bar. SANDERS stated he then removed the first group, then waited ten minutes to remove the second group. SANDERS stated that he then began to remove the second group, the unknown female and her boyfriend, and when they got outside the boyfriend began to push and shove him, which he then struck him one time in the face prior to officers arriving. SANDERS stated that the unknown female did spit on him and I observed that he was using napkins to wipe liquor off of his shirt.

I also spoke to Felipe MARTINEZ (M/W 04-181984) who confirmed SANDERS's story and added that when security attempted to remove the second group they began to argue with them and pouring the leding to be a security MARTINEZ stated hat once he observed that the lesue had every one out of the parand closed down.

I also spoke to Andre A.D. GREGORY (M/B 11-16-1997), who confirmed the story. Upon me arriving to the scene I observed GREGORY attempting to deescalate the situation and attempting to separate the party from the security. GREGORY stated that the unknown male had left then comeback when he started to argue with SANDERS and began pushing him. It should be noted that after the bar had clear out, GREGORY was arrested due to the fact that he had an open and active warrant with the Milwaukee Police Department.

Licenses were visible upon entering the bar and all staff were co-operative.

to Squad 2166, I met with licensees or representatives of Walker's Lounge (Felipe MARTINEZ), Snifters, (Julio MALDONADO), Hex (property owner Larry PACHEFSKY), and Hamburger Mary's (Ashley WRIGHT) and Walker's Point Association President, Simmi URBANEK, at Arts @ Large, located at 1100 S 5th St, in order to discuss common problems between the taverns on S 5th St and to work together to find solutions that would benefit the customers, residents, and taverns.

Attendees discussed the issue with thefts from motor vehicles, patrons being allowed to leave taverns with food/alcohol, traffic flow, noise, littering and other nuisance behavior of patrons departing businesses. Attendees were reminded that the behavior of patrons after they have left a tavern is reflective upon the tavern and that patrons should be monitored after leaving the tavern.

Attendees discussed the issue of parking and traffic flow on S 5th St at close of business. It was suggested that the taverns share closing time information with each other so that a tavern(s) that is not busy on a particular night could close earlier in the night to allow the busier tavern that night to have space to let customers out. Attendees were encouraged to contact the City of Milwaukee to have a traffic study done and to possibly limit the flow of traffic in the area (S 5th St and surrounding east/west streets) to limit traffic congestion.

Attendees discussed sharing security personnel/and/or knowledge in real time related to ejected or troublesome patrons so that a patron could not be ejected from one tavern and simply enter another in the area. Attendees also discussed the possibility of hiring off-duty MPD officers to patrol the S 5th St area as an "extra-duty" assignment. Attendees stated that they were generally content with MPD's current presence level in the area.

Attendees also discussed the idea of bringing back the "S 5th St Festival" in 2023.

#### INITIAL INVESTIGATION

This report is written by Police Officer Victor HERNANDEZ-FLORES, assigned to District Two, Late Power Shift; Squad 2423

On Sunday January 1, 2023, at approximately 2:48am, Officers were dispatched to 626 S 5th St (Walkers Lounge Bar), which is in the City and County of Milwaukee, for a shooting complaint.

#### INVESTIGATION:

Upon arrival officers observed the first victim, Breonna L. LOVETT (B/F, 12-07-95) exiting the bar stating she was shot. Officers located a graze wound on LOVETT's left side. The second victim, Jawuan J. TUNSTALL (B/M, 4-27-96) was located inside of the bar with a gunshot wound to his right thigh. Both victims were transported to Froedert Hospital by MFD.

According to statements made by witnesses and the owner of the establishment, there was a fight between two groups of people inside of the establishment. The fight turned physical and then shots were fired. There was one brass spent casing located inside of the establishment, and three spent casings located on the sidewalk directly in front of the establishment.

Our investigation revealed that security detail failed to prevent firearms from being brought inside the premise as there was one brass spent casing recovered from inside the establishment and a witness stating that she observed a subject retrieve a firearm from the subject's waistband and discharge it inside the tayern

#### WITNESS INTERVIEWS:

Felipe Martinez Jr (w/m 04/18/1984), owner of the establishment, stated that he was standing at the west-side of the bar. MARTINEZ stated he observed a male subject come up to the bar to get a drink.

MARTINEZ stated that another subject then glabbed the patron to get a drink and a fight begins with other subjects jumping in. MARTINEZ stated that as he and his staff were putting the subjects out of the bar someone started shooting outside. MARTINEZ stated that the patrons began running back into the bar. MARTINEZ stated the subject began running out of the back door. MARTINEZ stated that he did not see the person shooting. MARTINEZ stated he did not know anyone inside the lounge fired any shots until he was told by the police.

Aricelys MEDINA (w/f, 09/07/2003), a bottle server at the establishment, stated that a black male who was in the middle of the bar at table, removed a firearm MEDINA believes either from his ankle or waist area, and began to fire shots. MEDINA couldn't tell if he was firing shoots in the air at the time or at someone, but the unknown male did point the gun in her area as her uncle grabbed her out of harm's way. MEDINA stated that the black male along with his friends ran out the northeast exit onto the

parking lot. MEDINA described the shooter as a b/m, 5'10", med 20's, slim build, with dreads, wearing a long sleeve white shirt with a red Bape symbol on the front, wearing blue jeans.

Breonna L LOVETT (b/f, 12/07/1995), gunshot victim, stated that she was at the club for approximately 20 minutes, ordered a drink and heard people fighting in the club. LOVETT stated she then started running and heard anywhere from four (4) to 10 gunshots and fell to the floor. LOVETT stated she arrived at the club with her cousin Tianna JOHNSON between 2:00 and 3:00 am. when they entered the bar. LOVETT stated that they went to the bathroom and then headed to the bar and ordered some drinks. LOVETT then said while they ordered and paid for their drinks she could hear arguing and fighting in the background. LOVETT stated that people started to throw chairs in the bar, and she started to run to safety. LOVETT stated that when she made it to the end of the bar, she heard over 10 gunshots and then fell to the ground. LOVETT stated that she immediately felt pain in her butt and knew she had been shot. LOVETT stated she didn't see who was shooting.

#### **FOLLOW UP WITH OWNER:**

On 01/06/23 a follow up interview with MARTINEZ was conducted. MARTINEZ stated that on the day of the incident he hired Elite Protection Detail for security he stated he had approximately 5 - 6 security guards working for him that night. MARTINEZ stated that since the day of the incident, he will no longer be employing the company since they failed to pat down patrons correctly.

MARTINEZ was extended an Axon invitation to upload footage of the incident, and since has not uploaded the videos. We will attempt to meet with MARTINEZ again and attempt to recover surveillance footage.

#### ADDITIONAL COMMENTS/RECOMMENDATIONS:

The premise is located in an operating barbershop, near the rear of the building, which is owned by the applicant. The applicant stated that the venue is currently being used as an area for his workers to spend time recreationally and "play games". The location has a bar installed, pool tables and several sofas placed around the room, and a mini fridge stocked with beers and other beverages. There are also pizza ovens, nacho cheese machine, and popcorn machines behind the bar, along with a cash register and credit card machine. There's 2 entrances/exits that he plans to use. One is only accessed by walking through the barbershop, and the other door is accessed through the alley behind the building.

The applicant also explained that he wants to operate the bar through a membership system, where patrons can only use the premise if they sign up for an "appointment", and sign up to be a member of the bar, which allows the "member" special discounted drinks and Happy Hour promotions. The applicant said it be operate like a private club, but also open to the public, and

would like his patrons to be comprised of 90% of the people that he deals with through the barbershop. The applicant stated that he doesn't feel the need for security because of the appointment system he will utilize, and he can control who he allows into the bar. Also, the only seperation differentiating the barbershop from the bar is a sliding "barn door" style door and another swing door.




# City Concentration Map 817 W National AVE




