





- 2. An application to renew said license was filed with the Office of the City Clerk on November 6, 2002.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On November 7, 2002, the Milwaukee Police Department responded with a police report that created a basis for non-renewal or suspension of said license.
- 4. On November 22, 2002, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on December 10, 2002, commencing at 2:00 p.m. in Room 301B of City Hall. At said date, time and place, the Licensee appeared and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On June 18, 1994, Adam Hock was a passenger in a vehicle stopped for a traffic violation and he was found to be in



- possession of alcohol as an underage person. He was found guilty of that charge in Waukesha County.
- B. On June 20, 1994, Adam Hock was a passenger in a vehicle in which the Brookfield Police found drug paraphernalia. He was cited for possession of drug paraphernalia. On May 28, 1998 he was found guilty in Waukesha Circuit Court and fined \$100.
- C, On October 23, 1994, Adam Hock was a passenger in a vehicle in which officers found alcohol. He was cited for underage and possession of alcohol and found guilty in Waukesha Circuit Court.
- D. On February 19, 1995, Adam Hock was found by an officer to be in possession of alcohol at house party. He was cited for underage and possession of alcohol and found guilty in Waukesha Circuit Court.
- E. On July 2, 1996 Adam Hock was at a house party at 2566A North Frederick, Milwaukee, Wisconsin where alcohol was present. The officers approached, the applicant ran but he was later apprehended. Adam Hock was guilty of obstructing in Milwaukee Municipal Court and fined \$50.00.
- F. On July 22, 2000 Adam Hock was charged in Milwaukee County Circuit Court with two counts of hit and run injury (felony) stemming from a May 21, 2000 offense. He was found guilty in Milwaukee County Circuit Court of hit and run, felony, two counts, and sentenced to 50 days in the House of Correction and five years probation on November 29, 2000. The applicant indicated that he simply walked from the scene as he was only one block from his home. The accident involved an injury to the operator of another vehicle.
