6. On 07/09/22 at 12:41a.m., Milwaukee Police were dispatched to a ShotSpotter, which was later updated to a shooting at 3551 N. Teutonia Av. Officers located a victim with multiple gunshot wounds laying in the parking lot of the gas station. The employee was very cooperative and allowed officers to view video surveillance which depicted a vehicle pull into the lot, a subject get out and shove the victim, then fire 3 shots.
7. On 09/11/22 at 2:12p.m., officers were dispatched to 3551 N. Teutonia Av., for a Subject with Gun. The employee stated a subject was inside the store loitering and was asked to leave, when they displayed a firearm and pointed it at the employees making threats and causing them to fear for their safety. The employees locked the subject in the store, however, the subject was no longer on scene on police arrival. The employees were cooperative and allowed officers to view video surveillance of the incident.

LICENSE PREMISE REPORT

On Saturday, 07-09-2022 Squad 5372 (P.O. Chad BOYACK and P.O. Ryan CLEMENTZ) were dispatched to a "Shotspotter" complaint at 3551 N. Teutonia Avenue, City and County of Milwaukee. The dispatcher stated three (3) gunshots had been fired at the location with Flex ID # 81-830795. The call was immediately updated to a possible shooting as a caller stated a boy was shot across from the location at 1925 W. Keefe Avenue. Squad 5372 with SGT. Joseph BOEHLKE were the first squads to arrive at the Citgo gas station at 3551 N. Teutonia Avenue at 12:45AM.

Located by pump # 4 was a victim of the shooting. The victim (identified as a Gino A. CINGRANI, W/M, 08-16-1998) was laying down in agony. CINGRANI appeared to have several bullet wounds to both his left and right upper legs / thigh area. Several feet from CINGRANI'S body was (3) spent / fired gold-jacketed casings, matching the amount of shots detected on the "Shotspotter". At 1:00AM CINGRANI was conveyed to Froedtert Hospital by MFD MED Unit # 7, accompanied by P.O. William MAUCH of Squad 5371.

I (PO TERRELL) entered into the location and spoke with the cashier at the premise who was identified as Timmy OLUBO (M/B, DOB 10/18/1995). OLUBO was very cooperative in this investigation and provided me with the password to view surveillance footage. I then viewed video surveillance from gas station and I observed a pearl white Nissan Rogue or Murano with tinted windows enter into the parking lot of the location. I then observed one B/M subject exit the driver side of the vehicle and approach the victim. The suspect grabbed the victim by his collar, pushed him away, and then shot him three (3) times. The suspect reentered into his vehicle and fled S/B on N Teutonia Ave from the location.

Staszewski. We arrived in a marked MPD patrol vehicle in full capacity as Uniformed Milwaukee Police Officers. This location is a Citgo Gas Station. The caller reported to MPD dispatched a male subject was inside the store armed with a he suspected was a real firearm. Upon arriving we did not observe anyone inside the store displaying a firearm. I made contact with the clerk who subsequently identified himself as Jovempreet SINGH. SINGH stated he was working behind the counter along with his two co-workers when a male subject entered the store and began loitering inside without purchasing anything. It should be noted SINGH spoke clear English, but I determined he did not fully comprehend some questions I asked. He seemed to struggle at times to understand what information I was requesting regarding the subjects' actions and behaviors.

SINGH assisted officers by replaying the in-store camera footage of the incident. SINGH stated the subject entered the store about 1:50pm and walked directly to the rear of the first aisle and stood in the aisle loitering. SINGH stated he was instructed by his boss to not allow people to loiter inside the store. SINGH stated he stayed inside the enclosed, locked area that houses employees and the cashiers. He stated he asked the subject to leave the store if he was not purchasing anything. That's when he instructed him to leave or purchase an item. He stated the subject became agitated and said, "fuck you" and provoked him to come from behind the counter out of the enclosed area and get in his face. SINGH stated the subject continued to make rude comments and use profane language, calling him offensive names. SINGH stated the subject then displayed a firearm and pointed it toward him in a threatening manner. SINGH stated he called 911, he and another co-worker remotely locked the entrance door and closed a steel bar metal gate stopping the subject from leaving.

SINGH stated the subject began to escalate his threatening behavior and started demanding he open the gate and let him leave. SINGH stated when the subject pointed the firearm toward him, he did fear for his life and safety. He stated he did not consent to this behavior. At the time of this report this suspect is not identified. It should be noted SINGH informed officers the locked enclosure they operate in has bullet resistant glass. I did call the listed agent on the license. He was cooperative and did instruct his employees to comply with our request. No further police action was taken.

You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your nPMe, and address. (If your first and/or last nPMes are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.


