This letter is regarding the denial of my claim # 06-5-91 for damage to my door due to unnecessary forced entry by the Milwaukee Police dept. I would like to request a hearing to appeal this decision. As I stated I did not initiate the call and was not in danger as was no one else in the home. There were no weapons as stated by an individual who did not even submit a statement to the police regarding this incident. The individual who placed the call did not stay on the scene and again no statement from him was taken so the allegation of a weapon was false and was not proven after the forced entry.

The suspect was not found in my residence but rather at 2803 N Pierce with no weapons. I was on the phone with an officer as I stood in a window where they could clearly see that I was not harmed and that I didn't need them and that's the reason why I didn't call the Milwaukee Police dept to my home. Before the officer started to break the glass I opened one door and them know that I had to go get the key to open the door from inside but the officer continued to break the glass anyway.


THIS LETTER IS REGARDING DAMAGE TO A WINDOW AT 2801 N PIERCE ON 3/8/06 AT 1:30PM BY THE CITY OF MILWAUKEE POLICE FROM DISTRICT 5. THE OFFICERS WERE CALLED TO MY RESIDENCE BY SOMEONE OUTSIDE OF THE HOME OTHER THAN ME, WHO DOES NOT RESIDE WITH ME. I ASKED THEM WHY THEY WERE THERE AND TOLD THEM I DID NOT NEED THEIR SERVICES. I CAME TO THE WINDOW WHERE THEY COULD SEE MY FULL BODY AND TOLD THEM THAT I WAS OK AND ASKED THEM TO LEAVE.

THEY TOLD ME THAT THEY HAD TO COME IN TO MAKE SURE ALL WAS OK. I WENT TO THE FRONT DOOR TO LET THEM KNOW I WOULD OPEN IT BUT HAD TO GO AND GET THE KEY AS ONE OF THE OFFICERS WAS BREAKING THE GLASS. I TOLD HIM THAT I HAD TO GO AND GET THE KEY FROM MY COAT TO UNLOCK THE DOOR. HE KEPT ON BREAKING THE GLASS. THIS WAS UNNECESSARY AS THE ONLY WAY TO UNLOCK THE DOOR IS WITH A KEY FROM THE INSIDE AND HE HEARD ME TELL HIM

THAT I HAD TO GET IT TO OPEN THE DOOR BUT KEPT ON BREAKING THE GLASS ANYWAY.

I WOULD LIKE TO HAVE THIS REPAIRED AT THE CITY'S EXPENSE DUE TO HIS NEGLIGENCE AND THE FORCEFUL MANNER IN WHICH HE HANDLED THIS SITUATION. AGAIN THIS WAS NOT NECESSARY AS I WAS WILLING TO OPEN THE DOOR BUT HAD TO GET THE KEY. I HAVE TWO ESTIMATES ENCLOSED.

IN ADDITION THE POLICE WERE LOOKING FOR SOMEONE WHO WAS ALLEGEDLY AT MY HOME AND WAS A DANGER TO ME, EVEN THOUGH I NEVER CALLED FOR THEIR SERVICES. THIS PERSON WAS NOT AT MY HOME AT 2801 N PIERCE SO THEIR INTRUSION WAS EVEN MORE UNNECESSARY.
