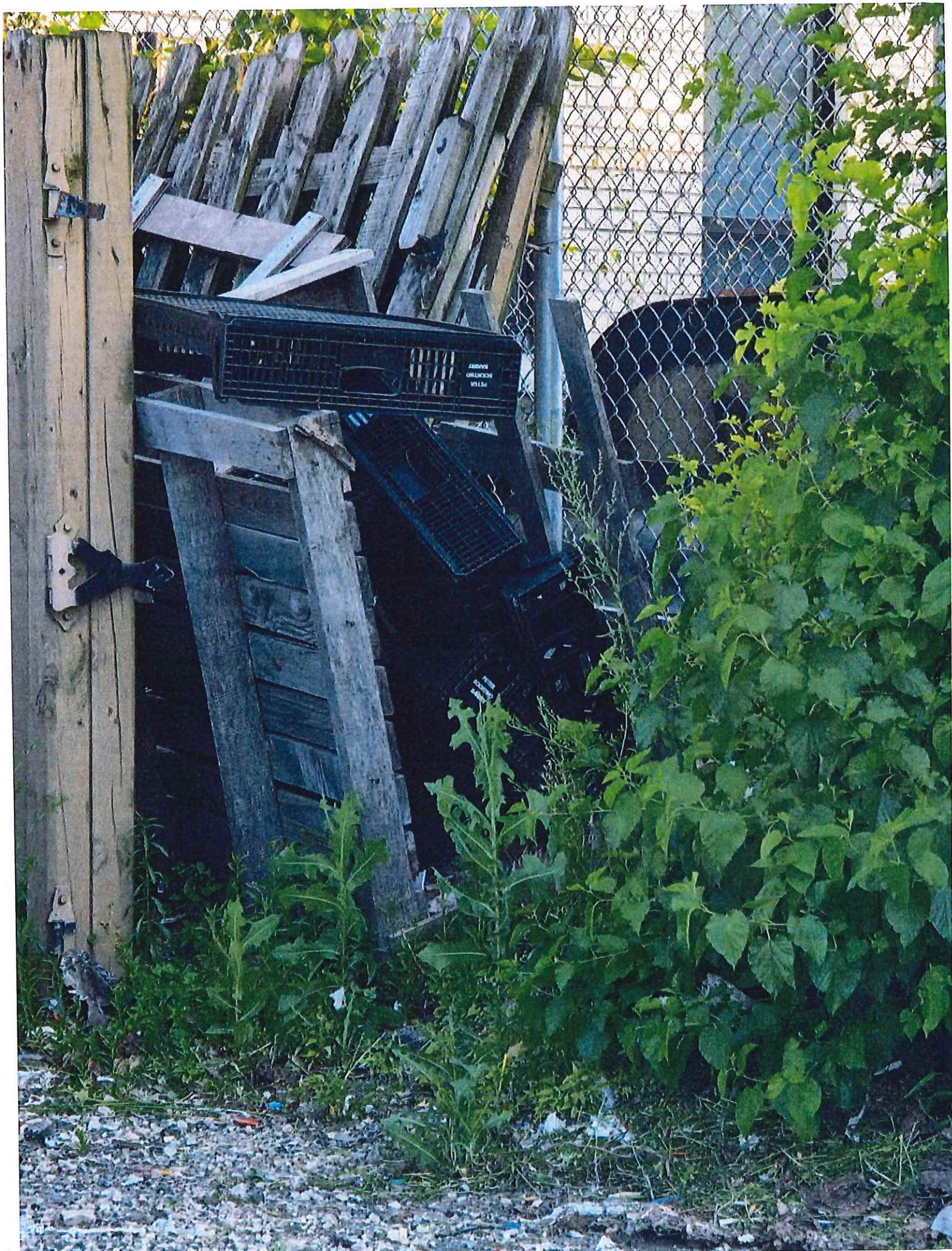

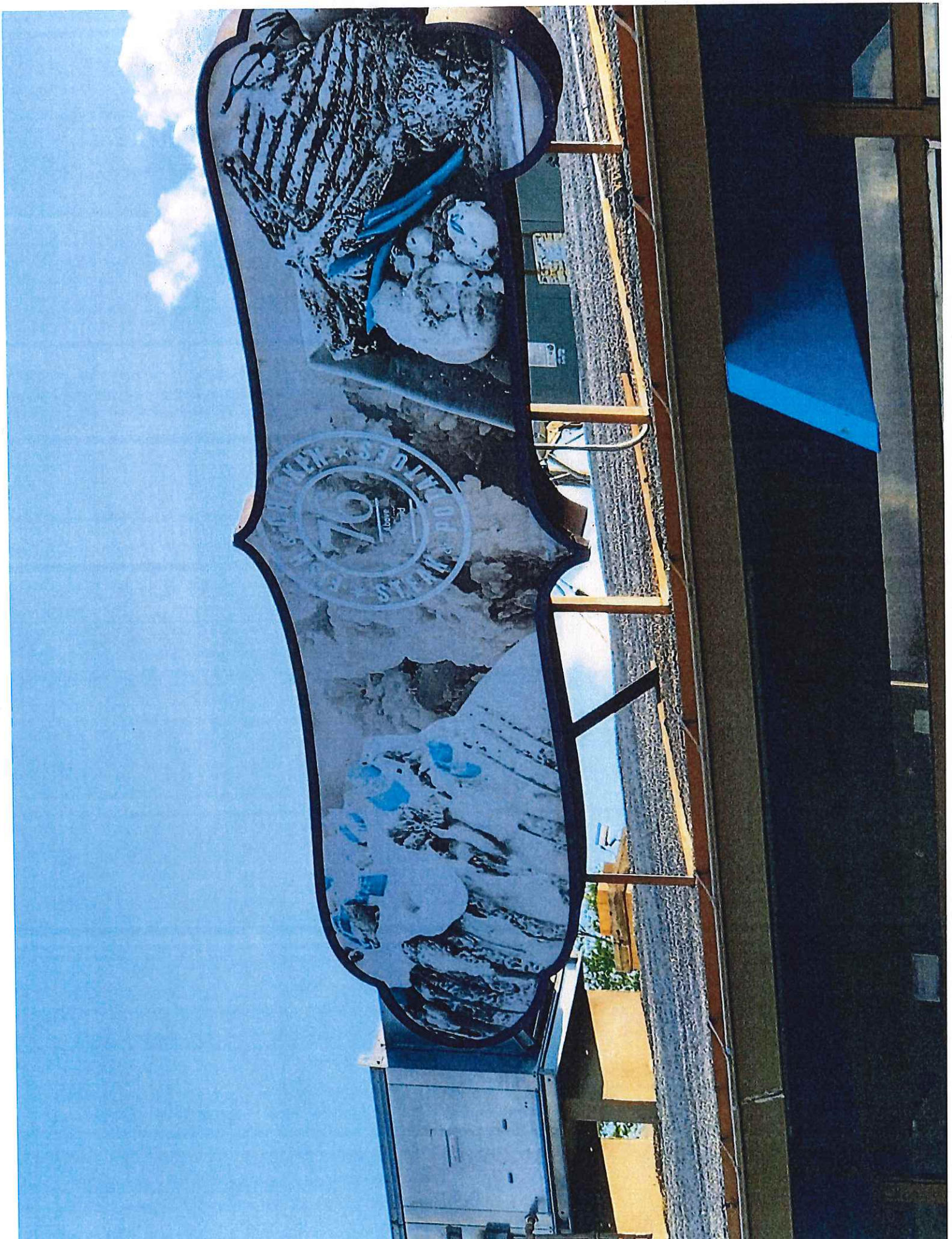

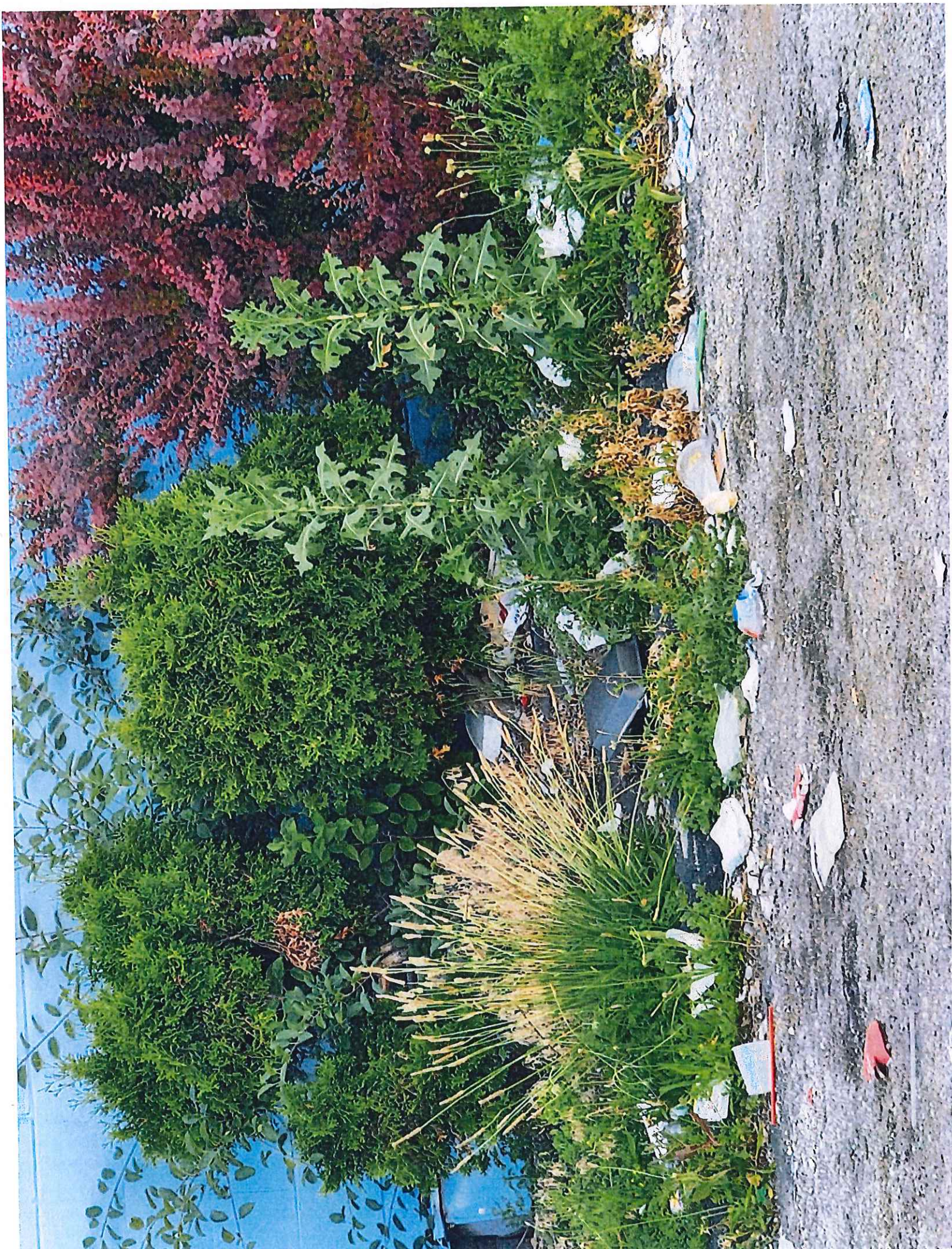

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 07/10/23 Milwaukee Police were dispatched to 7601 W. Hampton Ave, for a shooting complaint. Officers spoke with the manager who stated that shots were fired in front of the business. The manger provided video to officers regarding the incident. The video showed subjects, a vehicle of interest, but it did not captured the shots fired.
2. On 12/05/23 at 4:05pm, Milwaukee Police were dispatched to 7601 W. Hampton Ave, for a property damage complaint. The manager stated that an ex-employee threw items on the floor after being fired.
3. On 12/11/23 at 5:24am, Milwaukee Police were dispatched to 7601 W. Hampton Ave, for an entry complaint. Officers spoke with the caller who stated that a suspect entered the location by force. The suspect then took money that was left in the cash register and attempted to enter the office of the business. Officers reviewed video which captured the incident, the suspect and vehicle descriptions.

4. On 05/22/24 at 7:45p.m., Milwaukee Police were dispatched to a Theft at 7601 W. Hampton Ave. An employee's personal items were taken off the counter, when they went to obtain a customer's food. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

5. On 04/05/25 at 7:37p.m., Milwaukee Police were dispatched to a Trouble with Subject at 7601 W. Hampton Ave. Investigation revealed an intoxicated subject was refusing to leave. The subject requested medical assistance and was transported to a local hospital.

This report is being written by P.O. Tyler STEFFEN, assigned to District 7, Late Power Shift.

On Wednesday, May 22nd, 2024, at approximately 7:45 PM, P.O. Katherine GOMEZ and I (Squad 7420), were dispatched to 7601 W. Hampton Ave, which is located in the City and County of Milwaukee, WI., for a Theft complaint. This is the location of the business named 76 Steak and Potato.

Upon arrival, we spoke to the victim later identified as Srivardhan CHAVATAPALLI (W/M 12-17-1999). CHAVATAPALLI stated, on Wednesday, May 22nd, 2024, at approximately 5:04 PM, at the above listed address, an unknown actor intentionally and without consent stole his personal property. CHAVATAPALLI stated, a B/M walked into the business posing as a "Door Dash" driver and asked for food. CHAVATAPALLI stated, he was standing in the dining area and not behind the glass where the register is at, at the time when the B/M entered the business. CHAVATAPALLI stated, he then placed his phone and air pod case on the counter and walked around behind the counter to get food for another customer. CHAVATAPALLI stated, he noticed the B/M standing by the register and talking on the phone while he was attending to another customer. CHAVATAPALLI stated, he observed the B/M exit the business and remembered that he left his phone and air pod case on the counter. CHAVATAPALLI stated, when he went to grab his phone and air pod case they were gone. CHAVATAPALLI stated, he then realized it was probably then B/M that entered the business and ran outside to confront the B/M. CHAVATAPALLI stated, when he confronted the B/M, he stated the B/M stated, he didn't know what he was talking about and got into a vehicle. CHAVATAPALLI identified this vehicle to be a White Sedan with an unknown plate, leaving the scene eastbound on W. Hampton Ave. CHAVATAPALLI stated, he attempted to run after the vehicle but stopped when he sped up.

CHAVATAPALLI stated, his property cost approximately \$1200 dollars in total.

CHAVATAPALLI stated, he was unable to track his phone and air pods.

Upon reviewing the camera footage, it revealed on Wednesday, May 22nd, 2024, at approximately 5:04 PM, at the address of 7601 W. Hampton Ave, an unknown B/M, with short black dreadlocks, wearing a red T-shirt, gray pants, black shoes, standing around the counter, talking on the phone. It was observed that while the B/M was on the phone, he walked up to where CHAVATAPALLI placed his phone and air pods, grabbed them and put them in his pocket. The B/M was then observed walking towards the exit of the business and out of sight of the camera.

CHAVATAPALLI was unable to retrieve camera footage from outside of the business showing the vehicle drive off.

The hearing before the Licenses Committee will take place on 7/22/2025 at 11:05 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
