5. DESCRIPTION OF PROJECT:

During WJE's visual assessment in June 2021, widespread glaze spalling was observed at previous replacement terra cotta units, including both the 2008 and 2014 vintage material. Many units had multiple spalls on the surface exposing the clay bisque. Generally, the spalls are occurring randomly on flat portions of the units away from the edges of the units, but in some instances spalls with thicker profiles were collected from the twelfth-floor balustrade area at the tower. Additionally, glaze spalling was occurring at units where previous limited glaze spalls had been coated as part of the 2014 repairs and 2017 warranty repairs. In response to these conditions, The City requested WJE to design a temporary stabilization netting system to address identified areas with spalled units and potential spalling, citing potential life safety concerns.

The temporary facade stabilization solution involves the use of the following: (1) self-adhered membrane with stainless-steel termination bar and anchors, (2) stainless steel mesh with stainless steel termination bar and anchors. Typically, the self-adhered membrane is applied at coping units, the mesh is used on flat and curved surfaces, and the fiberglass mesh is employed on free-standing ornamental elements like urns or finials.

The attached drawing illustrates the locations for stabilization installations, categorized by the three types of stabilization methods. Mockups of each stabilization system will be executed at the start of the project. Approximately six mockup locations, each covering an area of around 20 square feet, will be installed at designated sites: one at the cross gable, one at the dormer, one at the 12th-floor balustrade, one at the finial/urn, one at scrolls/drums, and one at the clock gable.
