Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

**Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.**

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing. You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/30/22 at 12:54a.m., Milwaukee Police conducted a License Premise Check at 3300 W. Lincoln Av. Officers observed a Disc Jockey and patrons dancing. Officers interviewed the agent on scene, who stated they are mainly a restaurant; however, they are trying out the tavern business. Officers cleared the scene, however, at 2:57a.m., officers were dispatched to S. 33<sup>rd</sup> and W. Lincoln Av., for a Subject with a Gun. The caller stated subjects were loud at bar close and were asked to leave by the caller. The caller stated one of the subjects then threatened the caller with a gun and began to walk to their vehicle as if to retrieve a gun. The caller stated they called 911, due to fearing for their safety. The officers interviewed the agent, who denied hearing anything because she was inside the tavern. A check with LIRA revealed they did not have a Public Entertainment License and were issued a citation for the violation.

2. On 10/07/22 at 9:13p.m., Milwaukee Police were dispatched to a Battery at 2273 S. 33<sup>rd</sup> St., which investigation later determined occurred at 3300 W. Lincoln Av. The victim stated they were assaulted by an employee at the license premise. Officers interviewed the manager on scene, who denied having access to the cameras. The agent later arrived and stated they have had problems with the victim in the past, however, have not taken any steps to remedy the situation. The agent was asked to allow officers to view video surveillance to determine what occurred, however, she denied the officers access. The officers then requested the agents information, however, she became uncooperative and refused to provide her information or to allow access to video surveillance.
3. On 10/08/22 at 1:12a.m., Milwaukee Police conducted a License Premise Check at 3300 W. Lincoln Av., due to complaints they were operating outside of the scope of their license. Officers observed entertainment lights, a Disc Jockey and patrons smoking out of hookah. The agent stated they were not aware they could not have entertainment on the premise, despite being made aware of this on 10/01/22 by a different officer. The agent was cited for Public Entertainment License Required.

4. On 01/26/23 at 11:48p.m., Milwaukee Police conducted a License Premise Check at 3300 W. Lincoln Av. This was in regards to a Aldermanic complaints received regarding loud music and drunken activity late at night coming from the tavern. On arrival the officers did not observe any activity outside of the tavern. The officers were greeted by the agent, who stated it was R & B night and she has not had any issues on prior dates. The agent further stated she spoke to surrounding neighbors in an attempt to mend issues. The agent was cooperative with the investigation.
5. On 02/02/23 at 11:45p.m., Milwaukee Police were dispatched to a Noise Nuisance at 3300 W. Lincoln Ave. Officers were advised by dispatch the noise was an ongoing issue. Upon arrival and parking across the street from the location, officers could not hear any noise. Officers entered the establishment and spoke to the agent and requested she turn the music down, to which she complied. Officers then contacted the caller, who stated the music was still loud and advised officers they lived two doors down. Officers repositioned their squad in an attempt to hear the music, however, could not hear any noise stemming from the tavern. The agent was cooperative with the investigation.
6. On 06/09/23 Milwaukee Police compiled a summary of calls for service for Noise Violations at 3300 W. Lincoln Av. Between 12/17/22 and 06/09/23, there were a total of 30 calls for service and/or Tavern Checks, with the majority of dispositions being "No violations observed and the caller was advised".

This report is typed by PO Oscar ESPITIA assigned to District Two, Late Power Shift and Squad 2484.

On Saturday October 1st, 2022 at approximately 12:54 AM I drove in front of 3300 W. Lincoln Ave (AsianRican Foods) and observed a security, and approximately 5 subjects standing in front of the business smoking. Myself and squad 2331 (PO HAYES & PO KIBLER) responded to the AsianRican foods and conducted a tavern check.

Upon arrival I observed entertainment lights, a DJ and patrons dancing.

I spoke to Julie L. VALCARCEL (A/F, 03/25/82), who stated she is the owner of AsianRican. VALCARCEL stated she is mainly a restaurant but she is "trying out" the tavern business. VALCARCEL stated she has DJ and 2 unarmed security guards. She continued to state she is going to try to have events at least once a month. She stated she wants her tavern to be a "chill spot", to patrons smoke hookah and listen to music. I advised VALCARCEL that it was important for her to control the noise outside the tavern because she doesn't want to disturb neighbors. VALCARCEL stated she had spoke with the Alderwoman and Police regarding the tavern.

At approximately 2:57 AM Squad 2330 (PO MUNIZ & PO SOSA) along with Squad 2331 (PO HAYES & PO KIBLER), responded to 33rd and Lincoln to investigate a subject with gun complaint. Upon them making contact with the caller, who stated he had called earlier in the night for a noise complaint for 3300 W. Lincoln Ave (AsianRican Foods). The caller stated after bar closed patrons where outside the tavern being loud. The caller stated he told the patrons to leave because they where to loud. The caller stated one of the patrons made threats to get a firearm and walked to his vehicle as he was going to get a firearm. The caller stated he became fearful and went inside his residence and called 911.

Officer spoke with VALCARCEL who denied anything happening and didn't see anything because she was inside the tavern.

While at District Two a license check of 3300 W. Lincoln Ave (AsianRican) revealed they do not possess a Entertainment license. I issued a citation due to the owner of the tavern not possessing the proper license for having a DJ playing music inside the tavern (Cit# 0681NDBC9K).

This report is written by Police Officer (P.O.) Quentin C. ARNOLD, assigned to District Two, Late Power Shift, Squad 2432 partnered with P.O Antwan POWELL. Officer POWELL and I were equipped with an AXON body worn camera, which captured this investigation.

On Thursday, January 26th, 2023, at approximately 11:48 P.M., Squad 2432 Officer POWELL and I (While in full duty Milwaukee Police Uniform with the Milwaukee Police Badge on our outer most garments, operating a marked Milwaukee Police Squad 511 equipped with operating emergency lights and audible siren) conducted a tavern check at the tavern named Asian-Rican at the address of 3300 W. Lincoln Avenue located in the City and County of Milwaukee, WI.

Prior to our tavern check I was made aware of complaints regarding the tavern. The complaints were made directly to the Alderwoman, and I was unable to gather further information regarding the complaints. The complaints stated that on Thursday and Saturdays there is "loud music and drunken neighborhood activity late at night."

I introduced my partner and me and stated to VALCARCEL the reasoning of the tavern check.

VALCARCEL stated that she has had no issues regarding previous dates and stated that tonight was R&B night. VALCARCEL stated she doesn't believe there was any patrons causing any disturbance outside of the tavern on previous dates. VALCARCEL stated that she spoke to the surrounding neighbors regarding previous events to attempt the mend issues moving forward.

I also asked VALCARCEL had working cameras, VALCARCEL stated that she has eight working cameras inside and outside of the tavern. I told VALCARCEL to notify my partner or I of any issues moving forward. VALCARCEL was cooperative throughout our interaction.

This report is written by Police Officer (P.O.) Quentin C. ARNOLD, assigned to District Two, Late Power Shift, Squad 2432 partnered with P.O Antwan POWELL. Officer POWELL and I were equipped with an AXON body worn camera, which captured this investigation.

On Thursday, February 2nd 2023 at approximately 11:45 P.M., Squad 2432 Officer POWELL and I (While in full duty Milwaukee Police Uniform with the Milwaukee Police Badge on our outer most garments, operating a marked Milwaukee Police Squad 546 equipped with operating emergency lights and audible siren) was dispatched to a noise nuisance at the tavern named Asian-Rican at the address of 3300 W. Lincoln Avenue located in the City and County of Milwaukee, WI.

Upon dispatch we were informed that the caller stated this is an ongoing issue. Upon arrival we parked in front of the address of 3232 W. Lincoln Ave which is located across the street of the tavern. When we exited our patrol vehicle, we could not hear any noise emanating from the tavern. We entered the tavern's main door at the corner of 3300 W. Lincoln Avenue and were greeted by the license holder VALCARCEL, Julie.

I explained that we had a noise complaint regarding the tavern, even though we did not hear any noise coming from the tavern. I then requested VALCARCEL to turn down the music which she complied without any hesitation. I then checked the licenses that were posted to the western wall of the tavern behind the front bar area. These licenses we posted in plain view for all customers to see.

After ensuring VALCARCEL had our information for future questions we exited the tavern and requested an incident report number.

Upon receiving our incident report number my partner Officer POWELL called the noise complaint caller. The caller stated that there is an abundant amount of noise coming from the tavern every Saturday and Sunday. When he was asked if it currently was occurring, he stated that it was. Officer POWELL asked the caller where he was located in reference to the bar and the caller stated that he lived two residents to the south of Lincoln Avenue.

I repositioned our squad vehicle in the alley way on S. 33rd Street next to the address of 2319 S. 33rd St facing eastbound. Upon parking the car, we could not hear any noise stemming from the tavern. The roadway noise from Lincoln Avenue is all we could hear. We informed the caller a report would be filed regarding. The caller stated that he would contact the alderwoman at a later date and time.

Squad 2416, Sgt. Jonathan MEJIAS-RIVERA, along with myself and PO POWELL went back in the business and spoke with VALCARCEL. Sgt. MEJIAS-RIVERA witness that there were no infractions. The only time


