## 1. Description of Grant Project/Program (Include Target Locations and Populations):

The Milwaukee Comprehensive Home Visiting Program (MCHVP) will be providing evidence-based case management/home visiting services to high-risk pregnant women, new mothers and their families who reside in a six zip code targeted area (53204, 53205, 53206, 53208, 53212 and 53233.) The purpose of this project is to provide a comprehensive home visiting curriculum that will include nationally certified training for staff (next grant year) and to provide necessary supplies needed by families for a safe and healthy environment for their children, to enhance parent-child interaction and to stimulate their children's intellectual, language, social and physical development.

## Relationship to City-wide Strategic Goals and Departmental Objectives:

This program helps to improve the health of children, reduce infant mortality and insure that all children entering school are physically, mentally and emotional capable of satisfactory education achievement.
