Vernon Mickey was arrested on 3/1/2006 for Possession of Cocaine and on two open warrants. He alleges that the arresting officer, Lewis Brown, stole \$200 from him at the time of his arrest.

After reviewing this case I have concluded that no criminal charges can be supported. Essentially, I believe officer Brown's denial that he stole the money, and I do not believe Mickey, a drug dealer whose account of the events is implausible.

For these reasons, no charges will be issued.
