There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

**Notice for applicants with warrants or unpaid fines:**

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings in City Hall is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of East Kilbourn and North Water Street. Parking tickets must be validated in the first floor information booth in City Hall.

Dear Mr. Bauman,

My name is \_\_\_\_\_, and my wife \_\_\_\_\_ and I live at \_\_\_\_\_ in Milwaukee. We would like your assistance with respect the noise generated by our next door neighbor, the Villa Filomena (1119 N Marshall Street). We moved into our home in 2013, knowing that the Villa Filomena was \_\_\_\_\_. For the first two years we did not have any serious noise issues. However, in 2015 we started to hear very loud music on many Friday and Saturday evenings. Initially we attempted to ignore the music. However, it is now routinely too loud for us to listen to our television (even with the heavy drapes closed and the washing/dryer running).

We have reached out to them personally on numerous occasions and have attempted to work with them on the subject. We have never gotten a satisfactory response. They have turned the music down for brief periods of time after we complain, only to turn it back up within 30 minutes. We have been gracious and patient, reaching out to thank them when they have a quiet evening – but this has not had a noticeable impact. They have suggested that we sound proof our condominium (at very high expense) and, more recently, have indicated that they would not take action unless we call the police.

After attempting to work with them on numerous occasions, we took their advice and turned to complaining to the police. We have worked with the local police officers, as well as the neighborhood liaison officer. According to police records, the police have received 16 noise compliant calls to that location in the last three years. This does not appear to have had any impact on the Villa Filomena's noise level.

We understand that the Villa Filomena's liquor license is up for renewal on July 25, 2018 and we would like to challenge that renewal based on a misrepresentation that they made in their previous application. Specifically, their application indicates that they do not use sound amplification (see item 4 of the Supplementary Application, attached). Not only have we experienced their use of sound amplification for at least three years now, I have personally seen the electronics in operation inside their property.

We do not take this step lightly, as we do not want to put them out of business, but when we realized that they obtained their liquor license under false pretenses, we felt a need to act. We will be filing a formal complaint against their liquor license through the normal channels. However, we also wanted to reach out to you to see if we can get your support in this matter.



In follow up to my visit to Milwaukee Foods, please accept the following.

I have visited Milwaukee Foods twice in my role as neighbor and Merrill Park Association President. On the first visit I noted a wall of coolers dedicated to beer and soda. Near the back of the store there is a "fresh" deli counter. The food was oddly packaged with deli meat stored above open vegetables and fruit. Grocery aisles were dedicated to canned goods and about 6 straight feet of ramen noodles. The other aisle was all liter sodas. Meat in the freezer was burnt and in some cases black. Pictures attached.

I wrote a letter to the owner from our notifying him of our interest in developing a park. Neighbors are concerned for loitering and litter. His son set up a time for us to meet, February 12 at 8am. Mr. Patel waited on customers while we spoke. He told me that he keeps the area free of litter and does not allow loitering. When informed of a proposed park he stated that he wanted to purchase the land and build a bigger store. I told him that MPNA was not interested in further expansion of liquor stores and would oppose his upcoming Liquor License. He insisted that he would get the license and needed the license. He asked me "How much money do you want?" I told him he was welcome to join the . He said that he would. I ended the meeting, feeling uncomfortable.



During our 10 minute meeting he waited on 5 customers. One man bought 2 six packs of beer at about 8:05am.

I am the newly elected [redacted] I am writing to you in order to introduce myself and offer to schedule a time to meet.

[redacted] a 23 year old [redacted] that works to improve the quality of life within the area bounded by [redacted]. We are neighborhood residents and homeowners who seek to improve infrastructure, housing stock and to reduce crime.

We understand that you own the Milwaukee Food Market, a grocery store that sells malt beverages. In Merrill Park at 2903 W. Clybourn Avenue. Although there is a posted "No Loitering" sign at the door, your employees do nothing to deter loitering or littering. As a result, the grocery store has negative impacts on area homes related to noise and litter. The store itself sells highly priced, unhealthy foods that are in poor condition. Much of the store sales floor is dedicated to alcohol and soda sales.

There is an upcoming proposal to create a park in the vacant lots across the street from Milwaukee Food Market. 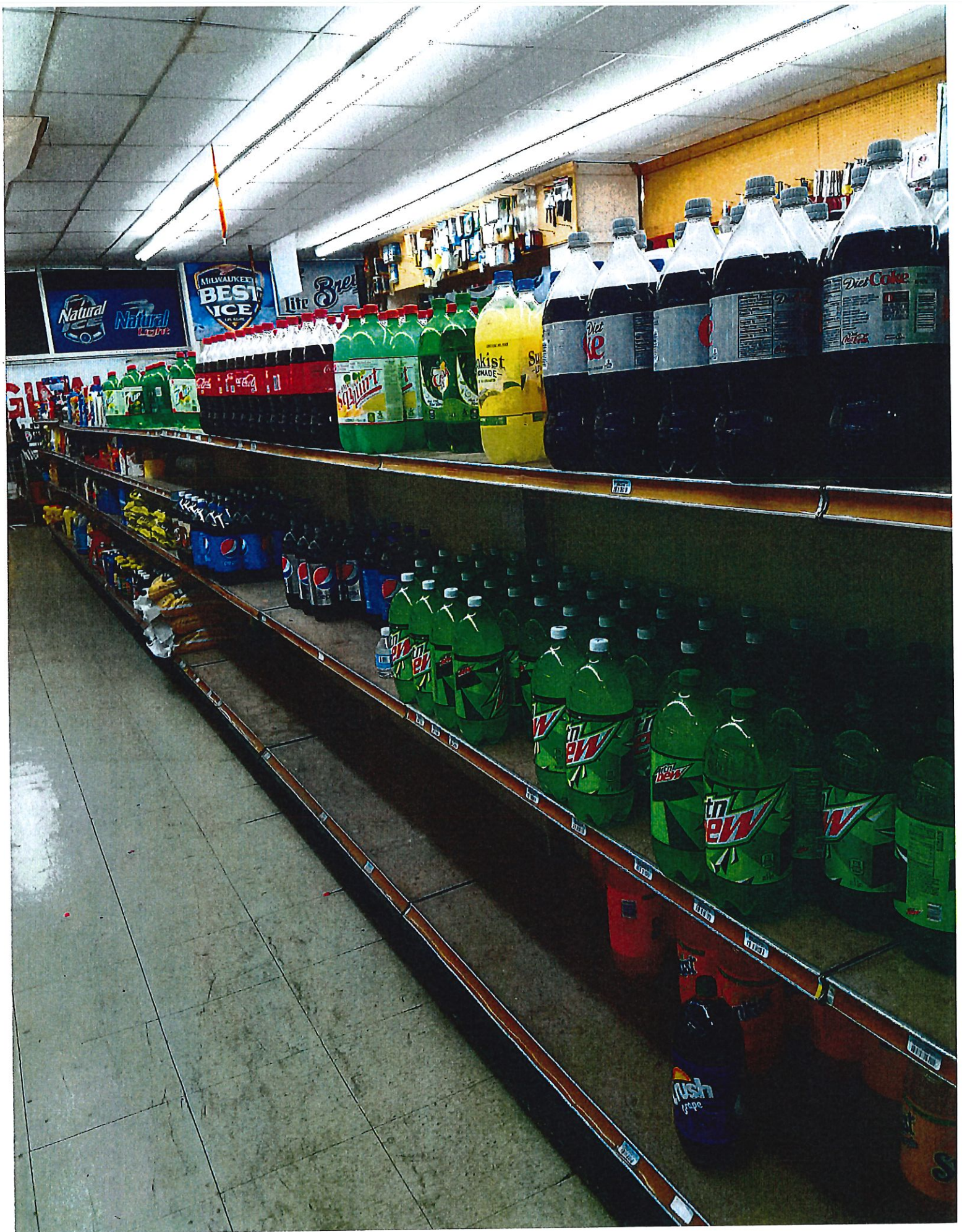

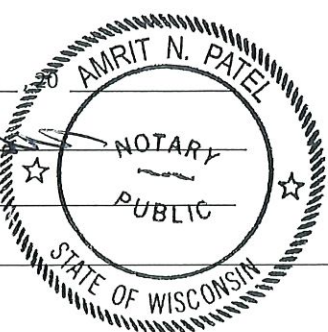
