

Dear Sir:

I am writing to request compensation from the City of Milwaukee in the amount of \$666.32 for damages not covered by our insurance to our 2003 Chrysler PT Cruiser caused when our passenger side wheels hit a large, deep, unfilled cut-out square in the street on North Avenue just west of the bridge. This accident occurred on Wednesday, June 20, 2007 about 2 p.m. My wife, Jean, was on the passenger side and I was driving. The opening was not marked in any way and was very deep, approximately 6 inches, with the dimensions of the cut-out being approximately 4 feet by 4 feet. The enclosed photograph, taken about ten days later (when gravel had been added to begin filling it in) shows the opening in greater detail. The painted indicators on this photo were not there when the accident occurred.


Initially we thought that the only damage to our car was a front flat tire, therefore we took no action against the city nor documented the scene sooner. Once we took our car to a car repair shop, we discovered that much more damage had been done and contacted our insurance company. The insurance company's auto repair shop indicated that both passenger tires had irreparable damages and that both rims had been damaged and needed replacement.

We have just returned to live in Milwaukee from the small city of Delavan, having lived here for 25 years previously. We are appalled at the bad street conditions that exist here now, ten years after we left. Delavan has much better streets than Milwaukee! We were very upset that such a large, deep hole was left with no warning to motorists. If warning signs had been placed, we, and I am sure many other motorists, would not have suffered damages to our cars.
