At a public hearing held on Monday, March 11, 2013, the Historic Preservation Commission, by a vote of five (5) ayes, zero (0) noes, and two (2) excused, denied the permanent designation of the Holy Mt. Carmel Missionary Baptist Church located at 2127 W. Garfield Avenue as a historic site in accordance with provisions of Section 320-21-9 of the Milwaukee Code of Ordinances based upon the site not fulfilling any criteria set forth in s. 320-21-3.

Section 320-21-9-j of the Milwaukee Code of Ordinances provides that the applicant or local Common Council member may appeal the Commission's decision to the Common Council by filing a written request with the City Clerk within 20 days after the mailing date of this letter. The City Clerk shall file the appeal with the Common Council for a public hearing.


