Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffit, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/04/23 at 6:58p.m., Milwaukee Police were dispatched to a Theft at 2604 W. Capitol Dr. Officers were advised the caller was no longer on scene and spoke to them via phone. The caller stated an employee stole money, however, they would report it later.

The following items are related to the Licensee and business located at 2604 W. Capitol Dr., Hook Fish & Chicken.

1. On 10/04/24, at 11:28 p.m., officers were dispatched to a Subject with Weapon complaint. The caller and a second employees were in the parking lot sitting in a car, when a male got into a disagreement with another person in the drive thru. The male produced a rifle style gun and shots were fired. Upon officers' arrival the employee who owned the vehicle was not on scene. The caller refused to give officers information regarding the second employee. An officer called a person identified by employees as the owner's son, and requested to review security video footage. That person stated they would check footage the next morning. A person identified as the owner was not available by phone. Officers were informed the exterior cameras may work, but it was unsure the interior cameras worked. Officers observed the times of operation posted did not conform with the city license website. No licenses were posted or could be found in the business.

- 2. On 01/27/25, at 1:57 p.m., officers were dispatched to a Property Damage complaint. An unknown subject was in the business causing a disturbance and throwing items around. Upon officers' arrival the subject was gone and police service was not needed.
- 3. On 05/23/25, at 4:23 a.m., officers were dispatched to a Trouble with Subject complaint. The caller reported a subject attempted to take his food. Upon officers' arrival the caller could not be located and the business was closed.

On Friday, October 4th, 2024, at approximately 11:28 PM, my partner PO Kyle LABENSKY and I, responded to the address of 2604 W. Capitol Dr., located in the City and County of Milwaukee (WI), for a Subject W/ Weapon complaint.

Scene Description:

This address is a place of business called Hook Fish and Chicken. The front of the restaurant faces south on W. Capitol Dr., and has a drive thru that wraps around the west side of the restaurant. There is a parking lot in the rear of the location. There is an access point in the front of the restaurant for customers and an access point in the rear for employees. The building is white, blue, and red, with a logo of two fish hanging from a fishing hook.

Initial Investigation:

PO LABENSKY and I entered through the front of Hook Fish and Chicken and met with a male subject, who was employed at Hook Fish and Chicken. The male subject provided PO LABENSKY with the owner's son's information, who was identified over the phone as Ali ALMAHD (W/M 08-25-02). ALMAHD stated

that he would have access to the surveillance cameras in the morning to review this incident. PO LABENSKY stated that if the incident was caught on surveillance camera, to contact him so that the video footage could be uploaded to Evidence.Com.

PO LABENSKY and I met with the caller, verbally identified as Monique A SMITH (B/F 02-22-94). SMITH stated that she is an employee at Hook Fish and Chicken and was outside in the rear, with a male employee, on her scheduled break. SMITH stated that the male employee, who remained unidentified, had his vehicle parked in the rear of the location, near the rear entrance. SMITH stated that a B/F, who was in the drive thru line, asked if it was busy inside of Hook Fish and Chicken, and that the male employee stated that he did not know since he was not inside. SMITH stated that there was another subject in the drive thru line, B/M, wearing a black shirt and a black ski-mask (Face partially covered), inside of a black vehicle. SMITH stated that the B/M was in front of the B/F and informed the B/F to shut up and get back inside of her vehicle. SMITH stated that as she was going back inside through the rear entrance, she saw the B/M pull out a large firearm, described as a black/tan rifle, and discharge the rifle one time. SMITH stated that she heard a second gunshot, but did not see the B/M discharge the second round. SMITH stated that the rear entrance was shot into twice and that it came in close proximity to her. When asked if SMITH wanted to be a victim, SMITH stated no. SMITH stated that the male employee's vehicle was shot through the front of the hood, but the male employee was not shot. SMITH stated that the male employee opened his hood to make sure that his engine was not shot, and SMITH stated that she could hear a bullet fragment fall into the hood or hit the ground. I looked at the surrounding area of where SMITH stated that the male employee's vehicle was parked, but did not observe any bullet fragments.

PO LABENSKY and I asked SMITH where this male employee was or if there was a way to get a hold of him to see if he wanted to be victim regarding this incident. As the male employee that was on scene began to give us the male employee's information, SMITH kept making gestures to not give us his information and stated that he did not wish to speak with police.

During our investigation, SMITH was very hesitant in speaking with the police and was uncooperative at times.

I was not able to make contact with the owner of this restaurant and when I attempted to contact ALMAHD to get more information, I was sent directly to an automated message stating that this person was no longer taking phone calls at this time. I asked who the owner of Hook Fish and Chicken was and all I was provided was a name of "Mohammed" (No further information).

I asked staff on scene if this restaurant was equipped with security guards and I was informed that it was not. I asked where the listed permits were in the restaurant and I was unable to locate any. There was an office inside of the restaurant, however no one had access to the office and it was unsure if there were any permits displayed inside. I did a check for the active permits online and I was able to locate a Food Dealer permit, issued on 06-21-24 and active until 07-06-25.

The hours posted on the city website stated that the hours are 10:00 AM-12:00 AM, Monday-Sunday.

I asked if the surveillance cameras work and I was informed that the exterior surveillance cameras do work, but it is unsure if the surveillance cameras inside work. As stated above, PO LABENSKY and I were not able to access the surveillance cameras at this time, and that ALMAHD would be able to review the footage in the morning.

A PV-17 form (Victims Rights) and a Community Contact Card was left at Hook Fish and Chicken for the owner.

Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
