Dear Mr. Mutza:

This office is in receipt your claim in the amount of \$345.39, relating to the weed cutting charges placed on your 2001 tax bill for your property at 4400 South 13th Street.

We are advised by the Sanitation Division that on May 18, 2001 an inspection was completed at this property, and it revealed a weed nuisance per §80-17 (Milwaukee Code of Ordinances). A weed destruction notice was issued and posted at this property. A re-inspection of the property was completed May 21, 2001. The re-inspection revealed the property was still in violation of City Ordinances governing weeds. The Sanitation Division hired a contractor to perform the weed cutting on May 24, 2001. The Sanitation Division followed appropriate procedures in this matter, therefore, the City would not be liable. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
