This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 11/27/2014 at the Days Inn at 1840 N. 6<sup>th</sup> St, four unknown actors, all armed with firearms, forced their way into the victim's hotel room by pushing past the victim after knocking. The suspects obtained property and fled the scene. The applicant was informed of this incident and was very cooperative with officer.
- 2. On 01/04/2015 at 12:21am officers responded to the Days Inn at 1840 N. 6<sup>th</sup> St for a Shooting. The investigation revealed the victim had rented a room for a party. There was alcohol and gambling at the party. During the party, unknown black male subjects, armed with guns arrived and attempted to rob the party patrons. The victim was shot through the door of the room. The officers on scene were unable to access or copy the security footage due to the applicant being out of the country and the employees not having access to the system.

3. On 03/18/17, applicant was cited for Building Code Violations at 2424 N Fratney Street.

- 4. On 11/02/17 at 6:15pm, Milwaukee Police Officers were dispatched to 1840 N. 6<sup>th</sup> Street (Days Inn) for a Strong Armed Robbery complaint. Investigation revealed that the victim was in the parking lot of the Hotel where she was battered and robbed of money and a cellular phone. Employees of the Hotel were cooperative with the investigation and assisted officers with video surveillance footage of the incident. A police report was filed (173060004).
- 5. On 11/14/17 at 1:45pm, Milwaukee Police Officers were dispatched to 1840 N. 6<sup>th</sup> Street (Days Inn) for a shots fired complaint. Employees were cooperative during the investigation and assisted officers with video surveillance footage. Officers located 13 spent casings near the vehicle. A police report was filed (173180105).
- 6. On 01/02/18 at 8:14pm, Milwaukee Police Officers were dispatched to 1840 N. 6<sup>th</sup> Street (Days Inn) for a Strong Armed Robbery complaint that occurred on 12/29/17. Investigation revealed that the victim and suspect were staying in a room at the hotel, when the suspect stuck the victim in the head with a liquor bottle and took \$1,800.00 from the victim. Employees of the Hotel were cooperative with the investigation and assisted officers with video surveillance footage of the incident. A police report was filed (180020035).
- 7. On 03/27/18 at 8:53am, Milwaukee Police Officers were dispatched to 1840 N. 6<sup>th</sup> Street (Days Inn) for a Fraud Complaint. Investigation revealed that an unknown actor paid a bill at the hotel with counterfeit money. The fraud occurred between the dates of 03/17/18 and 03/19/18 and hotel staff cooperated with the investigation.
- 8. On 04/03/18 at 12:35pm, Milwaukee Police Officers were dispatched to 1840 N. 6<sup>th</sup> Street (Days Inn) for a theft complaint. Investigation revealed that two victims were at the tavern located inside the hotel lobby when their purses were stolen by an unknown actor. Hotel staff assisted officers with the investigation. A police report was filed (180930068).
- 9. On 06/13/18, members of the Milwaukee Joint Human Trafficking Task Force, conducted surveillance at the address of 1840 N. 6<sup>th</sup> Street (Days Inn) because of various tips regarding criminal activity (drug dealing, soliciting, and trafficking). Officers were stationed for an hour and observed the following; A gentleman exit the front lobby and conduct a hand to hand exchange, females being dropped off by vehicles and enter the hotel without belongings or small bags, males and females exiting the hotel together, multiple people loitering in front of the hotel, and staff members walking around with females in skimpy clothing.

- 10. On 07/10/18 the agent of 1840 N. 6<sup>th</sup> Street (Hotel of the Arts LLC) was contacted by Milwaukee Police by telephone and told that he would be cited everyday he operated his hotel without a license. The agent was advised that officers will come to the hotel on 07/18/18 and enforce the closing of the hotel operations. The agent understood and stated that it gave him time to get his affairs in order.
- 11. On 07/10/18 at 10:00am, Milwaukee Police Officers, of the License Investigation Unit, conducted a license premise check at 1840 N. 6<sup>th</sup> Street (Days Inn) because of a complaint received about the hotel operating with an expired license. Officers observed the expired license posted and was able to interview the agent about the issue. The agent stated that he submitted an application, with payment, in April and had a completed inspection by the DNS in May; therefore, he thought his license was valid. The agent was advised to gather any evidence of payment and go to the License Division to straighten things out.

- 12. On 07/25/18 at 1:48pm, Milwaukee Police performed a license premise check at 1840 N. 6<sup>th</sup> Street (Day's Inn) because the business was operating without a valid motel/hotel license. When officers told the front door manager about the expired license, he told them that since he paid for the license, he could operate the hotel. When informed that he was wrong and that he would be fined everyday he operated, the door manager said that he has 19 people in the hotel now and 29 checking in tonight, so he will not be closing.
- 13. On 09/18/18 at 2:20pm, a meeting was held at District Five with the management of the Day's Inn (1840 N. 6<sup>th</sup> Street). Present at the meeting was the General Manager of the Day's Inn, representatives from Safe and Sound, City Attorney's Office, District Attorney's Office, Sensitive Crimes, District 5 CPU, and the Captain of the Fifth District. The General Manager stated that they have taken steps to combat crime on their property. These steps include; Security patrol in parking lot, background checks on hotel employees, entrance door is locked during the overnight hours, monitor phone numbers given by patrons on "back page", patrons must be 21 years of age and above, smoking patio only accessible from the inside, and an open door policy with the police. The following recommendations were made to the manager; conduct a CPTED survey with the District Five, Human Trafficking training for all employees, and no rooms to be rented after 10pm without a reservation. The manager was advised that they would be issued one citation for each week they are determined to have operated without a license.
- 14. On 11/30/18 at 8:53pm, Milwaukee Police conducted a license premise check at 1840 N. 6<sup>th</sup> Street (Day's Inn). The business had a valid license.
- 15. On 12/07/18 at 2:15am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street (Day's Inn) for an entry to auto complaint. One of the guests of the hotel had his vehicle entered and a report was filed.
- 16. On 12/13/18 at 11:11pm, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street (Day's Inn) for a subject with gun complaint. Upon arrival, officer's interviewed the caller/employee who stated the subject he called about had left and he did not see a gun. The area was checked and but the subject was never located.

- 17. On 12/17/18 at 9:17am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street (Day's Inn) for a subject with weapon complaint. Officer's interviewed the caller/patron of the hotel who stated that her ex-boyfriend sent her a video, holding a gun, and that she was afraid he was outside. The caller was told that there was nobody outside and she was conveyed, by police, to the Greyhound Station.
- 18. On 01/10/19 at 9:37am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street (Day's Inn) for an Armed Robbery complaint. Investigation revealed that a patron of the hotel was walking to his vehicle, in the parking lot, when his vehicle was taken at gun point. There was surveillance footage of the incident and the management was cooperative with the investigation.
- 19. On 01/20/19 at 11:13am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street (Day's Inn) for a trouble with subject complaint. Investigation revealed that a patron was in her room and refused to pay for it. The patron eventually agreed to pay for the room and no report was filed.
- 20. On 02/01/19 at 6:17am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street (Day's Inn) to meet Milwaukee Fire Department for a combative patient. Officers were able to escort medical personnel, with the patient who was intoxicated and injured his leg, to the hospital and the staff at the hotel was cooperative.
- 21. On 03/20/19 at 7:01am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street (Day's Inn) for an entry to auto complaint. One of the guests of the hotel had his vehicle entered and a report was filed.
- 22. On 05/02/19 at 11:55pm, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street (Day's Inn) for an Injured/Sick Person. Investigation revealed that security of the hotel observed a female in the lobby, unconscious, with white foam coming from her mouth. With help from other patrons, security laid the female on the ground, called 911, and the patrons started performing CPR. Milwaukee Fire Department arrived and administered 2 doses of Narcan and conveyed the female to the hospital. A check of the females' hotel room revealed a male subject sleeping on the bed, drugs, and narcotic paraphernalia inside. The male was arrested and a report was filed.
- 23. On 10/16/19, the Milwaukee Police conducted an undercover prostitution operation at 1840 N. 6<sup>th</sup> Street. The applicant was instrumental in the success of the operation. He provided the police with two hotel rooms free of charge as he has done with past operations.
- 24. On 10/17/19, the Milwaukee Police conducted an undercover prostitution operation at 1840 N. 6<sup>th</sup> Street. The applicant was instrumental in the success of the operation. He provided the police with two hotel rooms free of charge as he has done with past operations.
- 25. On 11/13/19 at 2:56pm, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street for a subject with a gun complaint. Upon arrival officers interviewed the victim/caller who stated that a subject had been beating her for the past two days and was armed with a firearm. Officers went to check for the subject, found him, and a fight ensued while taking him into

- custody. After taking him into custody the subject was found to be in possession of a firearm and drugs. The agent was cooperative with all aspects of the investigation.
- 26. On 11/22/19 at 4:44am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street for check the welfare of a citizen complaint. Investigation revealed that two juveniles, who ran away from a group home, were sexually assaulted and being trafficked. The suspects were arrested and the staff of the hotel helped with the investigation.
- 27. On 03/05/20 at 4:04am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street for a battery complaint. Investigation revealed that a domestic violence battery occurred in one of the rooms at the hotel and the suspect was arrested.
- 28. On 03/26/20 at 7:35pm, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street for an overdose complaint. Investigation revealed that a subject was doing prescription drugs with another subject, inside her hotel room, when she overdosed. The police and firefighters administered NARCAN, she became conscious, and she was sent to the hospital.

29. On 01/28/22 at 1:25am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street for an armed robbery compliant. Investigation revealed that two subjects knocked on the guests door and when he answered, they assaulted him and took U.S. Currency.

- 30. On 02/15/23 at 5:00p.m., Milwaukee Police were dispatched to an Entry to Auto at 1840 N. 6<sup>th</sup> St. Investigation revealed a guest parked their vehicle in the parking lot and unknown subject(s) had broken into it, stealing tools valued at \$3000. The employee was cooperative and allowed officers to view video surveillance, however, the incident was not captured. The officer did observe multiple cameras in the parking lot, however, they appeared to be not in working order, which would have been crucial to capturing the incident.
- 31. On 03/21/23 at 8:06pm, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> St , for an overdose complaint. Officers met MFD at the location in a hotel room, where Narcan had to be delivered to the subject. The subject stated that he did not try to harm himself he just took some anxiety pills to relive pain. The subject was transferred to the hospital where he did admit to taking narcotics to the hospital staff.
- 32. On 03/21/23 at 9:40p.m., Milwaukee Police were dispatched to a Threat at 1840 N. 6<sup>th</sup> St. Investigation revealed a guest wanted to cancel reservation and became upset over the refund process. The guest threatened to come back with a gun, the fled the scene. The employees were cooperative with the investigation.
- 33. On 04/04/23 at 1:55pm, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> St , for a fight complaint. Police arrived and spoke to the victim who was slammed by the suspect against the ATM machine. Officers issued a citation and provided a ride to the victim, away from the location.

- 34. On 05/01/23 at 8:33am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> St , for a battery complaint. Investigation determine a battery did not occur. The caller was given information regarding a restraining order, and retrieved property from the room. The caller then left the location.
- 35.On 05/06/23 at 8:22am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> St , for a theft complaint. Officers spoke with the caller who stated that an acquaintance that was in her room intentionally took her property without her consent. Officers reviewed the video and observed the suspect running from the hotel room down the hallway and the victim giving chase. Officers on scene did not observed the business licenses.
- 36. On 05/10/23 at 3:40a.m., Milwaukee Police were dispatched to a Fight at 1840 N. 6<sup>th</sup> St. Investigation revealed a guest and another subject were physically fighting outside of the location. Both parties were gone on police arrival. The employee was cooperative with the investigation.
- 37.On 07/05/23 at 1:24pm Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> St , for a child abuse complaint. Officers spoke with the manager who stated that she believes the child in room 217 was abused by her mother. The manager stated that she heard yelling coming from the room and she checked on the room. The child answered and appeared to be cold. Officers respond to the room but the renter was not on scene. The hotel staff was cooperative with the investigation providing officers with the renter's information.

This report is written by PO Greg GREGORY assigned to District Five, Late Shift.

On Thursday, February 16th, 2023, I was assigned to Squad 5340. I was operating a marked black and white MPD Squad Car (Car #586), which was equipped with an AXON in car camera system but was not activated during this investigation. My partner, P.O. Robert ROEMBKE (driver) and I (passenger) were in full MPD uniforms with badges and nameplates affixed to our outermost garments. P.O. ROEMBKE and I were equipped with body worn cameras which were activated during portions of this investigation. I was dispatched to 1840 N 6th St, located in the City and County of Milwaukee, Wisconsin regarding an Entry to Auto complaint.

Upon arrival we interviewed the victim of the Entry to Auto complaint and determined that the incident was a Felony Theft from Motor Vehicle due to the amount stolen from the vehicle was approximately \$3000.00 in tools from the parking lot of Days Inn and Suites. The incident was filed under Milwaukee Police Incident # 23-047-0023. I made contact with the Front Desk Security identified as Braden M. FELSKE-SHISLER who was cooperative with attempting to locate video footage but was unable to retrieve any at the current time of investigation.

There are multiple camera's observed at Days Inn and Suites located at 1840 N 6th St in the City and County of Milwaukee, Wisconsin. Most of the camera's that are in working order are attached to the building facing outward into the parking lot and are in color. There are cameras observed on the light poles in the center of the lot but appear to NOT be in working order, which is crucial in capturing the multiple incidents that could be of evidentiary value.

On Tuesday, March 21, 2023, at 8:06 PM, Squad 5463 (P.O. Stephen ARNOLD and I) was dispatched to an Overdose complaint at the Days Inn Hotel, at 1840 N. 6th St. #406 which is located in the City and County of Milwaukee. P.O. ARNOLD and I were both wearing full Milwaukee Police Department issued uniform, driving a marked Milwaukee Police Department Squad car (535) and wearing Axon body worn cameras that recorded our investigation.

Upon arrival, we were briefed by the following MFD units.

Engine 2, Blue shift.

Med 6, Blue Shift.

Acting LT. VOLTER

MFD advised us they were on scene and had forced entry to hotel room #406 in attempt to help an unresponsive subject. The subject was identified as Saman HAGHPARAST-RAD (W/M 1/6/1990). I spoke with HAGHPARAST-RAD's sister who stated she had not heard from Saman in about 24 hours and knew he was at the hotel. She stated Saman suffers from depression and has a history of drug use.

MFD advised us they had administered 2mg of Narcan to Saman. I spoke with Saman who was still very delirious. Saman stated to me that he had taken about 10 of his anxiety meds in order to make himself feel better. Saman stated that he was not attempting to kill himself he was just trying to ease his physical pain. Saman denied taking any other form of drug.

Bell 412 responded and conveyed Saman to Mt. Sinai Hospital for further treatment. Saman was admitted at 9:22 PM in room 16. Bell advised us on scene that when they got Saman into the ambulance he again lost consciousness, so they administered 2 more mg of Narcan.

While speaking with the nurses, Saman did admit to shooting heroin earlier in the day and stated he believed it was fentanyl.
