There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Subject: 3033 & 2624 W Lisbon AV extended hrs renewals

My wife and I

down the street at 34th and Lisbon and live very nearby.

We oppose a renewal of extended hours At BOTH 2624 and 3033 W Lisbon Ave for multiple reasons.

1- we've lived in years and operated a business for over Longer than any of the current 24/7 operations. The times we have had most problems have coincided with out-of-control illegal street life, which coincides with 24/7 operations in our neighborhood. During years that area businesses operate within the guidelines of non-24/7 "good neighbor agreements" our neighborhood is at its best. The last time this occurred was in the mid teens (2016+/-). The long slide coincides with variances permitting 24/7 operation, erratic security and poor business practices.

2-Over the years of operation, no matter who owns and manages the 24/7 businesses, they ultimately cater to a culture of 24/7 street-based night life that is very disruptive to our community. I used to get gas at 3033. No more. We don't have a 3-shift workforce that needs gas, chips and soda pop 24/7.

3-Many of our customers comment on activities seen around BOTH 3033 W Lisbon and also 2624 W Lisbon AV. The overnight traffic that supports illegal drug dealing and human trafficking is frequently a closed loop between 27th and 35th St, resulting in high rates of criminal activity and chaotic traffic as well as tremendous quantities of trash. I frequently drive east, departing and returning early mornings. Rarely do I see cars pumping gas though the pumps are tied up with cars with trunks and doors open and frequently girls hustling near sidewalks. This is the business they permit to occur on and near their properties.


When allowed to persist, the streets become unwalkable due to pimps, John's and prostitution/drug-muling, leaving it uncomfortable and unsafe to walk to school or even wait for a bus. My tenants prefer the take their car to the community garden a block away so as not to be harassed by cars trolling neighborhood. My employees who must walk past these businesses to get a bus are harassed daily.

A customer recently noted, "it's no surprise that Lisbon and Greenfield Ave have similar problems". 24/7 operations have a direct link to high vacancies, high transitory rental and higher rates of percapita criminal activity. Perhaps this isn't a new phenomenon to Lisbon, as many point to x-rated Parkway Theatre (owned by 2 brothers from Racine) as the turning point in the 70s but the point remains that such disruptions import more problems.

4-It is not the responsibility of MPD to solve this problem alone. It is the responsibility of businesses to conduct themselves in a fashion that does not disrupt family's peaceful enjoyment of their residence; rental or otherwise. For the sake of our business and community, please deny extended hours renewals to BOTH 3033 and 2624 W. Lisbon.

Dear License Division Committee:

I wish to express my opposition to granting extended hours for both service stations/convenience stores located at 2624 and 3033 W. Lisbon Ave.

(just south of Lisbon Avenue) since 1988, thus the last 36 years. To live here is to accept the daily reality of sex work, drug dealing, and never-ending trash in our streets. Lisbon Avenue (and the surrounding residential streets) is a trash filled, sex work and street drug market from N 27th to N 35th Street and is visible for everyone to see. During my time here I have eagerly embraced multiple efforts to combat those challenges, but over time I have lost hope of impacting the 24/7 sex work or drug dealing.

I do, however, pick up the trash on the street, boulevards and vacant lots along Lisbon Avenue from just east of 27th St. to 36th St. starting at about 6:00 a.m. every Saturday and Sunday morning, weather permitting. I long ago learned that if I want something done, and I can do it, I just need to do it myself, and litter I can handle. The litter generated by these businesses is never ending, and from what I observe, there is little effort by the business owners to do anything about it. During these mornings on the street, the foot and vehicular traffic from the sex workers and drug dealers is constant. Avoiding violence (directed at others, not me, usually) is a part of my regular routine.

I also drive by each of these locations at 5:45 a.m. every weekday heading east, and the foot and vehicle traffic is constant, and it appears to be about much more than purchasing gas.

Reaearch has shown that sex work can only thrive where the sex workers have access to convenience stores. The stretch from 2624 W Lisbon to 3033 W Lisbon with their extended hours, along with the liquor store at 29th Street (opens at 8:00 a.m., closes at 9:00 p.m.) creates the perfect ecosystem for sex work and the street drug market to thrive 24/7.

Denying extended hours will not solve the problem, but it is one tool the city can use, and that those of us who live this life daily can hope will lessen the problem.

I am writing to voice my concerns about 3033 W LISBON AV a RENEWAL Extended Hours Establishments license was applied for on 10/16/2024 for LISBON GAS & FOOD, WISCONSIN BENIPAL, LLC. It would be fair to say that I am in opposition of extending the operation hours of this gas station. I live and work in this neighborhood and I have never felt safe using this location. I have personally witnessed open air drug exchanges, firearms with large clips being brandished in public, and sex trafficking pickups at this location day and night.

When was the last time an inspection was conducted at Lisbon Gas & Food? I would like to see more safety / security put in place, the discouraging and prevention of trafficking on the premises, and kept clean on and around the lot of the business. I think it is ridiculous to provide an extension of hours before addressing the current issues. The loitering that occurs there all revolves around feeding the drug and trafficking occurring on Lisbon Ave and it is simply unacceptable.

5. On 08/21/13 officers investigated a Stabbing that occurred at 1:15am in the parking lot of Lisbon Gas and Food at 3033 W. Lisbon Ave. Officers spoke to the on duty security guard regarding the incident. The security guard stated the stabbing did occur at this location. He further stated he already cleaned up the blood and no one called the police because the victim drove away.

The officer spoke to the on duty clerk who stated he did observe an altercation inside of the location, but once the subjects left the store he didn't see or hear anything else until his security told him what happened outside. The clerk stated he told the security guard to clean up the blood.

A detective did view the surveillance video, which captured the incident. An altercation began inside the store and spilled outside where the stabbing occurred. The detective also spoke with the security guard who stated he did observed the stabbing.

- 7. On 10/18/17 a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a property damage complaint. Officer's interviewed an employee who said that the employee on another shift called in the complaint and that employee stated that a black male and black female entered the parking lot of the establishment in a white four door sedan. The female entered the store and attempted to take an item without paying. The employee locked the front door of the establishment so the female was unable to leave the store with the merchandise. The black male then rammed the front door of the establishment with his vehicle causing the door frame to bend and allow the female to escape. The employee was unable to retrieve a registration plate number and could not operate the surveillance system. No suspects were taken into custody and an Incident Report was filed (172910170).
- 8. On 01/13/18 at 12:53am, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandler). Upon Squad's arrival, the subject left the location and no incident report was filed.
- 9. On 01/21/18 at 12:42am, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandler) Upon Squad's arrival, the subject left the location and no incident report was filed.
- 10. On 01/31/18 at 2:00pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandler). Upon Squad's arrival, they interviewed the employee/caller who said that a black female entered the store begging for money. The subject left the location before squad arrival and no incident report was filed.
- 11. On 02/16/18 at 10:03pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandlers) complaint. Upon Squad's arrival, the subject left the location and no incident report was filed.
- 12. On 03/04/18 at 5:37pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject complaint. Upon Squad's arrival, the officer's interviewed the employee/caller who stated that a black male was loitering on the property, doing drugs, and refusing to leave. The subject left the location before squad arrival and no incident report was filed.
- 13. On 03/06/18 at 5:15pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for an injured/sick person call. Upon Squad's arrival, the officer's found a subject, outside the establishment trembling and shaking. The subject was unable to comprehend the officer's questions, so one of the officers entered the establishment and talked with the clerk who said he has observed the subject before and has seen his body shake in the past. While one officer was talking with the store employee the subject told the other officer that he was feeling suicidal and wanted to go to a Milwaukee County Mental Health Facility. Officer's conveyed the subject to the facility but while waiting to enter, the subject's health worsened and one of the officers called for medical attention. Wauwatosa Fire Department arrived on scene and conveyed the subject to Froedtert Hospital.

15. On 07/27/19 officers were flagged down by citizens regarding a fight complaint outside the location of 3033 W. Lisbon Av. Officers stopped the juveniles who were then transported to their homes.

16. On 12/07/19 at 2:44am, Milwaukee Police were dispatched to 3033 W. Lisbon Avenue for a theft complaint. Investigation revealed that a subject entered the store and took product without paying for them. Officers were given a description, checked the area, and found the subject still in possession of the product. The subject was issued a citation and the product was returned.

- 17. On 06/13/20 at 5:21am, Milwaukee Police were dispatched to 3303 W. Lisbon Avenue for a ShotSpotter complaint. Investigation revealed that a group of about 15 people were in the lot when there was an argument between two of them. One of the persons had a handgun and was sitting in his vehicle when he fired one shot at the person he was arguing with. Everyone fled the scene and on casing and one fired bullet was recovered. The employee was able to provide video surveillance.
- 18. On 07/01/20 at 12:53am, Milwaukee Police conducted a license premise check at 3033 W. Lisbon Avenue. When officers entered the lot, they observed large numbers of vehicles and groups of people "hanging out". While officers were walking up the group entered their vehicles and left the premise. Officers interviewed the employee who stated that this is an ongoing problem with people in the lot and building. Officers left the premise to assist another officer just north of the location and when they returned, there was another large group of people and vehicles gathered inside the lot. Officers then entered the lot with their squad vehicles and, again, the vehicles and people left. The employee said this is an ongoing problem but he never calls police.
- 19. On 07/03/20 at 12:27am, Milwaukee Police conducted two license premise checks at 3033 W. Lisbon Avenue. The reason for the checks was because of the large amount of vehicles/people in the lot loitering throughout the nights. The first check lasted about twenty minutes and there were no problems observed or reported. During the second premise check there was a firework lit off in the parking lot and about 18 vehicles with 15 people loitering on the premise. The filling station employees have been advised numerous times to call the police when there are people loitering on the property but there were no calls for service from that location.
- 20. On 07/04/20 at 3:22am, Milwaukee Police, while on patrol, observed the filling station located at 3033 W. Lisbon Avenue had no lights on and about 20-25 vehicles in the lot with about 20 people loitering. Officers entered the lot and parked causing the vehicles/ loiterers to leave and the lights to the establishment came back on. There were no calls from the establishment for people and vehicles loitering.

21. On 09/25/20 at 2:41am, Milwaukee Police were dispatched to 3033 W. Lisbon Avenue for a Shot Spotter complaint. Investigation revealed that a subject was standing next to pump number 5 pulled out a firearm and fired shots toward a black sedan located next to pump number 8.

- 22. On 09/29/2020 at 11:38am officers were dispatched to a Reckless Use of Weapon at 3033 W. Lisbon Av. The officer interviewed the clerk, who stated a subject came into the store and pointed a firearm at him. The subject did not steal anything. The clerk was cooperative and showed the officers video of the incident.
- 23. On 10/31/2020 at 12:16am officers were dispatched to a Theft at 3033 W. Lisbon Av. The officers could not locate the caller, who was attempting to report his bicycle stolen from the lot.
- 24. On 11/11/2020 at 12:17am officers were dispatched to a Shotspotter at 3033 W. Lisbon Av. The officers interviewed the clerk, who spoke limited English. The clerk pointed to the north when the officer asked about shots fired. A customer stated she did not see shots fired on the property but heard some from across the street. There were no cameras that could have captured the incident.
- 25. On 11/15/2020 at 9:51am officers were dispatched to a Robbery complaint at 3033 W. Lisbon Av. The officers interviewed the victim, who stated she was handing money to the cashier when a subject came up behind her and grabbed the money from her hand. The suspect grabbed her hair and pushed her to the ground. The officers interviewed the clerk, who was cooperative. The clerk provided officers with video of the incident and stated he recognizes the suspect because she frequents the area.
- 26. On 11/15/2020 at 6:05pm officers were dispatched to a Subject wanted at 3033 W. Lisbon Av. The officers did not locate the described suspect and could not contact the caller. No contact was made with the business.
- 27. On 11/16/2020 at 12:33am officers were dispatched to a Trouble with Subject at 3033 W. Lisbon Av. The officers interviewed the clerk, who stated there was a group of females that had been on scene panhandling and about to fight. The group left prior to the arrival of police. An unrelated subject on the scene was provided medical attention.
- 28. On 11/17/2020 at 6:29pm officers were dispatched to a Trouble with Subject at Express Pantry, 3033 W. Lisbon Av. When the officers arrived an employee exited the store and stated the call was made in error and no police service was required.
- 29. On 11/18/2020 at 8:03am officers were dispatched to an Injured Person call at 3033 W. Lisbon Av. The call was for a subject on the floor in the bathroom. When the officer arrived they located a female outside the main entrance in a wheelchair. The female stated she was waiting for a ride to take her home.
- 30. On 11/28/2021 at 12:13am officers were dispatched to a Robbery at 3033 W. Lisbon Av. The officers interviewed the victim, who stated he was at the station when someone attempted to take his keys and vehicle. The business did not have anyone to operate the video system but did provide it at a later time. The business was cooperative with the investigation.
- 31. On 01/10/2021 at 10:04pm officers were dispatched to a Trouble with Subject at Express Gas, 3033 W. Lisbon Av. The caller stated there were 20 cars parked in the lot for 20 minutes. When

- the officers arrived they observed 12 cars on the lot. The officers parked on the lot to monitor the area. The autos left within a few minutes and the officers cleared the area.
- 32.On 01/26/2021 at 1:17pm officers were flagged down for a parking trouble. The clerk stated there was a car has been blocking the pumps for 30 minutes and the drivers refused to leave when asked. The officers spoke with the driver and he left the area.
- 33. On 03/06/2021 at 2:44am officers were dispatched to a Shot Spotter call at 3033 W. Lisbon Av. The officers located four casings in the front of the gas station property. The officers spoke with the clerk, who stated he observed a subject shooting from the corner of N. 30th St. and W. Lisbon Av. The officers watched surveillance video, which showed two subjects in an argument. As one of the subjects was leaving, the other subject ducked behind a car and fired shots at the first subject. Both subjects then fled the scene.
- 34. On 03/07/2021 at 4:04am officers were dispatched to a Shot Spotter call at 3033 W. Lisbon Av. The officers checked the area and did not locate any casings on the ground. The officers interviewed the gas station clerk, who showed officers video of the incident. The video showed a car parked at the pumps and another man firing shots at the auto. The auto flees eastbound on W. Lisbon Av. and the suspect continues to fire at the car.
- 35. On 05/11/2021 at 7:03pm officers were dispatched to a Fraud complaint at Lisbon Gas 7 Food, 3033 W. Lisbon Av. The officer interviewed the clerk, who stated on 05/10/2021 a subject came into the store and demanded \$40 or he would break the stores credit card machine. When the clerk refused the subject broke the machine and again demanded money or he would break the other machine. The clerk then gave the subject the money. On 05/11/2021 the subject returned and demanded \$60. The clerk gave the money to avoid further damage. The officer spoke with the applicant and he stated he would like to prosecute. The applicant was not present for the incidents but did view them on surveillance video.
- 36. On 06/19/2021 at 3:20am officers were dispatched to a Shooting at Express Gas, 3033 W. Lisbon Av. The investigation revealed a shooting did occur inside the business and was the result of a theft of firearm. The employees were cooperative and closed the business during the investigation.
- 37. On 08/07/2021 officers were dispatched to a Robbery at 3033 W. Lisbon Av. The officers interviewed the caller, who stated he was at the gas station when an unknown actor grabbed him from behind. They fell to the ground and the suspect took money from the caller's pocket. The officers watched the video, which did not match what the caller said happened. The video showed the caller being on the lot for 20 minutes, interacting with the suspect. The officers confronted the caller about the video and he then stated the suspect was continuously asking for money.
- 38. On 08/09/2021 at 5:51am officers were dispatched to a Shooting at 3033 W. Lisbon Av. The officers were advised that the victim was transported the St. Joseph's Hospital. The officers interviewed the victim, who stated she was at the gas station at 3033 W. Lisbon Av. when she was shot in the abdomen by an unknown actor. Officers went to the scene and located 2 casings at 3231 W. Lisbon Av. at the location pinpointed by Shot Spotter.
- 39. On 09/22/2021 at 9:08pm officers were dispatched to a Shot Spotter call at 3033 W. Lisbon Av. The investigation revealed a shooting occurred at the gas station by the air pump. The clerk was cooperative and provided video of the incident. The video showed the victim was the air pump

and appeared to argue with a subject in a car. The car drove of but returned and the driver shot the victim to the chest. The victim was taken to the hospital by a witness, where he was pronounced dead.

40. On 10/14/2021 at 11:30am a meeting was held at District 3 regarding Lisbon Gas and Food, 3033 W. Lisbon Av. The applicant was present, along Guilty with the property owner and an attorney. The applicant stated he has no loitering signs posted, adequate lighting, and security cameras. The applicant stated one of the shootings was his armed security guard but he no longer has armed security at the location. He stated he has been turning off the interior building lights and locking the doors to the store between 2:00am and 5:00am to help prevent recent problems. It was suggested the applicant attend neighborhood meetings to become involved with the surrounding community. The applicant was advised to call the police to report loitering and other problems in the area to help prevent further incidents.

- 41. On 02/06/2022 at 8:01am officers were dispatched to a Battery at 3135 W. Lisbon Av. The officers located the victim in the gas station at 3033 W. Lisbon Av. The battery occurred at the victim's residence and was not related to the business.
- 42. On 06/13/2022 at 4:35am officers conducted a license premise check at Lisbon Gas and Food Mart, 3033 W. Lisbon Av. The clerk was cooperative and no violations were observed.

- 43. On 11/12/22 at 8:35p.m., Milwaukee Police were dispatched to a Subject with Weapon at 3033 W. Lisbon Av. Investigation revealed the employee that called or the subjects were no longer on scene. The officers spoke to the employee that called for police via phone who stated subjects were holding the door open to the business and telling people to take whatever they wanted, because it was free and banging on the security door.
- 44. On 02/13/203 at 6:36a.m., Milwaukee Police were dispatched to a Spot-Shotter at 3033 W Lisbon Av. Upon checking the area, the officers located one 40caliber casing near a gas pump. The clerk stated they were in the back room, when they heard approximately 5 gunshots from outside by the pumps. Video surveillance showed a vehicle enter the lot and a suspect, who appeared to be waiting for the victim, produce a firearm and fire several shots, shooting out the rear window to the vehicle. Both the victim and the suspect flee the gas station. The employee was very cooperative allowing officers to view the video, which assisted in the investigation.
- 46. On 07/25/23 at 4:24p.m., Milwaukee Police were dispatched to an Armed Robbery the victim stated occurred at 3033 W. Lisbon Av. The victim stated they were on a drug "bender" and was in the gas station parking lot on 07/23/23 at approximately 11:40a.m., when a drug dealer they owed money to pulled up. The victim's passenger grabbed the keys out of the ignition and provided them to the drug dealer, and several subjects began to punch the victim multiple times, until the victim got out of the vehicle and fled on foot. The victim stated they didn't call the police for a few days, because they checked into rehab to get sober first. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

- 47. On 01/14/2024 at 8:07 AM., Milwaukee Police were dispatched to an Armed Robbery at 3033 W. Lisbon Ave., Citgo Gas. The victim an Uber driver just dropped off a client at the business and realized he needed gas. As he began to fuel up his vehicle a masked suspected approached him displaying a handgun. The suspect demanded the victim's keys. The first suspect entered the driver's side of the vehicle while a second masked suspect entered on the passenger side. A third suspect who appeared from the business entered the rear passenger side of the vehicle before all three fled in the victim's vehicle. Officers collected evidence from inside of the business where the suspects were seen.
- 48. On 01/26/2024 at 3:42 AM., Milwaukee Police were dispatched to an Armed Robbery-Carjacking at 3033 W. Lisbon Ave., Citgo Gas. The victim is approached by an armed masked suspect, who orders the victim out of his car. The victim walked into the business and told an employee to lock the door. The masked suspect and a second masked suspect were unable to get the victim's vehicle to move. Both masked suspects exit the victim's vehicle and enter a dark color vehicle, which was waiting in the lot with a third suspect in it. All three suspect flee the area before police arrival. The employee stated they did not witness the incident. Security footage was obtained from the business.
- 49. On 06/01/2024 at 10:50 AM., Milwaukee Police were dispatched to Sick and Injured call at 3033 W. Lisbon Ave., Citgo Gas. Upon officers arrival Milwaukee Fire Department personnel were rendering aid on two separate individual whom had collapsed in the Citgo parking lot. One of the individual became responsive and refused any additional help from MFD and walked away. The second subject was transported to a hospital where they refused medical attention. Both subjects refused to provide officers with any information. This incident was suspected to be a drug related. The business agent stated both subjects are known chronic panhandlers. The female was transported to a hospital. Officer s did not find any connection with the female and business. The Citgo employee working was cooperative with officers and provided access to exterior security footage.

a known subject that was at the property and had previously been served with a no contact order, issued by Milwaukee County Courts. Security video obtained confirmed the subject was in the business but not on scene upon officer's arrival. No license violations were observed.

On Sunday, January 14th, 2024, at 8:14am I, Squad 3121 (along with Police Officer Jacob Baczek) responded to an Armed Robbery at the Citgo Gas Station located at 3033 W Lisbon Ave, which was located within the City and County of Milwaukee.

Scene Description:

Upon arrival I was met by the caller and victim in this case, Cung N. BIK, A/M, 12-21-94. I obtained an initial statement from BIK and Police Officer Baczek provided a broadcast and typed out an Incident Notification.

"On Sunday, January 14th, 2024, at 8:07 a.m., the victim, Cung N. BIK (a/m 12-21-94) was operating as an Uber driver in his 2021 Chevy Suburban, Wisconsin Registration plate#AVJ-3600, last six of vin#362627. BIK dropped off a customer at 3033 West Lisbon Avenue (Citgo) at 8:07 a.m. BIK is observed on video sitting in his car for several minutes and begins to leave the gas station. BIK stated that he realized he was low on fuel, and conducted a "U" turn in the parking lot to go to PUMP 3 and get fuel. After exiting his vehicle and beginning to remove his wallet, BIK was approached by suspect 1, B/M, ski mask, wearing a blue, white, black jacket, displaying a black handgun in his left hand, demanding his keys. Suspect 1 was accompanied by suspect 2, a B/M, ski mask, black jacket, hood up and blue jeans. Suspect 1 obtained the keys and entered the driver's side of the vehicle, while suspect 2 entered the passenger side of the vehicle. Suspect 3 appeared from the gas station and entered the rear passenger side of the vehicle. The vehicle was then observed fleeing the scene eastbound on West Lisbon Avenue. The victim's cell phone, was left inside of the vehicle. A black IPHONE 13, phone#515-979-7929. BIK stated that he does not have a tracking option on his vehicle. He was unaware how to track his phone."

I secured the scene and viewed the video surveillance of the incident.

After viewing the video surveillance, I showed the Forensic Investigator Squad 1722 (Police Officer Jeremy Jurvelin) where the three suspects had placed their hands on some glass and countertops inside of the gas station.

Squad 9175 (Detective Shipman) responded and advised me to write up a supp on the initial scene.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the Armed Robbery, I did not observe any violations in the licensed premise.

and equipped with an Axon Body Worn Camera, responded to a armed robbery carjacking complaint that occurred at the Lisbon Gas and Food located at 3033 W Lisbon AV, which is located in the City and County of Milwaukee.

Per the CAD (computer aided dispatch)

Entered at 3:42 AM.

3:44 AM - Someone took callers vehicle, caller stated that this just happened and the subjects had a gun/ Nissan Rogue Silver

-This was a rental vehicle.

3:47 AM - caller stated that he was at the gas station parked at the pump and a male walked up to the vehicle and said something like get out and the caller put his hands up and exited the vehicle/ there was another vehicle- caller thinks it was black, did not see what direction the vehicle went/cameras at gas station

- -Victim vehicle Silver Nissan Rogue
- -Suspect 1- b/m w/ a gun.

Due to the CAD stating the vehicle was taken, Squad 3369, PO Tyler HENEY and PO Lauren MAROWSKY assisted me in saturating for the vehicle.

Upon arrival, I observed the vehicle, which was a Silver Nissan Rogue (Florida Plates BWGW77) parked unoccupied at the southeastern gas pump of the gas station facing east. I then observed the caller of the carjacking exiting the gas station, later identified as Dana L BROWN (b/m 06-10-1997, Ph # 414-388-2950).

BROWN stated that he stopped by the Citgo gas Station at 3033 W Lisbon Av to grab himself a Gatorade and gas. BROWN stated that he does not remember what time he arrived by assumed that it was closer to 3:00 AM because he dosed off.

BROWN stated that he observed a black sedan pull up next to his vehicle and a passenger of the sedan exited and approached him. BROWN stated that the subject opened his driver door and ordered him to exit the car. BROWN stated that the subject was armed with a black handgun and was holding it down by his right side. BROWN stated that he immediately put his hands up and exited his vehicle. BROWN stated that he then slowly walked away from his vehicle to enter the gas station. While doing this, BROWN observed the subject engaged in a conversation with the front passenger of the black sedan, which he only described as a black male. BROWN stated that he entered the gas station and told the gas station clerk to lock the door. BROWN described the subject who ordered him out of his vehicle as a black male, approximately 19 years old, wearing a dark hooded sweatshirt with the hood up, armed with a black handgun. BROWN stated that this was when he called for police services. BROWN believed that the suspects drove away in his vehicle, but they did not.

There were no witnesses on scene. I did speak with the Gas station clerk at the time, who stated that he did not observe a carjacking take place in the parking lot. I then asked if I could view video footage from the gas station, to which he guided me to where the footage monitor was and

gave me the password to access the footage.

Video Footage

I viewed surveillance footage at the Citgo Gas Station. I observed that BROWN is inside his vehicle parked in front of pump 4 facing east. I observed that his vehicle is still on as smoke was still emitting from the vehicle's exhaust. At approximately 3:37 AM, I observed a dark blue or black Infiniti sedan (possibly a Q50) with dark window tint and dark alloy rims enter the Citgo gas Station from the northwest entrance and park in front of Pump #7 facing east. The sedan is parked at this location for approximately 3 minutes. At approximately 3:40 AM, the sedan drives up to park #5 which is directly across from BROWN's vehicle.

I observed that suspect 1, who I observed as a black male 19 years old, 5'8", thin build, wearing a black hooded sweater with the hood up and white design on chest area, black jeans, black and yellow shoes exit the sedan from the rear driver passenger seat and approaches BROWN who is seated in the driver seat of his vehicle. It appears that Suspect 1 is conversing with suspect 2 who is seated in the front passenger seat of the sedan. I observed that the front passenger window of the sedan is rolled down. Shortly afterwards, I observed suspect 1 open BROWN's door and BROWN exits the vehicle with his hands up facing towards the dark colored sedan. In the footage, I can observe suspect 1 waving an object behind BROWN. BROWN then steps to the rear of the dark colored sedan and walks towards the gas station entrance door.

At this point, I observed suspect 1 enter BROWN's vehicle in the driver seat. I observed that the rear brakes of BROWN's vehicle do illuminate, indicating that the brakes of the vehicle are being pressed, which is an indicator that the suspect is attempting to put the vehicle into gear.

I then observed that suspect 1 exits the driver seat of BROWN's vehicle and swaps seats with suspect 2 who is in the front passenger seat of the dark colored sedan. Suspect 2 is unable to get the vehicle into gear as well. Suspect 2 is then observed exiting the driver seat of BROWN's vehicle and enters the rear passenger seat of the dark colored sedan. The sedan then exits the gas station using the eastern entrance of the lot and flees eastbound on W Lisbon Av.

When suspect 2 re-entered the dark colored sedan, I observed him to be a black male, 20's, approximately 5'08", thin build, with long dreads, wearing a blue windbreaker with white shoulder patches, khaki pants, and white shoes.

While on scene, I observed the licenses posted and they were up to date. I did not observe any violations while on scene of this licensed premise. It should also be noted that the gas station clerk was cooperative with this investigation.

Upon our arrival we observed Milwaukee Fire Department working on two separate individuals. One subject got up, refused any further medical attention and walked off refusing to speak to my partner and me.

Milwaukee Fire Department continued to work on another individual who would consent to medical attention. However, this subject would refuse to provide a valid name and identify himself. This subject would also continue to refuse any cooperation with the nurses at Mt. Sinai.

Upon arrival we met with a worker of the gas station who did not speak English so he pulled his phone out and called a subject verbally identified as Benipal SIMRANJEETS (W/M 12-28-1979). SIMRANJEETS is the owner of Lisbon Gas and Food. SIMRANJEETS stated that he was following a subject later identified as Rodney L BARBER (B/M 3-3-88). SIMRANJEETS stated that around 4:30am BARBER was causing a disturbance in the parking lot of his gas station. SIMRANJEETS stated BARBER ripped a piece of conduit off of a pole in his parking lot and intentionally and without consent began swinging it at his exterior windows and cracked three of his bullet proof windows costing him ten thousand dollars.

Squads who assisted to the call

31,30, 3150, 3172, 3225, 3245, 7190.

I spoke to the caller, SIMRANJEETS stated that he was not at the gas station while BARBER was doing this, however the worker on night shift was sending him videos of BARBER swinging the conduit at the windows and had known him from previous interactions they had at the gas station. SIMRANJEETS stated he was at the gas station around 11am when he observed BARBER come back and begin throwing items around the parking lot.

Officers conversation with SIMRANJEETS was still being had over the phone, SIMRANJEETS was urging officers to please meet him at the intersection of N 27th St and W Lisbon Av. SIMRANJEETS stated that he had followed BARBER to that intersection and he is not sitting at the bus stop. SIMRANJEETS stated he does not want BARBER to get away because he keeps causing him trouble at the gas station.

SIMRANJEETS stated BARBER was a black male wearing black pants and no shirt. SIMRANJEETS stated

there was a female sitting next to BARBER at the bus stop but she had nothing to do with it. SIMRANJEETS stated he was parked right by the bus stop. Before changing locations P.O. MARX and I observed three exterior windows to be cracked on the North side of the building.

P.O. MARX and I changed locations to N 27th St and W Lisbon Av and pulled into the BP gas station there. SIMRANJEETS stepped out of his car and began pointing at BARBER, stating that was him. BARBER realized we had arrived and began walking away from us. We caught up to BARBER and placed him into custody.

The owner SIMRANJEETS was cooperative with officers even with a language barrier that assisted in Officers locating and taking subject into custody.

I reviewed video footage of the incident which revealed that at approx imately 4:29am on the listed date, BARBER was walking around the parking lot of the gas station and began pulling on a electrical conduit pipe, which was attached horizontally to a pole between pump 1 and pump 2. After pulling on it a few times BARBER detached the pipe from the wall and began swinging it around his body. At 4:32am BARBER begins swinging the conduit pipe at the three external windows of the gas station on the north west side of the building. It appeared from the video footage that there was a heavy metal object attached to one end of the pipe. I observed BARBER to be swinging the pipe extremely hard, with a lot of force at the window. I observed BARBER to strike the window seven times, before throwing the pipe to the ground. BARBER begins walking around the gas station again, before coming back to the pipe, picking it up and swinging and striking the windows four more times.

There were no issues with obtaining video surveillance from above listed location.


