I feel the City's procedure was improper due to the following reasons and I have attached any supporting evidence, including city employee's names/dates which I spoke to regarding this issue and copies of any city orders received:

I spoke to inspector Ricardo Rosales on Dec 9th & 12th. He told me to clean and put Fresh bait on the traps in basement a few times. I was only able to enter the unit on Dec 18th. I did the same on Dec 26th Jan 5th Jan 11th. I took pictures of the traps. nothing was ever caught on any of these dates. I could not again enter on Jan 16th. I tried again on Feb 13th and on Feb 14th I had the MPD meet me there. Tenant would not cooperate. P.O. PAOLO and PO Knack concluded that it was not worth the DISL. CAD# 83-045-0670. Tenant is very abusive and uncooperative. I feel that ~~Appeal the first charge on Dec 6th~~. I did what I was supposed to do. Therefore, these charges are unfair.

that about 3 times. I didn't document or take any pictures.
So when I received the inspection charge form Dec 6th 2022
I chose not to appeal

When a property is reinspected and violations remain uncorrected, the Milwaukee Code of Ordinances provides for these reinspection fees:

First reinspection \$203.20
Second reinspection \$406.40
All subsequent reinspections \$406.40

There is no charge for the reinspection that shows compliance with all violations.

All reinspections which show noncompliance with the order will be charged at the above rate. These fees will be assessed against the property as a special charge and will appear on the tax bill for this property. On 02/06/2023, we imposed a \$355.60 reinspection fee, which includes a 1.6% training and technology surcharge. Any outstanding fees not paid by August 31, 2023 will automatically be assessed to your 2023 tax bill.

As you can see, the cost of noncompliance with the code can add up quickly. The Department would prefer to see you put the money into correcting the violations and not into paying reinspection fees. Please contact me as soon as the violations have been corrected. If I do not hear from you, we will continue to reinspect until the property has been brought into compliance with the code. Please do not put us in that situation.

If you wish to appeal this charge you must file that appeal within 30 days of the date of this letter. It must be filed with the: Administrative Review and Appeals Board, Office of the City Clerk, Room 205 City Hall, 200 E Wells Street, Milwaukee Wisconsin 53202, 414-286-2221. Please contact them to obtain the proper application form. There is a \$25 fee required when filing this appeal.

Please be advised that if you have filed for bankruptcy, this letter is for informational purposes and is not intended as to be construed as an attempt to collect a debt during the pendency of your bankruptcy as other conditions may apply.
