If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

It was brought to my attention that a client under our supervision, Samantha M. Walker, has applied for a Class D Operators (Bartender) license from the City of Milwaukee. Client Samantha Walker is currently on an extended supervision term that is scheduled to discharge on 3/30/2028 for the offense of Homicide by Intoxicated Use of Vehicle 940.09(1)(A).

This letter is to inform you that such a licensure would be in violation of their rules/conditions of supervision. If circumstances change, we will take measures appropriately, including action that may affect such licensure. We made this decision based in part, on the following information:

**A - Residence Stability:** Client has maintained residence stability Yes.

**B - Reporting History:** Client has maintained required contacts with agent Yes.

I am the extended supervision agent for Ms. Samantha Walker (4/10/1990). Ms. Walker was sentenced on Milwaukee County Case #17CF902, Homicide by Intoxicated Use of Vehicle, on 10/6/2017. Ms. Walker served 5 years in prison and was released to extended supervision on 3/29/2022. While incarcerated, Ms. Walker completed a substance use disorder program which she graduated from on 6/11/2018. Since her release to community supervision, Ms. Walker has continued to maintain absolute sobriety and submitted a total of 12 urine samples between 8/4/2018 and 4/4/2024, that were all negative for illegal substances or alcohol. Ms. Walker also participated in further substance use counseling in the community at Meta House for approximately 2 months upon release from incarceration. Ms. Walker has been stable and overall compliant with extended supervision. Ms. Walker displays good communication, reports on time and as scheduled, and appears overall motivated to remain out of legal trouble and successfully discharge from extended supervision. She is scheduled to discharge from extended supervision on 3/30/2028. Please feel free to contact me with any further questions or concerns about her compliance while on extended supervision.
