This office is in receipt of your claim in the amount of \$815.00, relating re-inspection fees charged on your tax bill for the Tax Year 2002 on your property located at 2735 North Humboldt.

Your January 28, 2003 letter indicated you do not have a phone. This letter will outline the City of Milwaukee's offer to settle this matter. The City is prepared to reduce the \$815.00 building re-inspection fees to \$240.00. The Department of Neighborhood Services (DNS) records indicate \$815.00 was placed on the 2002 tax bill for re-inspection fees related to 3 different orders. A \$240 fee was charged for the first and second orders. A \$575.00 charge was placed on the tax bill for the third order. The DNS has recommended this charge be cancelled. Accordingly, the City will offer to reduce the fees by \$575.00.
