

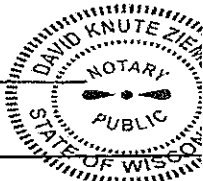

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$3,014,100 for a total estimated cost of \$3,312,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

1st Aldermanic District

N. 19th St. - W. Capitol Dr. to W. Olive St. (ST211120121) File Number 091621: Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (6-11 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$21,200; Nonassessable Reconstruction Paving Fund -- \$360,000). The total estimated cost for this project including the requested amount is \$400,000. This project is anticipated to be completed during the 2014 construction season.

3rd and 6th Aldermanic Districts
E. Wright St. - N. Humboldt Blvd. to N. Holton St. (ST211070141) File Number 121550: Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (3-4 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$18,400; Nonassessable Reconstruction Paving Fund -- \$255,000). The total estimated cost for this project including the requested amount is \$315,000. This project is anticipated to be completed during the 2013 construction season.

4th Aldermanic District

N. 8th St. - W. Michigan St. to W. Wisconsin Ave. (ST211130134) (TD03080000) File Number 111022: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (11-foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$9,000; TID30 Nonassessable Paving Fund -- \$100,000). The total estimated cost for this project including the requested amount is \$109,000. This project is anticipated to be completed during the 2013 construction season.

5th Aldermanic District

N. 97th St. - W. Keefe Ave. to W. Lisbon Ave. (ST211130101) File Number 121331: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8-9 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$16,700; Nonassessable Reconstruction Paving Fund -- \$175,000). The total estimated cost for this project including the requested amount is \$210,000. This project is anticipated to be completed during the 2013 construction season.

6th Aldermanic District

N. 4th St. - W. McKinley Ave. to W. Walnut St. (ST211110102) File Number 121213: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$57,700; Nonassessable Reconstruction Paving Fund -- \$325,000). The total estimated cost for this project including the requested amount is \$423,000. This project is anticipated to be completed during the 2013 construction season.

7th Aldermanic District

Alley between W. Ely Pl., W. Fond du Lac Ave., W. Leon Terr., W. Maxwell Pl., and N. 53rd St. (ST212120104) File Number 110352: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley

Paving Fund -- \$25,200; Nonassessable Alley Paving Fund -- \$75,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2013 construction season.

Alley between W. Ely Pl., W. Fond du Lac Ave., W. Leon Terr., and W. Vance Pl. (ST212120105) File Number 110352: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley Paving Fund -- \$28,300; Nonassessable Alley Paving Fund -- \$60,000). The total estimated cost for this project including the requested amount is \$103,000. This project is anticipated to be completed during the 2013 construction season.

8th Aldermanic District

W. Lapham St. - S. 37th St. to S. 38th St. (ST211130116) File Number 121682: Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (6-foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$2,000; Nonassessable Reconstruction Paving Fund -- \$110,000). The total estimated cost for this project including the requested amount is \$125,000. This project is anticipated to be completed during the 2013 construction season.

W. Scott St. - S. Layton Blvd. to S. 35th St. (ST211130122) File Number 110831: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (5-foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$34,700; Nonassessable Reconstruction Paving Fund -- \$550,000). The total estimated cost for this project including the requested amount is \$635,000. This project is anticipated to be completed during the 2013 construction season.

Alley between W. Mineral St., W. National Ave., S. 21st St., and S. 22nd St. (ST212120111) File Number 111472: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley Paving Fund -- \$11,300; Nonassessable Alley Paving Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$44,000. This project is anticipated to be completed during the 2013 construction season.

Alley between W. National Ave., W. Scott St., S. 31st St., and S. 32nd St. (ST212130101) File Number 111022: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley Paving Fund -- \$32,000; Nonassessable Alley Paving Fund -- \$90,000). The total estimated cost for this project including the requested amount is \$138,000. This project is anticipated to be completed during the 2013 construction season.

10th Aldermanic District

Alley between W. Beckett Ave., W. Melvina St., W. Vienna Ave., and N. 70th St. (Northerly half) (ST212120106) File Number 111472: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley Paving Fund -- \$11,900; Nonassessable Alley Paving Fund -- \$40,000). The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2013 construction season.

11th Aldermanic District

S. 58th St. - W. Forest Home Ave. to W. Morgan Ave. (ST211070128) File Number 110922: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (5-7 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$23,900; Nonassessable Reconstruction Paving Fund -- \$125,000). The total estimated cost for this project including the requested amount is \$180,000.

This project is anticipated to be completed during the 2013 construction season.

12th Aldermanic District

W. Burnham St. - S. 13th St. to S. 16th St. (ST21110136) File Number 121682: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (0-5 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$17,700; Nonassessable Reconstruction Paving Fund -- \$310,000). The total estimated cost for this project including the requested amount is \$360,000. This project is anticipated to be completed during the 2013 construction season.

15th Aldermanic District

Alley between W. Brown St., W. Lisbon Ave., N. 38th St., and N. 39th St. (ST212120112) File Number 111698: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley Paving Fund -- \$15,100; Nonassessable Alley Paving Fund -- \$70,000). The total estimated cost for this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2013 construction season.

Whereas, The report of the Commissioner of Public Works has been filed with the City Clerk; and

Whereas, Notices have been sent to all interested persons and public hearings held; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects: N. 19th St. (ST211120121), E. Wright St. (ST211070141), N. 97th St. (ST211130101), N. 4th St. (ST211110102), Alley W. Ely Pl. (ST212120104), Alley W. Ely Pl. (ST212120105), W. Lapham St. (ST211130116), W. Scott St. (ST211130122), Alley W. Mineral St. (ST212120111), Alley W. National Ave. (ST212130101), Alley W. Beckett Ave. (ST212120106), W. Burnham St. (ST21110136), Alley W. Brown St. (ST212120112) will be billed after January 1, 2015, but not before 12 months after the project contract has been completed; and, be it

Further Resolved, That project: S. 58th St. (ST211070128) will be billed after January 1, 2016, but not before 12 months after the project contract has been completed.
