Regarding: Your Class B Tavern and Public Entertainment Premises Licenses Renewal Application for "Club 99" at 2579 N Pierce St. 

There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings during normal business hours is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of Kilbourn Avenue and Water Street. You must present a copy of the meeting notice to the parking cashier.

Hello Alderwoman Coggs & Safe and Sound,

I hope you are all doing well and enjoyed a safe and fun summer. I live on [redacted] among some really great neighbors. Our block is a mix of young, old, parents with kids, dogs, even some chickens (aka raptors). We love living in the riverwest neighborhood and being a part of a vibrant community, but there have been some recent issues on our block that are very concerning and have us fearing for our safety and looking for solutions. I'm sure that you are aware of the nuisance house on [redacted] N. Pierce, and there was a recent shooting at the bar on the corner, Club 99 which is worrying, since there have already been several incidents this year involving guns and break ins. The owners are always nice and I believe they are finally getting cameras installed.

Biggest issue is [redacted] N. Pierce.

I'm aware that [redacted] is already deemed a nuisance property under the ordinance, but the police are still called almost daily due to continued criminal activity and frequent overdoses by the homeowner who is already in very poor health (Mark), his girlfriend (who finds/gives him the drugs), and the "friends" they bring around, among other nuisance and safety issues that take place most afternoons and evenings. Not only that, but now the homeowners girlfriend ("Joni") has been offering drugs and alcohol to a group of young kids (seem to be ranging in age from

like 8 or 9 to 13/14?) and letting them drive her truck when she is too drunk. They also have these kids swimming in a filthy pool in their side yard. I don't think the kids live in this neighborhood but they are attracted to this crazy lady with no rules. Can't blame them. The sad thing is, she calls the police on the kids when she wants them to leave. Talk about an abuse of city resources.

Anyway, we are reaching out in the hope that you all can assist us ASAP.

Please let me know when you or a representative might have time in the coming week(s) to meet the neighbors and discuss solutions. I can assist with coordinating a block meeting or neighborhood walk. I also was not able to easily find an email for the CLO in D5, if they can be looped in.

The Milwaukee Police Department's investigation regarding this application revealed the
following:

1. On 10/24/07 at 1:00 am, Milwaukee Police received a tip from a citizen (who wanted to remain anonymous) that there was drug dealing going on inside the tavern Club 99. Investigation revealed a patron that was inside of the tavern was in possession of suspected cocaine. Officers interview this subject who stated he uses the cocaine for personal use and hangs out at the club because his father tends bar there. This suspect also stated that several other patrons in the bar sell cocaine. He was arrested and charged with POCS – Cocaine.

2. On 06/02/2009 at 1:15PM, a Milwaukee Police Department squad was sent to 409 E Burleigh St, regarding a battery complaint. The victim stated she was at "Club 99" tavern on 05/31/2009 between 10:00PM and 10:30PM when she got into an argument with a known suspect. The victim then went into the bathroom and upon returning to bar area was struck in the face causing her to fall to the ground. The victim went to St Mary's hospital and received several stitches to her lip. The licensee and his son were cooperative with the police during the investigation and provided a copy of the video footage.

8. On 02/16/2019 at 2:20am officers were dispatched to a fight at Club 99, 2579 N. Pierce St. The officers spoke with the bartender who stated just before 2:00am 4 patrons began yelling. She stated these were not regular patrons and she decided to call last call. The applicant came down from upstairs to help kick out the subjects yelling with the assistance of regular

patron. The applicant stated when the subjects got outside they wanted to fight him and the regular patrons. The subjects then left on foot. The officers found no tavern violations.

9. On 12/08/2019 officers conducted a licensed premise check at Club 99, 2579 N. Pierce St. The officer spoke with Wilfredo ORTIZ, who stated they would be open New Year's Eve and have numerous employees working. ORTIZ was advised to call the district tavern car if there were problems they could not handle.

The caller was identified on scene, Wilfredo J ORTIZ (02-12-79). He stated he closed the bar at approximately 12:00 AM. He was alerted by a neighbor the front door was shattered and returned at 7:30 AM. He observed a brick was thrown through the glass entry door and cash register was taken. ORTIZ cooperated with police during the investigation.

Video cameras at location were old and inoperable. Owner was possibly looking to replace the cameras.

While on scene, I observed the licenses posted and they were up to date.

This report is written by *PO Tashumi WILLIAMS*, assigned to *DISTRICT 5 LATE SHIFT, SQUAD 5340* with *PO Robert ROEMBKE*.

On 09/06/2024 at approximately 2:26am (while in full duty uniform with Axon body worn camera activated) squad 5340 was dispatched to the location of E Clarke/N Pierce St, which is located in the City and County of Milwaukee for a Shots Fired investigation.

INTERVIEW OF CALLER

Upon arrival I spoke to the caller who verbally identified herself as Diana N SERRANO (F/W 06/03/1977) phone number 414-688-6263. SERRANO stated she was outside her residence at 821 E Clarke St. when she heard gunshots go off to the West of her location. SERRANO stated she believed the shots came from by E Clarke/ N Pierce. SERRANO stated she heard about 6 shots go off. SERRANO did not observe anyone or any vehicles near the location.

INVESTIGATION

Squad 5340 went to the area of E Clarke/N Pierce St. to check for any injured individuals or buildings/vehicles that may have been struck. I observed a Bar located at 2579 N Pierce St. was struck 4 times and a residence located directly above the bar was struck once in the living room window. PO ROEMBKE made contact with the individuals who live in the upper residence of the bar, and they stated that no one was injured from this incident. The residents was verbally identified as WILFREDO JL ORTIZ (M/H 02/12/1979) and GEORGE L ORTIZ (03/20/1947). GEORGE ORTIZ is also the owner of the bar that was struck and W.ORTIZ is an employee there as well. The bar was closed at the time of the incident.

G. ORTIZ stated he was in his bedroom when he heard multiple gunshots go off. G. ORTIZ stated he then went to go wake his son W. ORTIZ up to tell him about the gunshots he just heard. Neither of the individuals observed anyone do this incident and they were also unaware that their bar/residence was struck until PO ROEMBKE informed them, which is why police were not called by them. W. ORTIZ stated there are no cameras located inside or outside the bar or residence but he did plan on getting some in the future. W. ORTIZ did advise officers that no one was injured. G. ORTIZ and W. ORTIZ were fully cooperative during this investigation.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


