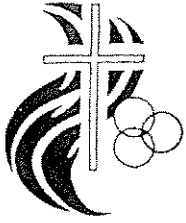
Ald. Witkowski:

Attached is a letter which we sent to our Alders and to the Mayor, in regard to an item that will be before the Public Safety Committee on Thursday, the replacing of stop lights at N. 17th St. and W. Locust Sts.

We have worked long and hard , over several years, on the issue of speeding on Locust with the support of the City and of the 5th District Police. This section of Locust is a dangerous street for our children-- a child was killed here--, for our elderly, for all of us. And many of us have experienced loss of property, damaged houses and cars because of the speeding in the area around Hephatha Church.

Alderwoman Coggs has accompanied us in this struggle. Ald. Hines has recently had his district widened to border Locust Street. We have their support in this effort. We hope for yours, and that of your committee as well.

Dear Mayor Barrett:

Enclosed you will find well over 600 signatures on a petition to restore a traffic light on N. 17th & Locust Streets. On April 30, Alderwoman Milele Coggs will introduce a resolution in this regard. It supports the efforts of our MICAHA Holy Ground Core Team at Hephatha, and neighbors and supporters, over several years now, to address the dangerous traffic issues on Locust Street.

We remember all too well our congregation and Bethesda Baptist Church coming together on a Sunday morning for a prayer vigil for a child killed on Locust Street, just east of our churches. We are concerned most especially for children walking on Locust Street to and from school and to neighborhood activities at our churches and other sites. Their number is growing—we just welcomed 22 new Habitat families into our neighborhood two weeks ago at an event attended by almost 200 people. The population at Hopkins Lloyd Elementary School, just down the street on Locust St. has also increased significantly this year.

The City has worked with us, and we have tried the City's remedies. They are not working. So we continue, as we have for years now, to ask that the traffic light removed at N. 17th & Locust be restored.

The people in the neighborhood say, "They don't understand, because they don't live here. So it is with a united and persistent voice that we once more ask for help in getting the light.

This year, 2013, is the 100th anniversary year for Hephatha Lutheran Church. Our special anniversary project is the installation of a ramp and lift to provide access to those with mobility problems to worship and activities in our building. The ramp opens on to Locust Street, yet another concern about dangerous traffic issues for pedestrians on Locust. In the near future, cars and vans will be stopping to unload these passengers on Locust Street.

Most importantly, lives have been lost, but people have also been injured in accidents near our church. And the church itself has been run into and sustained damage, the house across the street has been run into with considerable foundation damage, as have other nearby homes on Locust St. The church van has been hit, as have numerous cars of members who park on Locust Street while attending activities at the church.

Both Alderwoman and Alderman Hines have agreed to work with us on this issue. On April 30 this issue will be introduced to the Common Council, and assigned, no doubt, to the Public Works Committee.

You know that zip code 53206 has again been identified, in yet another recent report (Wisconsin's Mass Incarceration of African American Males: Workforce Challenges for 2013 prepared by John Pawasarat and Lois Quinn of the Employment and Training Institute at UWM) as having the highest concentration of released and incarcerated Ex-offenders in the city, as well as a leader in concentrated poverty and joblessness and boarded and abandoned houses.

As part of MICAHA we are working on many fronts for a comprehensive approach to restoring our community. The traffic issues is one of many we have worked at consistently to improve the safety and well-being of our some of the most vulnerable members of our neighborhood.

We need your support, and we are asking for it. Alderwoman Coggs can supply any other needed information and documentation for our request. Please lend your help so that the celebration our 100th anniversary may include your participation not only the dedication of our new ramp on Locust Street, but also the dedication of a restored traffic light at N. 17th and Locust .

Thank you for your consideration of our request. We look forward to hearing from you.
