We have received your claim in the amount of \$7,001.97, relating to your subrogation interest and the interest of your insured arising from a December 6, 2007 loss in which the insured's vehicle collided with a City of Milwaukee Fire Department Vehicle at South 1st Street and the alley-West Florida Street.

Our investigation reveals that the Wisconsin Motor Vehicle Accident Report and the Fire Department Vehicle Damage Report completed as a result of this accident notes that the fire truck had its right turn signal on and was making a wide right turn into the alley. Your insured's vehicle snuck in next to it on the right side and made contact. The liability for this accident is upon your insured. As such, the City cannot accept liability for your insured's damages. Therefore, we are denying your claim.
