
Attorney Eric Andrews of Dunkin Law has presented a claim for damages for injuries sustained on behalf of his client Sabrina Wade when she slipped/fell on November 23, 2022, while leaving her apartment building due to uneven concrete, at or near 5175 N. Hopkins Street. Mr. Andrews presented a settlement demand for past medical, hospital bills, and past/future pain and suffering to be \$178,173.07.

Our investigation reveals that Infrastructure Services completed a search of call center records for the 5010 through 5300 blocks of W. Hopkins Street between August 23, 2022 through November 23, 2022. The call center records revealed there were no calls for hazards received in this segment.

The city of Milwaukee had no notice of the allegedly defective condition in the sidewalk at the subject location. Because of this lack of notice, we recommend that the claim be denied.
