Memorandum

Dear Alderwoman:

I am writing this letter to inform you personally and directly of the matters raised in the letters sent to me by the Milwaukee Police Department related to my business operating within your district-respectfully. Of late, or at least within the last (6) months of the calendar year, I have been dealing with a number of issues in my homeland which have caused me to leave the United States for a period of time. Many of the issues I faced were family related. I even faced a major health scare I'll reference shortly. Ultimately, I failed to meet the high standard I'd previously established for the business while under my daily stewardship.

I take great pride in operating that store. I've never been a problem operator there or anywhere else I have operated; businesses be they in my home country or within the United States. My relationship with your office has always been one of openness and honesty. I plan on continuing that same relationship with you. I met with my counsel and another individual I know you're familiar with in, Mr. Amari Brown, a business owner within the community. He has been aiding me on the proper way to operate that storefront as it relates to dealing respectfully within the African American community I serve, getting all of my counter help set up with their own licenses to sell alcohol and he has offered to bring in contractors to help me with minor needed repairs to the store's infrastructure. I want to and will be complaint with all the City of Milwaukee's officials, its Inspectors and Police Department requires of all licensed operators such as myself.

As it stands, I am in desperate need of a provisional license to continue operating my business as my former license has expired. After I contracted COVID-19 while traveling in my home country I found it extremely difficult getting back into the U.S. to manage my stateside affairs. The renewing of my previous liquor license was one of those 'affairs' I now reference.

The incidents of note listed by MPD in the letter I received is quite misleading. I don't blame the officers for the tone of the report, but it is grossly inaccurate. There were never nor has there ever been any attempts made by myself nor by my employed staffers, to sell liquor to any licensed bars, lounges or restaurants within the City of Milwaukee or elsewhere. Please read below:

Item (1) 11/09/2020 Officers conducted a licensed-premises check of my venue after raiding another venue or 'after-party' on Atkinson Avenue. Upon their search of that 'after-set' they uncovered boxes with the name of my store on them. ANSWER: We have sold liquor for more than (2) years and running now to any manner of individuals. Those who purchase large orders of supplies are often given empty boxes we keep on site to use as 'carrying' boxes or crates. At times we have kept our empty boxes for make shift trash bins for our own litter & refuse. Those we do not use we discard. We have now taken to shredding our old boxes for the sake of clearing up any confusion relative to our businesses boxes and whom we sell to. Any sober minded, law-abiding patron over 21 years of age, are our customers, Alderwoman.

Item (2) 03/23/2021 This item in the letter indicates that there were two individuals in a car whom MPD pulled up on to inquire of them 'why they were entering the store after hours. One of the individuals questioned said that she was there to pick up liquor for a licensed purveyor of liquor operating within the Milwaukee area (KISS ULTRA LOUNGE). ANSWER: I do not know who that person was or is. The person entering the venue works for the store itself. Her shift ended at 9:52pm that evening after she cleaned the store with two others, re-stocking the shelves, taking out the trash and conducting a 'drop count' before she exited the store with her husband & friend who were seated in the car. Each of them were apparently 'going' to KISS Ultra Lounge thereafter to shoot darts in a league tournament that eve. After getting to their destination my employee realized that she had left her keys in the store's safe. They returned to the store (They were all in one car that evening) to retrieve the registers Master keys & my employees house keys-which she'd left in the safe after counting the 'drop' as mentioned earlier.

When asked about liquor supplies for any venue she told them her reasons for being back at her job-which hadn't a thing to do with alcohol or supplying any licensed venue. The officers never mentioned there being any liquor whatsoever in the car or on any person.

Item (2) 03/24/2021 This item references the same officers arriving back at store to inquire of my employee whether or not she was able to produce a Class "D" license in order to sell alcohol from my store. ANSWER: She told him that she did not possess a Class D license and that she was only a few hours from finishing her online work to procure them. She and all of the 4 employees I employee from the community now have them. Special Note: The officers were kind, professional and very courteous. They apprised my staff of the need for at least (1) licensed person to be on premises during store hours if they planned to continue working there selling alcohol per City of Milwaukee ordinance. I arrived home from my native country on the 27th of March. I was back in the store with a potential buyer on the 29th.

I should hope that my answers sufficiently answer each of the matters raised in the police report. I am working diligently to operate this store safely and in accordance with the powers granted me under the authority of my license's legal limits. I envision a time very soon when the store itself will be sold to a new owner who'll follow even stricter, more disciplinary measures as an operator than I have, with your blessings of course. I feel as if this business and the community would now be better served if it were operated by a Member of this strong community and neighborhood. I should like to meet with you soon on my plans if your schedule permits. I will surely keep you posted on that initiative as time progresses, Madame Alderwoman.

Thankyou as always for taking the time to listen to your district's business operators and residents.





The Milwaukee Police Department's investigation regarding this application revealed the following:

This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

- 1. On 11/09/2020 officers conducted a license premise check at Express Liquor, 3833 N. Teutonia Av. regarding an investigation of alcohol observed at a possible "after Set" at 1306 W. Atkinson Av. Officers located many containers at the after set with shipping labels to several liquor stores including Express Liquor. Officers responded to Express Liquor to conduct a preliminary inspection.
- 2. On 03/23/2021 at 10:23pm officers observed subjects entering the closed liquor store at 3833 N. Teutonia Av. The officers spoke with the subject sitting in the car outside and she stated they were there to pick up liquor for Kiss Ultra Lounge. The officer waited for the subjects to exit the business. One of the subjects stated she was an employee and had just come to the store because she left her keys inside, she denied being there to pick up alcohol. The employee refused to call the owner of the business by phone.
- 3. On 03/24/2021 at 7:32pm officers went to Express Liquor, 3833 N. Teutonia Av. to speak with the owner regarding the incident from 03/23/2021. The officers spoke with the same employee from the night prior. She stated she was the only one in the store selling alcohol. The officers know from checking the previous night that she does not have a Class D Operator's license. The employee contacted the applicant by phone and he responded to the store. The officers asked to look at the video from the previous night and the applicant stated he did not have the password. The applicant stated he did not know the employee did not have a bartender's license. The applicant was cited for Responsible Person on Premise.

This report was submitted by PO Keith GARLAND, assigned to District Five, Early Power, CPU.

On Monday, November 09, 2020, at approximately 4:04PM, PO Nicholas FERRANTE and I, PO GARLAND (Squad 5266) responded to 1306 W. Atkinson Ave for an ongoing investigation of an After Set complaint. Per the owner of the property, Phoebe BOTROS (Bokott Commercial LLC, 414-507-0434) only the upper level of the building (1310 W. Atkinson Ave) is occupied by tenants and no one should be located in the lower levels of the property (1306, 1308, 1312, 1314, 1318 W. Atkinson Ave). BROTOS stated the lower levels of the property is vacant and she was willing to prosecute anyone who is caught trespassing on the property. BOTROS gave the Milwaukee Police Department permission to access the property all times, minus the tenants apartments.

Upon arrival to 1306 W. Atkinson Ave, PO FERRANTE and I observed that there were multiple empty boxes of alcohol containers, located in a green waste management dumpster that was located on the Northwest corner of N. 13th St/ W. Atkinson Ave that aligned against the brick wall of 1306 W. Atkinson Ave. I observed that the shipping labels on the containers listed to multiple alcohol distributing companies, and liquor stores in the Milwaukee area.

On today's date, at approximately 4:30PM, PO FERRANTE and I responded to the Express Liquor Store regarding the investigation. Upon arrival, we spoke to the store clerk, who was identified as Dinesh CHAKERI (I/M, 11/15/920. PO FERRANTE and I did not provide CHAKERI with the specific details of the ongoing investigation, but we conducted a license premises on the business. CHAKERI identified the

This Report is written by PO Russell MACRAE assigned to District 5 - LATE POWER TAVERN CAR.

On 03/23/21 at 08:57pm, PO David LETTEER and I (SQ#5468) were dispatched to assist Milwaukee DPW in traffic control regarding a water main break. PO LETTEER and I were blocking traffic at 3805 N Teutonia Ave.

I observed that employees from EXPRESS LIQUOR located at 3833 N Teutonia Av left the store at approximately 09:00pm when the store closed. At approximately 10:23pm, PO LETTEER and I observed a white Jeep Grand Cherokee (WI-PL: AKG2826) and a Silver Hyundai (GA-PL: CCU7385). I observed (2) subjects walk inside the front door.

I walked from where we were still blocking traffic for Milwaukee DPW to the liquor store. I observed a female sitting in the front passenger seat of the Jeep. The woman verbally identified herself as the owner of the Jeep; it was later confirmed via WI-DOT. She was identified as Cheryl B. BURNLEY (B/F 09/04/75). I asked BURNLEY what they were doing at the liquor store. BURNLEY stated "picking up some liquor for delivery". I asked BURNLEY why they had driven around the construction zone. BURNLEY stated "How else are we to get to the liquor store?" I asked BURNLEY where they were specifically delivering liquor to. BURNLEY stated "To a nightclub". I asked what club; BURNLEY stated "KISS" (Referencing to KISS ULTRA LOUNGE located at 7330 N 76th Street). Lasked BURNLEY if she worked for "KISS"; she stated "No, we're just dropping off an order that we couldn't get earlier". I asked if the driver of the Jeep worked for "KISS"; BURNLEY stated "This is my car...had to use my car due to more space to transport the order" I reiterated that the driver of the Jeep because she was in the passenger seat; she stated "no". I asked if anyone here worked for "KISS". BURNLEY stated that "KISS" called at placed an order. I asked how much liquor did that order; BURNLEY stated she was unsure. I informed BURNLEY that what she was doing was illegal.

I informed dispatch of our location and investigation. Upon checking the front door to the business, the front door was locked. I could see in the windows and did not observe anyone immediately inside the door or behind the glass-area where the cash registers are located. While waiting for the (2) subjects to exit the store to speak with, BURNLEY stated that they were just picking an order up. I informed BURNLEY that it was 1.5 hours after the State of WI cutoff time for liquor sales, and that a nightclub or bar needed to order liquor through a liquor distributor and not from a liquor store. BURNLEY stated "that's what they are"; I informed her that the business was just a liquor store.

At approximately 10:35pm, the (2) subjects identified by WI-DL as Gregory D. RENFRO JR. (B/M 10/17/79) and Jaminah C. NELSON (B/F 09/05/82) exited the front door to EXPRESS LIQUOR. I observed NELSON holding a set of keys and a padlock used to lock the interior gate. I asked NELSON if she worked at the store; NELSON stated "I do". NELSON stated that she had forgotten her keys. I informed NELSON and RENFRO that I had just been informed by BURNLEY in the Jeep that everyone was at the store picking up a liquor order for "KISS" nightclub. I asked again what was NELSON doing at the store this late after hours. NELSON stated that she had just closed the store and had forgotten keys for home. I asked NELSON that when I review the security footage would it show her looking for keys or looking at liquor. NELSON stated that it would show her looking for keys. I asked to go inside to review the cameras. NELSON stated "No...I'm not going to let you in....Ya'll don't have any protocols for that" NELSON then asked "Do you have a warrant to get in here?" I informed NELSON that the store was a licensed premise. NELSON stated that she could not let us inside.

I informed both NELSON and RENFRO that they were being detained for our investigation and that they were not free to go at this time. RENFRO stated that he did not work at the liquor store. I asked NELSON that when I call the Licensee / Owner of the store and explain that we had observed her and RENFRO inside the store 1.5 hrs after the store closed, how might he react? NELSON stated "They'll probably be wondering what I was doing in the store after hours". I asked NELSON if she worked today. NELSON stated that she worked from approximately (5pm-Close). NELSON stated that when she left the store, when she arrived at home she realized that she did not have her house keys. I asked NELSON why would RENFRO have to be here to assist her. NELSON stated "Because it was night, I didn't know if you guys would still be here (blocking traffic for DPW) because I didn't know how long you'd be out here...but I don't like to come to the store at night...it's dark and I'm by myself". NELSON continued stating "I would never come here by myself".

I informed NELSON that since she was not going to allow us inside the store, I asked her to call her boss. NELSON did not reply and stood silent. I asked NELSON if she was refusing to call her boss. NELSON stated "I don't know if I should in the first place...I'm not going to just let you in...not like you're at my house, I wouldn't let you in there either" I asked NELSON again if she was going to call her boss. NELSON then attempted to close the front door. I informed her to not lock the door.

I asked NELSON if she had a Class-D License (Bartending). NELSON stated "Yes...but I don't sell alcohol". I asked NELSON if she had a Class-D License in the City of Milwaukee. NELSON replied "I don't sell liquor". PO LETTEER took both NELSON and RENFRO's information back to our squad to check for wants and to acquire the EXPRESS LIQUOR - Licensee's current phone number. I informed NELSON and RENFRO that until we made contact with the Licensee they were still detained. I informed that if it was discovered through my investigation that either of them work for "KISS" nightclub and they lied, I would pursue charges against them.

While waiting for PO LETTEER to return with information, I asked RENFRO why BURNLEY would tell me that they were at the store picking a liquor order up. RENFRO stated that he did not know why she would say that. RENFRO stated that he did not work for "KISS" and that I could tell based on what he was wearing. I told him I did not understand. RENFRO stated that if he worked for "KISS" that he would be wearing better clothing and be more dressed-up. I asked RENFRO if he had ever picked up liquor for the club previously, he stated "no". I informed RENFRO that BURNLEY's statement was so detailed and specific that it appeared to me that it was more truthful than not.

I asked NELSON what it was that she did at the store. NELSON stated that she "organizes things". I asked her to explain further; NELSON stated that she organizes events, work schedules, and stated that she is more of an office assistant. I asked how many days a week she works; NELSON stated "a few hours a week". I inquired that if she works a few hours a week, why would the store give her a key or full access to the store. NELSON stated "That's because I'm an office assistant...I need access".

NELSON began to make a phone call to an unknown male. NELSON asked me if I wanted to speak with the manager. I asked if the person she was speaking with was the Licensee or Owner of the store, NELSON stated "No". I informed her that I did not want to speak with whomever that was, and that I would be contacting the Owner directly at home. NELSON then puts her phone on speaker-phone where a male begins to yell. I informed NELSON again that I did not want to speak with whomever was on her phone. NELSON then held the phone closer to my face. I told NELSON again that I did not want to speak

to whomever was on her phone. At that time, PO Adam MARITATO and PO Robert PARKS (SQ#5469) arrived to assist PO LETTEER and I.

PO LETTEER returned and informed me that NELSON does not possess a Class-D (Bartender) License. PO LETTEER spoke with RENFRO regarding an open Protection Order against him that he had not yet been served with. PO LETTEER informed RENFRO that he has now been "served" regarding. PO LETTEER stated that he had attempted to contact the Licensee / Owner identified as Navroze A. LALANI (08/08/74) however there was no answer. PO LETTEER stated that he left a detailed message regarding at approximately 10:40pm.

I had NELSON show PO LETTEER and I that the keys she possessed actually were able to open the padlock and front dead-bolt lock to the front entrance door. I observed that the keys did work. I informed NELSON that we would be filing a report and conducting follow up to view the security footage to confirm her story in the near future. If any of their statements turned out not to be truthful, we would pursue charges against them.

NELSON and RENFRO stated that they understood.

This license premise report is written by PO David LETTEER, assigned to District 5 Late Power Shift, Tavern Squad 5468, with PO Russell MACRAE.

On 03-24-21 at 7:32 p.m., we responded to the location at 3833 N. Teutonia Ave., Express Liquor, which is a city of Milwaukee licensed premise. The purpose of our visit was to inspect the establishments licenses and speak to the listed agent, regarding Case# 21-082-0187 (03-23-21), in which an employee drove to the closed establishment, with what we learned might be an after hours liquor pickup for Kiss Lounge, as well as picking up keys that she had left at the store and did not take with her when they closed.

Upon entering the establishment, we observed a black male wearing a sweatshirt with sunglasses, along with a female who we spoke to the night before, regarding Case# 21-082-0187, in the cashier area. We did not observe the agent or his wife behind the counter. We also observed another black male, who was in the customer area. Also in the front customer area were a male and female, who had placed 9 bottle of liquor on the counter, as if they were waiting to pay for the products when we entered the store.

As I was walking into the store, I walked to the entrance of the cashier area, which is located in the middle of the store. I observed that the door was being held open by a deadbolt. As I reached for the door, the female Jaminah C. NELSON (b/f 09-05-82), yelled "Is it open or not?" I nodded to her, believing that she was having me come to her. I began to open the door, in order to speak to her, as I did this, she came over to me, telling me that I had to leave and that I could not be in this area. I informed her that we were here to inspect the licenses of the establishment. She informed me that I had no right to be, again in this area.

As she was speaking to me, PO MACRAE entered this area and began to conduct a check of the establishment. NELSON then began to speak to PO MACRAE and another employee, Delano A. DENNIS (b/m 08-30-64) walked up to me and began to question as to why the police were at the establishment. I informed DENNIS that we were there to check the business licenses and speak to the agent, regarding the incident from the previous night. DENNIS stated that events from the previous night did not happen and that he was working that night. He stated the business closed and workers stayed to finish getting things in order for the night. He stated that no one had returned to the store after closing. DENNIS then began questioning me on who the owner was and he informed me that the owner was a black male, but did not know his name. I informed

him that the agent of the store is not a black male and that he (agent) and his wife work at the establishment. When I asked him who the agents wife was, he could not answer the question. He again questioned why we were there and that we could not check the store, as well as the events from the night before did not happen. I informed him to contact District 3 and ask for the open records section and that he could acquire a copy of our body worn cameras from the previous night, so that he could watch the events from that encounter.

Both DENNIS and NELSON had become angry and arguing with us, so I called for a supervisor to respond to this location. I then walked to PO MACRAE, who was near the cash registers and located the licenses for the establishment. The posted Class A license (199976) listed Navroze LALANI as the agent, with the license set to expire 07-17-21 . I looked and located Class D license with LALANI's name on it. I also located CBD license for CBDIOLOGY, Industrial Hemp Process, license #479827-HP which expired 12-31-19, with Azmat KAHN as the agent, who is located at 1345 N. Jefferson St. #420, Milwaukee WI 53202. CBCIOLOGY LLC is located at 811 E. Pleasant St. Milwaukee, WI 53202. We observed products from this company near the front cash register, for sale, as well as a box lying on the floor with CBD products.

PO MACRAE and I then began to explain why we were at the establishment to NESLON and explained why she needed to have a Class D license. We explained to her that for her to take money or sell alcohol, the business agent needed to be present, in order for NELSON to take money for alcohol. NELSON stated she came to work about 5:00 p.m. or 5:30 p.m., but she did not tell me who she relieved, but that the store was open when she arrived. She stated she was the only person who was taking money for alcohol products, but PO MACRAE and I never observed her take money for any alcohol products.

NELSON was able to contact the listed agent on the telephone and he (LALANI) responded. We informed LALANI of what we observed from the previous night, as well as informing him that staff at the establishment would not let us conduct the license inspection. LALANI also was informed that NESLON was not licensed as a Class D Operator and could not take money for alcohol and someone with a Class D license or agent needed to be present in order to operate.

LALANI stated he left the establishment around 5:00 p.m. or 5:30 p.m. and turned operation of the establishment to NELSON. He stated he was unaware that NELSON did not have a Class D License. PO MACRAE then asked LALANI if we could watch the video from the previous night, in order to find out if what NELSON told us the night before was correct or not, in coming to the closed store to locate a key. LALANI took us downstairs to

the basement area and walked us to where the video surveillance system is. In an attempt to use the system, we needed a mouse to use the functions of the camera system, but we could not locate a mouse. We attempted to access the system via the keyboard, but could not due to a password that was needed to access the system.

LALANI stated he did not know the password and that his wife, who also works at the store, might know it. LALANI attempted to contact his wife, with no success. When asked how long he had this surveillance system, he stated 6 or 7 years. LALANI stated he has the cameras for the employees and never uses it. LALANI was asked how long he retains video and he stated "a couple days". LALANI stated that his wife knew the password because she is the one who runs this store. LALANI stated that he operates a Truck Stop in Illinois and only has this liquor store in his name.

While maneuvering through the store, moving around was tight and cramped, especially in the basement area. I asked LALANI how much inventory, in dollars he had inside of the store. LALANI stated \$400,000 to \$500,000 dollars worth of product. We informed LALANI with this much product or the safety of the employees, that he might want to know the password to his camera system, in case something happened to his employees or store, along with his products.

We inquired about whether the store had any firearms inside for employees. The previous owners had a handgun behind the area where the cashier is located. LALANI stated that there was a shotgun in the rear of the store. LALANI walked us back to the rear emergency exit in the rear of the store. *It should be noted that any patron could also walk into this area while at the rear beer cooler* LALANI stated that the shotgun is typically hidden in between boxes. LALANI was unable to locate the shotgun and became worried. LALANI ultimately stated that he assumed his wife had moved it to another location.

We informed LALANI that we would be issuing him a citation for responsible person on premise, the reason being that LALANI left the store and that NELSON was there for 3 hours, with no responsible person on premise. LALANI asked us several times if we could just give him a warning, but we informed him that the citation would be issued and that we would deliver it to him.

I checked LIRA during the previous nights encounter and did not find any valid city of Milwaukee licenses with NELSON's name. It should be noted, while speaking to her the previous night, I asked her if she had a license and she was confused, believing that I was asking her about her driver's license, when I was asking her about a city of Milwaukee

On 04-09-21 at 5:28 p.m., PO MACRAE and myself, along with Sq. 5266 (PO FERRANTE and PO GARLAND), Sq. 5280 (PO SUVAKA and PO LEBENSKY), Sq. 5284 (PO SROMALLA and PO RAMION), Sq. 5411 (SGT. BAMABA), 5211 (SGT. RAMIREZ), City of Milwaukee Building Inspection and Fire Inspection, along with Wisconsin Department of Revenue Agent Georgeann KING and Wisconsin Alcohol and Tobacco Agents DORN and WALDHERR conducted an inspection at Express Liquor, a licensed premise in the City of Milwaukee, located at 3833 N. Teutonia Ave.

Upon arrival we entered the store, which was open for business. As we entered the store, I observed the clerk in the secured clerk area, with a black female and a black male is helping stock the store. We entered the store and I observed Delano DENNIS (b/m 08-30-64) a stocker at the store, who was in the middle of the store, who stated he had just came upstairs for the bathroom.

We entered the clerk area, due to the door being propped open and informed the clerk that we were there to conduct an inspection of the premise with the State Agents. I asked if the listed agent NAVROZE LANALI was present and if he was not, that the clerk identified as Dinsesh CHAKERI (a/m 11-15-92), should contact him, so that he could come to the store. LALANI was not on the store premise when we arrived.

There was a female wearing pink, identified as Trinika N. WALKER (b/f 02-25-80), who stated she was hanging out with the other two. As we were speaking to CHAKERI, everyone began to conduct their inspections of the business.

The other black male, Joseph L. TURNER (b/m 05-05-80) is a stocker at the store and was sitting in a chair in the clerks area.

All 3 people were asked to leave the clerks area and wait in the customer area or main floor with other officers as the inspection was conducted.

Alcohol and Tobacco agents began checking alcohol and distribution receipts, Building Inspection checked the building and Fire Inspection conducted a fire inspection of the premise. LALANI did have his Class A license properly posted and the license is valid.

As the inspection was conducted, LALANI did arrive at the premise. He stated that he had to leave around 5:00 p.m. to do a money run to the bank, but that he was coming back. I informed him that from our last license inspection that we knew CHAKERI did not have a valid Class D Operator's license. No other employee at the establishment claimed or presented a Class D Operator's license. Again LALANI stated he had left for a short time to go to the bank.

PO MACRAE then began to speak to LALANI, having LALANI go downstairs to the basement, where the video system is kept, so that PO MACRAE could review the video for the store. PO MACRAE after watching the video, informed me that LALANI was in and out of the store and that he had left the store

around 5:00 p.m. and did not return until he was called for the inspection. PO MACRAE also asked WALKER if she was an employee at the store, to which she stated she was not. PO MACRAE asked WALKER why she would be taking money for alcohol if she did not work at the store, because he (PO MACRAE) watched the video where WALKER was taking money. WALKER then stated she is not an employee at the store, but was taking money. She stated she had taken the responsible servers course and submitted her paperwork to the city, but does not have her Class D license at this time. I did check LIRA and did not find any application with the name of Trinika WALKER as being submitted. WALKER was informed that she will be cited for not having a Class D Operator's license.

PO MACRAE also observed CHAKERI was taking money for alcohol, while the agent was not present at the store. CHAKERI also stated that he had completed the responsible servers course and that his paperwork was with city as well. I also checked LIRA for CHAKERI and did not locate an application with the name of Dinesh CHAKERI as being submitted. CHAKERI was informed that he would be cited for not having a Class D Operator's license. LALANI did also tell me that CHAKERI did submit his paperwork to the city for his Class D license.

I informed LALANI that due to the fact that he was not on the premise when we arrived that he would be receiving a citation for responsible person on premise, again the business was open for normal business and the stores sales are from the purchase of alcohol. LALANI began to question on why he was receiving a citation. I informed him that he was not at the store and there was no responsible person on premise.

Georgeann KING, Agents DORN and WALDHERR through their inspection located a Total Wine receipt for 66 bottles of 200ml of Hennessy, which was confiscated.

Also confiscated were 22 packages (3 boxes) of tobacco products, due to no invoice and acquired through an unknown source.

On 04-15-21 we received a Department of Neighborhood Services inspection report (ORD-2020-03840) for Taxkey #270-1720-000:

- -Items at the store that needed to be corrected by 03-30-20, from an inspection on 02-26-20:
- -Restore basement to clean and sanitary conditions, clean moisture and waste off of the basement floor.
- -Maintain 24 inch minimum clearance between combustible stock and ceiling, lower storage height under 24 inches in all areas of the building, including sales foor, basement, basement storage and displays behind register area.
- -Service fire extinguishers and note date on tag in accordance with IFC and NFPA 10-4-4.1
- -Provide the minimum number of fire extinguishers for the protection of both the building structure and occupancy hazards contained therein. Supply a fire extinguisher for every level of the building.
- -Remove obstruction to designated fire exits immediately and remove all obstructions from rear exit and all other areas of the building.
- -Remove any obstruction from stairways immediately and remove all boxes and storage on stairway.
