On Wednesday, February 5th, 2025, I was dispatched to the Burger King restaurant at 2862 N Dr Martin Luther King Jr Drive (store 4054) for a Welfare of Citizen incident.

Upon my arrival I observed a female subject at the order counter within the patron area of the Burger King restaurant. The subject was speaking to the staff who weren't acknowledging her presence. The phrases recited by the subject were incoherent and random. I requested another squad to assist with the subject who appeared to be emotionally disturbed.

The manager, Victoria MARTIN (F/B, 04-23-71) who was also the caller and called from her personal cell phone (414-499-5266), approached the counter from the worker's side and explained the situation. MARTIN stated that the subject was disrupting business within the restaurant by confronting customers as the attempted to order food and/or sit and eat within the dining area. MARTIN stated that she was concerned for the subject's mental health and well-being and that she may disturb someone who may cause harm to the subject. MARTIN was cooperative in her statement and with sharing the license premise documentation. I then was able to convince the subject to leave the restaurant. The asked the subject if she wanted to be conveyed home but she stated that she did not have a home. Then conveyed

I spoke to the caller, Victoria MARTIN (F/B, 04-23-71) who was the location manager, who called from her personal cell phone (414-499-5266) to report that an unknown subject who frequents the restaurant and was later identified as Memphis THORNTON (M/B, 11-29-93) was at the location earlier, panhandling and harassing customers. ON TUESDAY, OCTOBER 28, 2025 AT 1:06P, MY PARTNER (P.O. DANIEL TIERNEY) AND I WERE DISPATCHED TO A BATTERY COMPLAINT AT 2862 N. DR. MARTIN LUTHER KING JR. DR., BURGER KING. UPON ARRIVING, THE CALLER WAS LOCATED OUTSIDE OF THE RESTAURANT AND IDENTIFIED HERSELF AS BRITTANY L. CRIVELLO (W/F, 03-08-88). CRIVELLO STATED AT APPROXIMATELY 1:00P, SHE HAD WALKED INTO THE BURGER KING AND PICKED UP AN ORDER FOR HER AND HER CHILD. CRIVELLO STATED AFTER PICKING UP THE ORDER, SHE TOOK HER CHILD TO THE RESTROOM INSIDE OF THE RESTAURANT. WHILE IN THE RESTROOM, CRIVELLO STATED AN EMPLOYEE KNOCKED ON THE DOOR INDICATING "EMPLOYEES NEED TO USE THE RESTROOM TOO." CRIVELLO STATED SHE WAS IRRITATED AND OPENED THE DOOR. CRIVELLO STATED SHE ENCOUNTERED AN EMPLOYEE OUTSIDE OF THE RESTROOM AND BEGAN ARGUING WITH HER. CRIVELLO STATED THE EMPLOYEE ACCUSED HER OF SPITTING ON HER, GRABBED HER BY THE NECK AND SHOVED HER INTO A GLASS PANE WINDOW. CRIVELLO STATED HER HEAD BANGED AGAINST THE WINDOW CAUSING HER PAIN AND INDICATING HER GLASSES GOT BENT DURING THE ALTERCATION. CRIVELLO STATED THIS WAS DONE WITHOUT CONSENT AND SHE WISHED TO PURSUE CHARGES. I DID OBSERVE REDNESS TO THE TOP OF CRIVELLO'S HEAD AND HER GLASSES APPEARED BENT. CRIVELLO FURTHER STATED SHE DOES NOT HAVE UPPER TEETH SO SPIT MIGHT HAVE COME OUT OF HER MOUTH WHILE ARGUING BUT IT WAS NOT HER INTENT TO SPIT ON THE EMPLOYEE.

THE EMPLOYEE WAS ON SCENE AND IDENTIFIED HERSELF AS VICTORIA J. ALLEN (B/F, 04-12-93). ALLEN ADMITTED TO ENGAGING IN AN ARGUMENT WITH CRIVELLO. ALLEN STATED WHILE ARGUING WITH CRIVELLO, SHE GOT SPIT ON AND JUST REACTED. ALLEN ADMITTED TO GRABBING CRIVELLO BY THE NECK

THE MANAGER ON DUTY IDENTIFIED HERSELF AS VICTORIA SMART (B/F, 04-23-71). SMART STATED SHE OBSERVED THE INCIDENT OCCUR AND INDICATED IT WAS DUE TO THE AVAILABILITY OF THE RESTROOM. SMART STATED SHE OBSERVED ALLEN GRAB CRIVELLO BY THE NECK AND IMMEDIATELY STEPPED IN TO INTERVENE. SMART STATED SHE HAD ALLEN GO BACK BEHIND THE COUNTER AND INDICATED CRIVELLO WENT OUTSIDE TO WAIT FOR POLICE. SMART WAS COOPERATIVE AND ALLOWED ACCESS TO THE SECURITY CAMERAS. ALL CAMERAS WERE OPERATING PROPERLY AND ALL LICENSES WERE PROPERLY DISPLAYED.
