

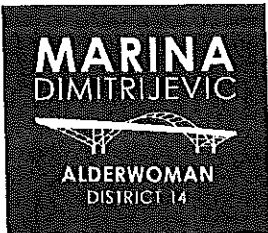
Good afternoon,

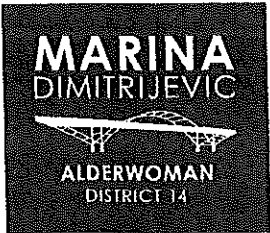

This report is written by PO Justin RAVELY, assigned to District 6, Late Shift, Squad 6340.

On Monday February 20, 2023, at 1:38AM, my partner, PO YOSHIEA GRIFFIN and I, were dispatched to a Shots Fired Complaint located in the area of S KINNICKINNIC AV / E RUSSELL AV, in the City and County of Milwaukee.

Upon our arrival, I called and spoke to the caller, Todd A. BROWN (W/M 03/16/1968), who stated that at approximately 1:30AM on 2/20/23 BROWN heard 5-gun shots in the alley near his residence. Approximately 5 minutes before officers arrived on scene, he observed a unknown subject (Unknown race/gender) wearing a black hooded sweatshirt run near a unknown black vehicle in the alley near 2619 S. Lennox St. BROWN stated that he did not witness this subject fire a gun. He just stated that this subject ran towards "the restaurant". When officers had asked him which restaurant because there are two restaurants on S. Kinnickinnic Ave. near his residence, he did not specify which one.

Officers located a Black Hyundai Tiburon (WI Plate 866-XXZ) parked in the rear near the alley, but the engine was cold to touch and it lists to an address nearby.

I went to Belli's Restaurant/Bistro and made contact with the owner, Michael J. PATTON (B/M 07/08/87), and asked him if either him or his staff heard any gun shots and they stated "NO" and that "this was news to them". PATTON did show concern because of him being a business owner. When asked what time customers left his establishment this evening he stated around "Midnight". I had also asked him if there was any arguments or trouble with any customers or employees tonight and he stated "NO".

Belli's restaurant was not directly involved with this incident. However, according to the original caller, BROWN stated that they continue to have problems with the noise that emits from the business and are concerned with the after hour activities where they hear and see people still inside the business after closing hours.

Squad 6330, PO SHEREMETA and I canvassed the back alley and we located 3




