Returned herewith is a document filed by Attorney Laurie Eggert for attorney's fees for representing Police Officers John Heim and Larry Pierce. The claim is in the amount of \$693.00 for 6.30 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the Police Officers on whose behalf this claim was filed.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Sec. 895.35, Stats., *Bablitch and Bablitch v. Lincoln County*, 82 Wis. 2d 574 (1978).


Dear Mr. Leonhardt:

You have referred this case to me for issuance of criminal charges of Duty Upon Striking (Personal Injury).

No suspect is listed, and, indeed, a reading of the police reports reveals that there is no suspect against whom there is evidence establishing even probable cause to believe that a crime was committed.

If someone committed a crime by striking this young woman on her bicycle, and evidence exists to establish that fact, I would be more than happy to issue charges. In the absence of such evidence, I decline to do so.
