
We have received your claim in the amount of \$2,200.00 relating to a loss from July 1, 2025 at address 807 S. 36th Street Milwaukee, WI.

The Milwaukee Police Department (MPD) report indicates that they executed a lawful search warrant at residence 807 S. 36th Street on July 01, 2025. The Milwaukee Police Department (MPD) used forced entry while executing a lawful search warrant, as permitted under Wis. Stat. § 968.14, and there is no evidence of negligence on the part of the MPD.
