Dear Ms. Jones:


This office is in receipt of your claim in the amount of \$3,500.00, relating to the recycling of your vehicle when it was towed after being ticketed on August 5, 2003.

Our investigation reveals your vehicle was towed on August 5, 2003 as being "Abandoned" and in a "State of Disrepair". The PT-27 Tow Report that was completed noted both of the front tires were flat, left rear window was broken out and there was other miscellaneous damage to the vehicle. The tow lot records note you were sent a letter on August 8, 2003 regarding the destruction of your vehicle. The letter was sent to 6407 North 54th Street, Milwaukee, WI 53225, which is the address of record with the Wisconsin Department of Motor Vehicles. The vehicle was recycled on August 22, 2003 in accordance with applicable regulation, therefore, the City cannot accept liable for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee city Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
