Investigation revealed that a customer was making threats towards an employee because her order was wrong. The manager stated that both parties were arguing with each other and the customer was given a refund.
5. On 07/01/23 at 4:38pm, Milwaukee Police were dispatched to 230 E. Capitol Drive for a battery compliant. Officers spoke with manager who stated that two of the store employee got in a physical altercation. One of the employees remained on scene while the other ran away from the location, and was terminated immediately. The employee on scene complained of pain to his shoulder. The employee stated that he got into a disagreement with the coworker and then got pushed against the wall, knocked down then punched in the face. The business was cooperative with the investigation and provided video. The video showed the incident in it's entirety. The employee was conveyed to the hospital for medical attention.

Investigation revealed that an employee dropped some change on the ground while giving it to a customer and the employee told the customer to pick it up off the ground. The officers did not review security footage because of the uncooperative managers and did not enter the premise because the shift managers were uncooperative.

I was informed by James that based on recent burglaries of similar businesses with a similar MO, the owner of the business will be installing an updated surveillance system that will not be susceptible to being disabled in such a way.

This report is being written by P.O Tylor BASALDUA, assigned to District Five Late Shift.

On Monday September 1st, 2025, at approximately 00:46, Squad 5340 (P.O Elijah MCQUEEN and I) were dispatched to a subject with a weapon incident at the address of 230 E Capitol Dr which is in the City and County of Milwaukee.

While in full duty uniform, a marked squad (530) and activated AXON body worn camera. Officers arrived at the address of 230 E Capitol Dr and spoke with an employee who was verbally identified as Brittany S. CHAMBERS (B/F 08/29/2006) CHAMBERS stated she was working inside of the Taco Bell and heard 5 to 6 gunshots but did not see anything. When she went to the entrance of the building, she did not see any cars leaving and no gunman. When officers were talking to CHAMBERS we asked if there was access to the cameras around the building. CHAMBER stated she had no access to the cameras, but she called her manager. The manager on the phone spoke with officers and stated no one will have access to the cameras until she shows up at 09:00 in the morning.

While officers were investigating, a witness who was verbally identified as Donovan H. SMITH (B/M 11/29/2000) stated he was in the drive thru line at the Taco Bell and heard 5 to 6 shots at a red hatchback type of vehicle and did not see a gunman or what car shot at the red vehicle. SMITH stated he saw the red car pull out of the drive thru and headed east down Capitol Dr, and then headed south bound down N Richards St. SMITH stated the drive thru was full and could not see a shooter or another car follow the red vehicle.

Officers searched the parking lot of Taco Bell and found 8 - 9mm LUGER brass-colored casings on the south side of the parking lot.

Squad 5426 came and took photos on scene at approximately 00:56.

While officers were still investigating dispatch notified officers about a witness talking to Shorewood PD at the intersection of E Capitol Dr and N Estabrook Pkwy (Squad 924 Officer Decker was the Shorewood

When officers arrived at E Capitol Dr and N Estabrook Pkwy, we spoke to the witness who was WI Photo identified as Jamari D. WALKER (B/M 12/04/2003) WALKER stated he was standing at the entrance of the Taco Bell and witnessed a silver Dodge Caravan Minivan heading east bound down E Capitol Dr and then saw the silver Dodge Caravan Minivan turn around at the intersection of E Capitol Dr and N Richards St, then hard break into the parking lot of Taco Bell. WALKER stated he saw a B/M about 6'01 108Lbs brown eyes and wearing a navy-blue hoodie and black jean pants get out of the silver Dodge Caravan Minivan and told WALKER to "move out of the way" and then began to shoot 6 rounds into the red Dodge Caravan Minivan. WALKER stated he then ran northbound and hopped the fence. WALKER stated he then heard someone get rear ended and that was all he saw.

Officers asked WALKER what type of pistol was used, and he stated it looked like a Sig P320 and that he was that close to the incident.

All 8 casings were inventoried at the District Five Property Locker by Officer BASALDUA on 09/01/2025.

## **Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:**

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
