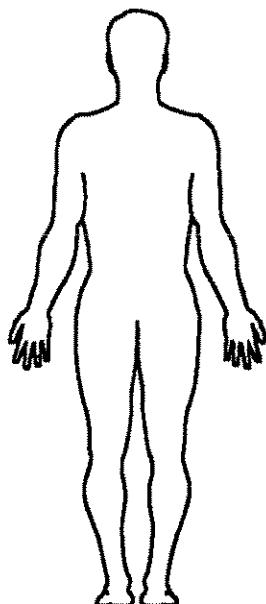

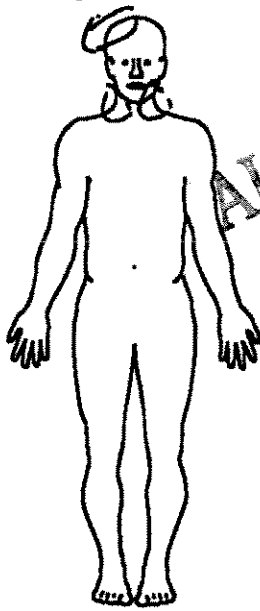

INVESTIGATIVE NARRATIVE

This report was written by P.O. Roger WALKER assigned to district three early shift. On 07-29-04 at 7:18p.m. mysely and sqd 331E (P.O. James LANGER) was dispatched to a fight at 3217 W. Wells apt 9.

Upon arrival I spoke to HARTFIELD Iola M. (b/m 07-31-65) who stated her live in boyfriend, MOTON Willie JR. (b/m 11-11-55) with whom she has been living with for approximately six months had been drinking alcohol and got into an argument about sex. MOTON became angry and choked slapped and ripped her shirt off of her. HARTFIELD than got loose and ran down to the managers apartment because she feared for her saftey. HARTFIELD then states that she returned to her apartment and continued arguing with MOTON and she went into her apartment to get away from MOTON. MOTON began knocking on the door for hartfield to open the door. MOTON then kicks down the door knocking the hinges off the door. MOTON then reaches in the apartment and grabs HARTFIELD by the neck and chokes her again and hits her with the door hinge. This was done without consent.

BOYD Alvin L. (b/m 11-28-60) apartment manager states that he heard the yelling and screaming, then HARTFIELD knocked on his door and told him to call for police. BOYD then goes to speak to MOTON to try and calm the situation. While talking to MOTON, HARTFIELD goes into the apartment and locks the door. MOTON begins slamming his fists on the door for HARTFIELD to open the door. MOTON then turns to BOYD and tells him to get the key or he will kick the door in. BOYD explains to MOTON that he does not have a key to the apartment. MOTON then kicks the door in and grabs HARTFIELD by neck and chokes her and throws her up against the wall. BOYD sees this and fears for HARTFIELD'S saftey and goes to call for police.

Police officers saw swelling above HARTFIELD'S right eye and red marks around her neck. HARTFIELD was visibly shaken and afraid. SQD 3 responded at 8:32p.m. and took seven photos. P.O. WALKER called the D.V. hotline at 8:19p.m. I spoke with Amtul.
